## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee and participants of the

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements**

We have performed an audit of the financial statements of the Messer Financial Group 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) which comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (the 2024 financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). ### 1. Description of Plan

The following description of the Messer Financial Group 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering eligible employees of Messer Financial Group, Inc. (the Company) and affiliated entities. All employees of the Company, except employees covered by a collective bargaining agreement, residents of Puerto Rico, leased employees and non-resident aliens, are eligible to participate in the Plan who have completed two months of service and are at least age 16. Employees may enter the Plan monthly with deferral elections taking effect on the first day of the following month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective July 1, 2025, the Plan was amended to comply with certain provisions under the Secure 2.0 Act of 2022.

#### Contributions

Each participant may elect to make pre-tax, after-tax voluntary employee contributions, and/or Roth contributions of up to 100% of eligible compensation as defined by the Plan document, generally subject to Internal Revenue Service limitations of \$23,000 in 2024. Eligible employees who have attained age 50 by the end of the Plan year may make catch-up contributions of up to \$7,500 in 2024. The Plan allows participants to make after-tax contributions. In 2024, a participant may have total contributions to the Plan in the amount of \$69,000, or \$76,500 including catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Plan Sponsor makes safe-harbor contributions in an amount equal to 3% of the participants eligible compensation. For the Plan year ended December 31, 2024, the Company made approximately \$366,412 in safe-harbor contributions.

The Company may make discretionary matching contributions to eligible participants, as deemed annually by the Board of Directors. In 2024, the Company made a discretionary contribution of \$605,049, net of forfeitures.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, the Plan Sponsor's contributions, earnings and losses on the investments in their account, and is charged with certain administrative expenses. Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan. Participants may change their

investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are vested immediately in their contributions and their safe-harbor contributions plus earnings and losses thereon. Vesting in the Company discretionary contributions portion of their account is based on years of continuous service. A participant vests 20% per year after 2 years and is fully vested after 6 years of service or upon retirement, age 65, total or permanent disability, or death.

### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account. A participant may have one note outstanding at any time. The notes are secured by the balance in the participant's account and must bear a reasonable rate of interest as defined in the Plan document. During 2024, notes had fixed rates ranging from 6.50% to 9.50% for the term of the note, not to exceed 5 years (10 years if used for the purchase of a primary residence). Principal and interest are paid through payroll deductions.

### **Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to participant contributions. The plan expects to distribute the 2024 excess contributions during 2025 as required.

### **Payment of Benefits**

At the time of death, disability, termination of employment or retirement, a participant or their beneficiary may receive payment of the vested interest in their account in a lump-sum distribution. Participants are eligible to receive hardship withdrawals when certain conditions are met. After attaining the age of 59½, participants may also be eligible to make a withdrawal of all or any of their vested account.

### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0. These accounts may be used to reduce future Company contributions or pay administrative expenses of the Plan. In 2024, \$19,786 was used to offset the Company's contributions and no forfeitures were used to pay administrative expenses.

### Administrative Expenses

Administrative expenses include recordkeeping and investment advisory fees. These may be allocated to participants pro rata based on participant balances, paid through forfeitures, or paid by the Company. These expenses paid by the Plan to various services providers qualify as party-in-interest transactions. Loan and withdrawal fees are charged directly to the participant requesting the loan or withdrawal. The Company does not expect reimbursement from the Plan for payment of administrative expenses on behalf of the Plan.

## 2. Summary of Significant Accounting Policies

### Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### Contributions

Participant contributions and Company safe-harbor contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The Company discretionary matching contributions are considered payable to the Plan when approved by the Company. Any unfunded participant or employer contributions are included in the employee or employer contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023.

In accordance with the Financial Accounting Standards Board Accounting Standards Codification 326, *Financial Instruments—Credit Losses*, the Plan estimated the current credit risk associated with the employer receivables. After giving consideration to the risk characteristics, including historical payment experience, the Plan determined that no allowance for credit losses as of and for the year ended December 31, 2024 and 2023.

### Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net increase in fair value of investments includes realized and unrealized gains and losses on those investments and interest and dividends on those investments. Interest income is recorded when received.

### Notes Receivable from Participants

Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the plan administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded as a deemed distribution. Notes receivables from participants qualify as party-in-interest transactions.

### Payment of Benefits

Benefit payments are recorded when paid.

### Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.

## 3. Information Certified by the Qualified Institution

All investment information in the accompanying financial statements and supplemental schedule, regarding investments held and notes receivable from participants at December 31, 2024 and 2023, net change in fair value of investments and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Charles Schwab Trust Bank (Charles Schwab), the Plan's qualified institution.

## 4. Investments

Plan investments include shares of mutual funds, self-directed brokerage accounts, and the money market fund managed by Charles Schwab. Charles Schwab is a service provider to the Plan; therefore, transactions in these investments qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net increase in fair value of the investments, as they are paid through revenue sharing rather than a direct payment.

Investments are exposed to various risks, such as market, currency, interest rate, and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include healthcare crises, such as a pandemic, international conflicts, supply

chain disruptions, global monetary policy decisions, significant exogenous economic influences, and significant cybersecurity attacks. It is at least reasonably possible that changes in their fair value will occur in the near term and that such changes could materially affect participants' account balances.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Investments in the money market fund and mutual funds are stated at quoted market prices for the identical security in an active market (Level 1).

The Plan invests in self-directed brokerage accounts that include investments in mutual funds, common stock, and interest-bearing cash. All investments in the self-directed account can be traded daily, and are considered to be Level 1.

### 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their Company discretionary matching contributions.

### 6. Income Tax Status and Other Matters

The Plan uses a Pre-Approved Volume Submitter Profit Sharing Plan with CODA sponsored by Epic Advisors, Inc (Epic). The Internal Revenue Service has opined and informed Epic by a letter dated April 2, 2018, that the pre-approved plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan has not received an individual determination letter and has been amended since Epic received the opinion letter. However, the plan administrator believes that the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by taxing authorities and may change upon examination.
