**(1) Description of the Plan**

The following description of the Imperial Valley Family Care Medical Group, APC 401(K) Profit Sharing Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

*General*

The Plan, as amended, is a defined contribution and profit sharing plan covering all employees of the Company with a minimum age of 21. Participation in the Plan is voluntary. The Plan went into effect January 1, 2000, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and is designed to qualify under Section 401(k) of the Internal Revenue Code (the “Code”).

*Contributions*

Each plan year, the Board of Directors of the Employer will determine the amount of the discretionary employer contribution (if any). The discretionary contribution is determined as a percentage of compensation or a dollar amount per participant. The Plan creates a separate employee classification group for each eligible employee. Employer contributions are recorded by the Plan on the last day of the plan year and deposited either during the year or after the close of the Plan year. During the year ended December 31, 2024, the Board of Directors of the Employer granted a 3% safe-harbor match for those eligible participants contributing to the Plan. Also, the Board of Directors granted up to an additional 6% profit sharing match for shareholders of the Employer participating in the Plan.

Employees of the Employer can participate in the Plan after becoming eligible. Participants may elect to contribute to the Plan up to 100% of their annual eligible compensation, as defined by the Plan Agreement, up to the annual maximum allowed under the IRC (\$23,000 for the year ended December 31, 2024). The Plan also allows for Roth contributions by participants. All employees who were eligible to make pretax and Roth deferrals under the Plan and had attained age 50 before the close of the plan year were eligible to make catch-up contributions in accordance with, and subject to, the limitations of the IRC. (\$7,500 for the year ended December 31, 2024, respectively). Participants may rollover into the Plan amounts representing distributions from other qualified plans.

**(1) Description of the Plan (continued)**

*Participant Accounts*

Each participant's account is credited with the participant's contributions, allocations of the Employer's safe-harbor and discretionary contributions (if any), earnings or losses based on investments chosen by the participant for their contributions, and charged with an allocation of Plan expenses. Allocations are based on participant earnings or account balances, as defined in the Plan agreement.

*Vesting*

With the amended and restated Plan on July 27, 2022, Employer safe-harbor and discretionary matches are 100% vested upon contribution to the Plan.

*Note Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and currently bear interest rates commensurate with local prevailing rates as determined on an annual basis by the Plan Administrator. Principal and interest is paid ratably through payroll deductions. Loans must be repaid over a period not to exceed five years (unless the loan is taken for the purchase of a primary residence). Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan agreement.

*Investment Options*

Participants direct the investment of their contributions and safe-harbor matching contributions into a portfolio of diverse investment options offered by the Plan. The Employer's discretionary contributions are invested upon the direction of the Plan Administrator based on professional investment advice retained by the Plan.

*Payment of Benefits*

Payment of benefits will commence following retirement. Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or installment payments.

**(1) Description of the Plan (continued)**

*Payment of Benefits (continued)*

Pre-retirement distributions are allowed upon either attaining age 59<sup>1/2</sup> and are 100% vested in all accounts or when becoming permanently disabled during the time of employment with the Employer. The Plan defines disability to be determined as being physically or mentally disabled which is expected to result in death or to last a continuous period of 12 months where one is unable to perform the required job duties. Such withdrawals are subject to applicable excise and income taxes, and may only be made with the approval of the Plan Administrator. Terminated participants who have account balances less than \$5,000 will receive an automatic distribution, as defined by the Plan Agreement.

*Administrative Expenses*

The Plan's expenses are paid either by the Plan or the Employer, as provided by the Plan Agreement. Expenses that are paid directly by the Employer are excluded from these financial statements. Special expenses like distribution fees and loan fees, etc. are charged to the particular participant using the service.

**(2) Summary of Significant Accounting Policies**

*Basis of Accounting*

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

*Use of Estimates*

The preparation of financial statements in conformity with G A A P requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

*Risks and Uncertainties*

The Plan provides for investment options in various combinations of investment securities. Investment securities are exposed to various risk factors including, but not limited to, interest rates, market conditions and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the Statements of Net Assets Available for Plan Benefits.

*Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value.

The Plan presents in the statement of changes in net assets the net appreciation (depreciation) in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**(3) Summary of Investment Data Certified by the Plan Asset Custodian**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to investment information certified by Charles Schwab Trust Bank, except for comparing such investment information certified by the asset custodian to information included in the Plan's financial statements and supplemental schedules.

For the Plan's investments held by Charles Schwab Trust Bank at December 31, 2024, the following investment information was certified to be complete and accurate within the meaning of 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820-10 are described below:

The three levels of the fair value hierarchy are described below:

Level 1: Quoted prices for identical assets or liabilities in active markets.

Level 2: Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3: Unobservable inputs that are supported by little or no market activity and that are financial instruments whose values are determined using pricing models, discounted cash flow methodologies, or similar techniques, as well as instruments for which the determination of fair value requires significant judgment or estimation.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The methods described below may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Mutual funds are valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at the price. The mutual funds held by the Plan are deemed actively traded.

Money market fund seek to maintain a stable price of \$1.00 per share by investing in a diversified portfolio of high quality, US government money market instruments and in related repurchase agreements. The fund is valued at the closing price as reported by the fund.

**(4) Fair Value Measurements (continued)**

Stocks are valued at the closing price reported on the active stock exchange market on which the individual securities are traded. Stocks are publicly traded on a national exchange.

Alternative investments, which are not readily marketable, are carried at an estimated fair value as provided by the investment managers or sponsors based on estimated net asset value per share (“NAV”). The NAV is based on the estimated fair value of the underlying investments held in the partnership or investment fund. The values of those investments are determined using various methodologies including estimated sale prices of the assets or other valuation techniques.

**(6) Federal Income Tax Status**

The Company adopted a non-standardized pre-approved profit sharing plan provided by Schwab. The pre-approved profit sharing plan provider received an advisory letter from the Internal Revenue Service (“IRS”), dated June 30, 2020, which stated that the pre-approved plan, as than designed, was in compliance with the applicable requirements of the IRC. The Plan has not received a determination letter specific to the Plan. Although the Plan has been amended since the issuance of the opinion letter, the Plan Administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan is qualified and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

**(7) Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become 100% vested in their Employer contribution accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Employer may determine.

**(8) Prohibited Transactions**

*Delinquent Contributions*

The Employer remits participant contributions into the Plan on a bi-weekly basis. There were \$52,500 of participant contributions that the Employer transferred into the Plan after what was considered to be a reasonable period of time for the year ended December 31, 2023. These delinquent contributions are considered non-exempt prohibited transactions under the regulations of the Department of Labor and therefore the Plan and/or the Plan Administrator may be subject to fines, penalties, and interest. The Plan Administrator has self-corrected this issue through submitting the necessary lost earnings. The accompanying financial statements do not include any accruals or provisions related to the outcome of this uncertainty.
