Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Integrated Community Alternatives Network, Inc 401(K) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agrees to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Operations

The Plan is a defined contribution profit-sharing plan covering eligible employees of Integrated Community Alternatives Network, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Basis of Accounting

The financial statements are reported using the accrual basis of accounting in which revenue is recognized when earned or otherwise available, and expenses are recognized when incurred.

Investment Valuation and Income Recognition

Investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the statements of changes in net assets available for benefits includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are recorded at unpaid principal balance at year end plus any unpaid accrued interest. Delinquent notes receivable from participants are reclassified as deemed distributions based upon the terms of the Plan document.

Payment of Benefits and Excess Contributions

Benefits are recorded when paid. Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability on the statements of net assets available for benefits and as a deduction on the statements of changes in net assets available for benefits. The excess contributions for the years ending December 31, 2024 and 2023 were \$263 and \$2,919, respectively. Since the Plan distributed these excess contributions to the applicable participants prior to the required due date, there was no excise tax liability.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

NOTE 2 DESCRIPTION OF PLAN

The following brief description of Integrated Community Alternatives Network, Inc. 401(K) Profit Sharing Plan & Trust provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Contributions

The following brief description of the Plan provides only general information. Participants should refer to the Summary Plan Description or the Plan document for a more complete description of the Plan's provisions.

Employees become eligible to participate in the Plan upon attaining the age of 21. Financing of the Plan comes from employer and participant contributions and investment income. Rollover contributions by participants are permitted. Employer-profit sharing contributions are allocated equally among all participants eligible to share in the contribution. In no event will the employer plus employee elective deferral contributions exceed the maximum amount permitted by law. The Board of Directors of Integrated Community Alternatives Network, Inc. determines annually, at its discretion, the total amount of employer matching and profit-sharing contributions to be made to the Plan. Effective January 1, 2021, the Plan was formally restated to adopt automatic enrollment of 4% for certain eligible employees, unless they affirmatively elect otherwise. In order to be eligible, participants must be 21 years of age. The entry date shall be the first day of each month coinciding with or immediately following the date such eligible employee completes the service requirements. The employer will make matching contributions on behalf of all eligible employees monthly. In order for a participant to receive the employer profit sharing contribution, the participant must have a minimum of 1,000 hours during the plan year and be active on the last day of the plan year.

Participants may contribute up to 100% of eligible pre-tax compensation as defined in the Plan, subject to maximum annual additions allowed by law. For 2024 and 2023, the employer matched 100% of up to 4% of the eligible pre-tax compensation. The amount of profit-sharing contributions made to the Plan for 2024 and 2023 were \$118,794 and \$250,000, respectively.

Participant Accounts

Each participant's account is credited with the participant's contributions and employer matching contributions, as well as allocations of any profit-sharing contributions and Plan earnings. All investments are directed by the Plan participants.

Vesting

Employees are always 100% vested in all salary deferrals they make. The Company has a vesting period related to its employer contributions as follows:

Forfeitures

The non-vested portion of a terminated participant's account is forfeited when they receive a distribution of their entire vested account. According to the Plan document, forfeitures may be used at plan administration's discretion to offset administrative expenses of the Plan, to offset employer contributions to the Plan, or be reallocated as additional employer contributions or as additional matching contributions to the Plan. Forfeitures available totaled \$118,794 and \$43,577 at December 31, 2024 and 2023, respectively. Forfeitures of \$0 and \$33,289 were used in accordance with the Plan's adoption agreement during 2024 and 2023, respectively.

Payment of Benefits

Benefit payments are made upon normal retirement, death, disability, or termination of service. The benefits are paid in a lump-sum or distributed in installments in accordance with the Plan document. In addition, the Plan allows for in-service distributions if the participant has reached the age of 59½. The Plan has a mandatory cash out provision if the participant terminates employment and their vested account balance does not exceed \$1,000.

Notes Receivable from Participants

The Plan allows for participant loans. Participants may borrow from their accounts a minimum of \$1,000 and a maximum equal to the lesser of \$50,000, reduced by the outstanding balance of any existing loans, or 50% of their vested account balance. All loans shall be for a fixed term of not more than five years, except a loan which shall be used to acquire any dwelling. If within a reasonable time the dwelling is to be used as the principal residence of the borrower, a longer repayment term may be allowed. The loans are collateralized by no more than 50% of the vested balance in the participant's account and bear interest at a rate of prime plus 2%. A participant can have no more than five loans outstanding at one time.

Plan Termination

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the net assets of the Plan will be allocated as prescribed by ERISA and regulations pursuant thereto.

NOTE 3 FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board authoritative guidance on fair value measurements establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Invested Cash: Valued at amortized cost which approximates fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust: Valued at net asset value of shares held by the Plan at year end as determined by its sponsor.

All assets have been valued using a market approach, except as noted above.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 TAX STATUS

The Plan is an adoption of a prototype plan, is qualified under the appropriate sections of the Internal Revenue Code and is not subject to tax under present income tax law. The Plan adopted the amendment and restatement of the previous prototype plan effective May 1, 2016.

The prototype plan obtained its latest determination letter on March 31, 2014, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 5 SUMMARY OF INFORMATION CERTIFIED BY PLAN TRUSTEES

The total fair value of investments held in trust was \$8,933,141 and \$7,106,878 at December 31, 2024 and 2023, respectively.

The trustee, NBT Bancorp, Inc., has supplied the Plan's administrator with a certification as to the completeness and accuracy of all information regarding investment assets, transactions, and income presented in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the statements of changes in net assets available for benefits, for the plan years then ended and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 6 PARTY-IN-INTEREST TRANSACTIONS

A party-in-interest is defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer and certain others. Plan assets are used to pay some expenses for administration of the Plan and the remaining administrative expenses are paid by the Company. Payments to such service providers by the Plan qualify as party-in-interest transactions.

Fees paid directly from the Plan during 2024 and 2023 to NBT Bancorp Inc., trustee of the Plan, were \$65,128 and \$53,018, respectively.

NOTE 7 RISKS AND UNCERTAINTIES

Investments are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

NOTE 8 SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 19, 2025, the date on which the financial statements were available to be issued.
