Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Absentee Shawnee Tribe Savings Incentive Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note E to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE A--PLAN DESCRIPTION

The following description of the Absentee Shawnee Tribe Savings Incentive Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for complete information.

General: The Plan is a defined contribution plan covering substantially all employees of the Absentee Shawnee Tribe and Li-Si-Wi-Nwi Health (the "Tribe") who have completed two months of service and are age 21 or older. Employees may begin participating in the Plan at the beginning of the first quarter, occurring after the employee has met the eligibility requirements. The Tribe adopted the Plan effective January 1, 1997. The Plan was amended and restated effective September 9, 2020, via the adoption of the Minnesota Life Insurance Company Volume Submitter 401(k) Profit Sharing Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Asset Custodian and Administration: The Plan's assets are held by Minnesota Life Insurance Company (Minnesota Life), the asset custodian of the Plan, and are invested through participant-directed accounts offered by Minnesota Life. In 2022, Minnesota Life and Standard Insurance Company (The Standard) entered into a Reinsurance Agreement and other related agreements that transferred administrative, payment, and investment responsibilities with respect to certain insurance contracts from Minnesota Life to The Standard, on a coinsurance basis in the case of general account liabilities and on a modified coinsurance basis in the case of separate account liabilities. Pursuant to the agreements, The Standard is responsible for all administrative services, including the preparation and certification of the plan's annual reporting on behalf of Minnesota Life. Because Minnesota Life remains the issuer and retains liability for the insurance contracts that are reinsured and administered by The Standard, both Minnesota Life and The Standard are identified in the plan's annual reporting. Duties of the asset custodian include, among others, recordkeeping, receiving and investing cash contributions and investment income, and making payments from the Plan funds as directed by the participants and Plan administrator. Officers or employees of the Tribe perform administrative functions. The Tribe incurs certain administrative services and costs without cost to the Plan. No officer or employee of the Tribe receives compensation from the Plan.

Contributions: Each participant can make pre-tax contributions up to the maximum amount allowed by the Internal Revenue Service (IRS). The IRS limit was \$23,000 for 2024. Plan participants age 50 and older were eligible to make catch-up contributions of an additional \$7,500 to the Plan for 2024. Rollover and transfer contributions from qualified plans are permitted under the Plan agreement. During each Plan year, the Tribe may make a matching contribution to the participants' accounts. Although the Tribe intends to continue making such contributions to the Plan, the Tribe is not required to do so. The Tribe has the right to revoke, suspend, or modify its obligation to make matching contributions upon giving proper notice to all participants at any time during the Plan year. For the year ended December 31, 2024, the Tribe matched 100% of the amount contributed by a participant, up to 5% of the participant's eligible compensation, as defined in the Plan agreement. Additionally, profit-sharing amounts may be contributed to the Plan at the option of the Tribe's Executive Committee. The Tribe made no profit-sharing contributions during 2024.

Vesting: Participant contributions to the Plan and earnings thereon are fully vested at all times. Vesting of Tribe contributions is based upon the years of service with the Tribe as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than one year	0%
One year	33%
Two years	67%
Three years or more	100%

Payment of Benefits: Participants who terminate employment due to death, permanent disability, or normal retirement may receive all benefits in a lump-sum payment equal to the value of the participant's account balance. Participants receiving required minimum distributions may receive such distributions in periodic installments. For termination of service due to other reasons, a participant may receive the value of their vested interest as a lump-sum distribution. As of December 31, 2024, net assets available for benefits included approximately \$4,415,000, relating to former participants who have elected, for the present time, to leave their balances intact with the Plan.

Investment Options: Participant accounts are 100% participant directed. Upon enrollment, participants may direct their contribution in any increments to any of the investment options provided by the custodian. The investments are allocated to a selection of various mutual funds and a guaranteed investment contract which are registered under the Investment Company Act of 1940.

Participant Accounts: Each participant's account is credited with the participant's contributions, Tribe contributions, if any, and Plan earnings. Allocations are based on a participant's account balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Administration of Plan Assets: A Tribe employee serves as the Plan Administrator, having overall responsibility for the Plan. The Plan Administrator has the power to interpret the Plan's provisions, determine questions concerning eligibility, participation and benefits, and such other powers and duties as are necessary to the operation of the Plan. The Tribe pays most of the administrative costs of the Plan.

Income Tax Status: The IRS has ruled that the Plan qualifies under Section 401(a) of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently operating in compliance with the applicable requirements of the IRC.

Income Tax Status--Continued:

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 740, *Income Taxes*, provides detailed guidance for the financial statement recognition, measurement, and disclosure of uncertain tax positions recognized in an entity's financial statements and requires an entity to recognize the financial statement impact of a tax position when it is more likely than not that the position will be sustained upon examination. The Plan Administrator believes that all significant tax positions utilized by the Plan will more likely than not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions. However, there are currently no audits for any tax periods in progress. As of December 31, 2024, the tax years that remain subject to examination by the major tax jurisdictions under the statute of limitations are from the year 2021 forward (with limited exceptions). Tax penalties and interest, if any, would be accrued as incurred and would be classified as tax expense in the statement of changes in net assets available for plan benefits.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Transactions are treated as a transfer to (from) the investment fund from (to) the participant's note receivable fund. The notes are secured by the balance in the participants' accounts with a fixed interest rate equal to the Wall Street Prime rate plus 2% at the time the loan is issued. Notes are to be repaid ratably through payroll deductions over a period not greater than five years, except for loans for the purchase of a principal residence, which are repayable over a period not to exceed 30 years.

Forfeitures: The Tribe's contributions and earnings thereon that become forfeited due to any benefit payment or withdrawal provisions of the Plan may be used to pay plan expenses. Any forfeiture amount remaining after paying plan expenses is used to reduce the Tribe's matching contributions and pay certain administrative expenses of the Plan. Forfeitures of nonvested portions of participants' accounts during the year ended December 31, 2024 totaled approximately \$48,000. As of December 31, 2024, there were approximately \$117,000 in unallocated forfeitures in the Plan.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared using the accrual method of accounting.

Payment of Benefits: Benefits are recorded when paid.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES--CONTINUED

Notes Receivable from Participants: Notes receivable from participants represent participant loans recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant's loan balance is reduced, and a benefit payment is recorded.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable: The Plan is subject to annual tests designed to limit the disparity between elective deferrals by highly compensated participants and elective deferrals made by non-highly compensated participants. The Plan had a liability of approximately \$37,000 as of December 31, 2023 resulting from excess contributions to the Plan by highly compensated participants. There was no such liability at December 31, 2024.

Plan Termination: Although it has not expressed any intent to do so, the Tribe has the right under the Plan document to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of Plan termination, participants will be 100% vested in their accounts.

Date of Management's Review of Subsequent Events: The Plan's management has evaluated subsequent events through October 7, 2025, the date which the financial statements were available to be issued and determined that no subsequent events have occurred that require adjustment to or disclosure in the financial statements.

NOTE C--INVESTMENT CONCENTRATION, RISKS, AND UNCERTAINTIES

As of December 31, 2024, approximately 82% of Plan investments consist of one guaranteed investment contract and three mutual fund investments.

In general, the Plan's investments are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

NOTE D--FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820-10-35-39 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE D--FAIR VALUE MEASUREMENTS--CONTINUED

There have been no changes in the valuation methodologies used as of December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

Pooled Separate Accounts: Investments represented by a unit of account whose unit per value is the result of the accumulated values of the underlying investments. The underlying investments are public investment vehicles using net asset value (NAV) per share. The NAV is based upon the value of the underlying assets owned by the fund, minus its liabilities, then divided by the number of shares outstanding. The underlying investments of the NAVs are valued as follows:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at the price. The mutual funds held by the Plan are deemed actively traded.

Guaranteed investment contract: This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the trustees, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. (see Note G).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy.

NOTE E--INFORMATION CERTIFIED BY THE CUSTODIAN

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, The Standard Insurance Company (on behalf of Minnesota Life Insurance Company), the custodian of the Plan for the years ended December 31, 2024 and 2023, certified that the following data included in the accompanying financial statements and supplemental schedule of assets (held at end of year) is complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, Line 4i--schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform audit procedures with respect to this information, except for comparing such information per the custodian's certified statements to the related information included in the financial statements and supplemental schedule.

NOTE F--TRANSACTIONS WITH EXEMPT PARTIES-IN-INTEREST

Certain Plan investments were managed by The Standard, on behalf of Minnesota Life, which also served as the Plan's custodian and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.

Certain assets of the Plan consist of notes receivable from participants, which are considered exempt party-in-interest transactions under ERISA.

NOTE G--GUARANTEED INVESTMENT CONTRACT

As of December 31, 2024 and 2023, the Plan had a fully benefit-responsive guaranteed investment contract (The Minnesota Life Guaranteed Return Account) with Minnesota Life, totaling approximately \$2,324,000 and \$1,768,000, respectively. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan. The guaranteed investment contract does not permit the insurance company to terminate the agreement before the scheduled maturity date. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

NOTE G--GUARANTEED INVESTMENT CONTRACT--CONTINUED

The account is an investment of Minnesota Life that receives interest credited at rates declared annually in accordance with the Plan's contract. Interest is credited daily to amounts allocated to the account at the rate declared by Minnesota Life before the beginning of each contract quarter, subject to a minimum guaranteed rate determined in the contract. Transfers and withdrawals from the account are subject to certain limits. Under the Plan's contract, the use of a money market or stable value account as part of the Plan's investment array is prohibited when the guaranteed investment contract account is used. The Plan's accumulated value in the account (reduced by the liquidation charge) will be paid in three substantially equal installments over a two-year period, beginning on the liquidation date. The account's accumulated value is also available to be paid in a lump sum on the liquidation date after applying a market value adjustment determined by the formula specified in the contract.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments, including the interest rate and credit risk. Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the plan documents (including complete or partial plan termination or a merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan or (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. The contract continues in force until all assets have been distributed, or no further payments are due.
