The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). 1. Description of Plan

The following description of the Sharp Health Plan 401k Plan (the Plan) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering eligible employees of Sharp Health Plan (the Employer). The Employer serves as the administrator of the Plan. The Plan engages Lincoln Financial Group Trust Company (Trustee or Lincoln Financial Group) to hold and invest Plan assets and execute Plan transactions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Effective December 26, 2021, the Plan was frozen to new entrants and contributions to enable employees to become eligible for future contributions into the Sharp Healthcare 403(b) Tax Deferred Retirement Plan, which is another plan sponsored by the Employer. Participants may maintain their frozen account balance, change investment elections, and take distributions and loans from their frozen account balances.

Contributions

Prior to December 26, 2021, Eligible employees elected to defer a flat dollar amount or from 1% to 80% of eligible pay period compensation, up to statutory limits, as defined in the Plan. The Plan allowed both pre-tax and Roth after-tax contributions. Participants who have attained age 50 by year end were also able to make catch-up contributions, up to statutory limits. There are no employer contributions to the Plan. The Plan previously allowed rollover contributions to the Plan. Rollover contributions are assets transferred to the Plan from a qualified retirement savings plan in which an employee participated prior to employment with the Employer.

Participant Accounts

Each participant's account is credited with the participant contribution, rollover contribution, and an allocation of the Plan's earnings and charged with an allocation of the Plan's losses and administrative expenses. Allocation of the Plan's earnings or losses and certain administrative expenses are based on each participant's account balance or participant requested services, as defined. Participant accounts are invested based upon participant-directed allocations. The benefit to which a participant is entitled is the benefit that can be provided by the participant's account.

Vesting

Participants are always 100% vested in their voluntary contributions. There are no employer contributions.

Payment of Benefits

Participants are entitled to receive payment of their benefits in the event of retirement, death, disability, termination of employment, or attainment of age 59½. Distribution may be taken as a lump sum payment equal to the value of the participant's account balance. Immediate lump-sum distributions may be made to terminated participants if the participant's vested account balance is

\$1,000 or less. Effective January 1, 2024, for terminated participants with vested balances greater than \$1,000, but less than \$7,000, their vested balance may be automatically rolled into an IRA unless otherwise elected.

Upon termination of employment, the Participant may elect to receive a lump-sum payment or defer the receipt of payment according to plan provisions.

Hardship Withdrawals

Participants may withdraw all or a percentage of their account balances upon approval of the Plan Administrator and subject to IRS hardship withdrawal rules. The recordkeeper limits Participants to a total of two hardship withdrawals in a 12-month period, if eligible.

Notes Receivable from Participants

Participants may borrow from their participant accounts a minimum of \$1,000 not to exceed a maximum of \$50,000, or 50% of the participant's vested account balance, whichever is less. Participants are allowed a maximum of one loan outstanding. The notes are secured by the participant's vested account balances and are payable not to exceed five years, except for funds used to acquire a principal residence, which must have a repayment period within a reasonable time commensurate with the repayment period permitted by commercial lenders for similar loans. Interest rates must be commensurate with the interest rates charged by persons in the business of lending money for loans under similar circumstances. The Plan's loan procedures comply with applicable regulations which limit the amount that can be borrowed and the length of the loan repayment period.

Loan repayments are not handled through the payroll process. Participants are required to make direct payments to Lincoln Financial Group for loan repayment purposes. It is the participant's responsibility to ensure prompt and accurate repayment of the loan amount directly to Lincoln Financial Group.

2. Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value (see Note 5). Fair value is the price that would be

received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan payments beyond the applicable cure period and the loan is deemed a distribution, based on the terms of the loan document, the participant's loan balance is reduced, and a benefit payment is recorded in the financial statements in the year the determination is made.

Payments of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

Fees related to plan administration, and the issuance and administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments. Plan related expenses paid by the Employer are excluded from these financial statements. The plan further maintains an expense account to pay administrative and other Plan expenses which is funded by fees received from eligible investments. Assets in the expense account are invested in Lincoln Financial Group Stable Value Annuities and amounted to \$15,063 and \$9,605 as of December 31, 2024 and 2023.

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Lincoln Financial Group Trust Company, a qualified institution.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market Fund - The money market fund is stated at cost, which approximates fair value.

Mutual Funds - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts - These accounts are comprised of mutual and money market funds. The mutual and money market funds are valued at the NAV that is quoted on an active market and is determined based on the fair value of the underlying assets at the end of each day.

Pooled Separate Account (PSA) - Valued at the NAV of the units of the PSA. The NAV, as provided by the trustee of the PSA, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The fair value of the underlying investments, which can consist of a single mutual fund or multiple securities, is determined using market quotations or prices obtained from independent pricing sources. The unit value of the pooled separate account is based upon significant observable inputs. NAV would not be used if it was probable that the investment would not be traded at NAV. The PSA provides for daily redemptions by the Plan at reported NAV with no advance notice. There are no unfunded commitments related to these investments. The initial pricing input is the quoted price obtained for the underlying mutual fund which is then adjusted to apply separate account expenses. This investment is a direct filing entity.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Fully Benefit-Responsive Investment Contract

In 2011, the Plan entered into a fully benefit-responsive investment contract in the form of an insurance contract with Lincoln National Life Insurance Company (Lincoln National). Currently Lincoln Investment Advisors Corporation serves as the advisor for the Lincoln Financial Group Stable Value Annuities (insurance contract). Lincoln National maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is a traditional contract and is included in the financial statements at contract value as reported to the Plan by Lincoln National.

Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participant withdrawals and transfers from the insurance contract are paid at contract value but funded through the market value liquidation of the underlying investments, which also impacts the interest crediting rate. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The crediting interest rates were approximately 3% for the years ended December 31, 2024 and 2023. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be

less than a 3.0% effective annual interest rate. Such interest rates are reviewed on a quarterly basis for resetting.

In certain circumstances, the amount withdrawn from the contract would be payable at fair value rather than at contract value. These events include termination of the Plan, a material adverse change to the provisions of the Plan, a Principal Employer election to withdraw from a contract in order to switch to a different insurance provider, or if the terms of a successor plan (in the event of the spin-off or sale of a division) do not meet the contract issuer's underwriting criteria for issuance of a new contract. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable. The Lincoln Stable Value Fund is compared to the liquidity of Lincoln National. The contract will transact at contract value provided Lincoln National remains liquid.

6. Related Party and Party-in-Interest Transactions

Certain Plan investments are invested in the Lincoln Stable Value Contract and the Lincoln National Variable Annuity Account, both offered by the TLNLIC. Both TLNLIC and Lincoln Retirement Services Company, LLC, the Plan's recordkeeper, have the same parent company, Lincoln Financial Group. As such, transactions related to recordkeeping expenses and for the Lincoln Stable Value Contract and the Lincoln National Variable Annuity Account qualify as party-in-interest transactions. Additionally, notes receivable from participants are considered exempt party-in-interest transactions.

7. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would remain 100% vested in their accounts.

8. Tax Status

The Internal Revenue Service has informed Lincoln Retirement Services Company, LLC, through the pre-approved program, which received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, stating that the Plan, as designed, is in compliance with the applicable requirements of the Code and, therefore, not subject to Federal income tax. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

9. Risks and Uncertainties

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of

risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

10. Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.
