We have performed audits of the financial statements of RigNet, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 – DESCRIPTION OF PLAN

RigNet, Inc. 401(k) Plan (the Plan) is a qualified retirement plan adopted by RigNet, Inc. (the Company) to enable employees to save for retirement. The Plan was originally effective January 1, 2004. Effective April 1, 2023, the plan was amended and restated and Empower Trust Company, LLC became the trustee of the Plan. The Plan is administered by the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The following description of the Plan provides only general information. Participants should refer to the plan document and trust agreement for a more complete description of the Plan's provisions.

Effective June 15, 2022, the Plan was frozen and is no longer accepting employee or employer contributions, other than loan payments. Plan assets will continue to be held on behalf of participants and their beneficiaries until distributed in accordance with Plan terms.

Eligibility: Employees were eligible to participate in the Plan upon attainment of age 21. Employees could enter the Plan on the first day of each month coinciding with or next following the date they satisfy the age requirement. The Plan had no service requirements.

Contributions: Participants could elect to defer a percentage of their eligible compensation into the Plan on a pre-tax or Roth basis. The percentage deferred was limited to the lesser of 96% of eligible compensation or a dollar limit which is set by law. Participants who were projected to be age 50 or older by the end of a tax year could defer additional amount as catch-up contributions. The Plan also contained an automatic enrollment feature in which the Company would automatically deduct 6% from a participant's pay as a pre-tax deferral contribution to the Plan. The Company would automatically increase automatic enrollments 1% annually until a deferral rate of 12% was reached. Participants could increase, decrease, suspend, or resume their deferral contributions or automatic contributions at any time.

The Company elected to make discretionary matching contributions to all eligible participants in an amount equal to 100% of the first 3% of a participant's eligible compensation, and 50% of the next 2% of a participant's eligible compensation, contributed to the Plan as deferral contributions.

Participants were permitted to deposit into the Plan distributions they had received from other plans and certain IRAs. Such a deposit was called a rollover contribution and could result in tax savings.

Participant Accounts: Each participant's account was credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings and losses, and (c) forfeiture of employer discretionary matching contributions and was charged with his or her withdrawals and an allocation of administrative expenses. Allocations were based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled is the benefit that could be provided from the participant's vested account. Each participant directed the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death, and Disability: A participant was entitled to 100% of his or her account balance upon retirement, death, or disability.

Vesting: Participants were immediately vested in their contributions, rollover contributions, and safe harbor contributions plus actual earnings thereon. Vesting in the remainder of their accounts, plus earnings thereon, was based on years of continuous service. A participant received a 20% vested percentage after one year of vesting service and an additional 20% for each additional year of vesting service. Participants became 100% vested after five years of credited service.

Payment of Benefits: Participants could receive a distribution of the vested portion of some or all of their accounts in the Plan for termination of employment, normal retirement, disability, or death. If a participant's vested account balance exceeded \$5,000, they must have consented to any distribution before it could be made, and they could elect to receive a distribution of their vested account balance in a single lump-sum payment, partial withdrawals, or installments. If a participant's vested account balance did not exceed \$5,000, then a distribution of their account balance would be made to them in a single lump-sum payment, regardless of whether they consented to receive it. Participants could also rollover all or a portion of their distribution to an IRA or another employer retirement plan willing to accept the rollover.

Participants could be entitled to receive an in-service distribution from the Plan from certain accounts prior to termination of employment provided they had attained age 59½. In addition, a hardship distribution could be made to satisfy certain immediate and heavy financial needs that a participant had.

Notes Receivable from Participants: Participants could borrow from their vested account balance a minimum loan amount of \$1,000 up to a maximum of the lesser of 50% of their vested account balance, or \$50,000 reduced by the highest outstanding loan balance in the past 12 months. All loans were adequately secured by the balance in the participant's account and charged a reasonable rate of interest based on the prime rate, plus 1%. Principal and interest payments were paid ratably through payroll deductions over a term not to exceed five years.

Forfeitures: If a participant terminated employment before being fully vested, then the non-vested portion of the terminated participant's account balance remains in the Plan and was called a forfeiture. Forfeitures could be used to pay Plan expenses or allocated as discretionary additional matching contributions. At December 31, 2024 and 2023, there were no forfeited non-vested accounts.

Plan Termination: Effective June 15, 2022, the Plan was frozen and is no longer accepting employee or employer contributions, other than loan payments. Plan assets will continue to be held on behalf of participants and their beneficiaries until distributed in accordance with Plan terms. As of the report date, the Company is evaluating options on whether to terminate the Plan or to merge the Plan into the Viasat 401(k) Plan. The Company has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants will become 100% vested in their Company contributions and earnings thereon.

As of the date the financial statements were available to be issued, the Company is continuing to evaluate whether to formally terminate the Plan or merge it into the Viasat 401(k) Plan. While no formal action has been taken, any such decision could result in accelerated distributions or a transfer of participant accounts to another plan. The outcome and timing of this evaluation are uncertain, and the financial statements do not reflect any potential adjustments related to plan termination or merger.

Administrative Expenses: Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation in fair value of investments.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through October 14, 2025, which is the date the financial statements were available to be issued. No events have occurred subsequent to December 31, 2024, that require adjustment to or disclosure in these financial statements.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participant's account balances. Maturities on notes receivable from participants extend through September 2028. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, credit and risks as a result of global events. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 3 – CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividends, other income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1 – Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2 – Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3 – Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy. The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Money Market Fund: Valued at the daily closing price reported on the active market on which the individual fund is traded (Level 1 inputs).

Pooled Separate Account: The Plan invests in the JPMorgan Large Cap Growth Fund, a pooled separate account that is measured at net asset value (NAV) as a practical expedient. This investment is valued using the NAV provided by the investment manager, which represents the Plan's proportionate share of the fair value of the underlying assets in the fund. The NAV is determined using the market approach and is based on the fair value of the underlying investments less liabilities, divided by the number of outstanding units.

There are no unfunded commitments associated with this investment. The pooled separate account permits daily redemptions with no notice period or other redemption restrictions. The investment objective of the fund is to provide long-term capital appreciation primarily through investments in large-cap U.S. equity securities. Because this investment is measured at NAV, it is excluded from the fair value hierarchy classification.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 6 – TAX STATUS

The Internal Revenue Service issued an opinion letter dated November 14, 2022 indicating that the non-standardized pre-approved plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original non-standardized pre-approved plan document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
