Notes to Financial Statements For the Year Ended December 31, 2024

Note 1 - Plan Description

The following description of the Overlake Hospital Medical Center 403(b) Retirement Plan (the Plan) is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the plan document.

General - The Plan is a defined contribution plan covering substantially all employees of Overlake Hospital Medical Center and Overlake Medical Clinics, LLC (collectively the Hospital or Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Plan Administration - The Plan is administered by the Retirement Program Administrative Committee, which consists of certain employees of the Hospital. Fidelity Management Trust Company and Fidelity Workplace Services provide custodial and recordkeeping services for the Plan (collectively referred to as Fidelity). Empower Annuity Insurance Company of America (Empower) is the issuer of the Plan's annuity contracts and Empower Retirement, LLC is the recordkeeper for those contracts.

Contributions - Participants may elect to defer up to 75% of their eligible compensation as pretax or Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other eligible retirement plans (rollover). The Plan includes a provision whereby all newly eligible employees are automatically enrolled at a 5% deferral rate unless they elect a different deferral rate or not to participate in the Plan. Automatically enrolled participants will have their deferral rate increase by 1% each year, up to a maximum of 10%, unless otherwise elected.

The Hospital makes matching contributions equal to 100% of the first 7% of eligible compensation that a participant contributes to the Plan for participants with five or more years of service and 100% of the first 5% of eligible compensation that a participant contributes to the Plan for participants with fewer than five years of service. Participants must be credited with 1,000 hours of service during the plan year to receive employer matching contributions. The 1,000 hours of service requirement is waived if a participant terminates employment during the plan year because of: (i) death; (ii) disability or attainment of normal retirement age in the current plan year; or (iii) on account of the participant's disability or attainment of normal retirement age in a prior plan year.

The Hospital may also make discretionary nonelective contributions. There were no nonelective contributions made for the plan year ended December 31, 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts - Each participant's account is credited with the participant's contributions and matching contributions, as well as allocations of the Hospital's nonelective contributions (if any) and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

Vesting - Participants are immediately vested in their contributions as well as the Hospital's matching contributions plus actual earnings thereon. Vesting in the Hospital's nonelective contributions portion of their accounts (if any) is based on years of continuous service. A participant is 25% vested after two years of credited service and 100% vested after three years of credited service.

Note 1 - Continued

Forfeited Accounts - As of December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$73,000 and \$94,000, respectively. During 2024, approximately \$109,000 in forfeited accounts were used in accordance with the provisions specified in the Plan document.

Payment of Benefits - Upon termination of service, death, disability, or reaching normal retirement age, a participant or beneficiary may elect to receive installment payments or a lump-sum distribution equal to the value of the participant's vested interest in their account. Participants with investments held in the Empower fixed annuity contract may also have an annuity payment option. Participants who have attained age 59½ may also elect to receive a distribution of the deferral portion of their account prior to termination of employment (in-service withdrawals). The Plan allows for hardship withdrawals in accordance with provisions specified in the plan document. Participants may also elect to receive in-service withdrawals from balances rolled into the Plan.

Note 2 - Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Hospital. Expenses that are paid by the Hospital are excluded from these financial statements. Transaction based fees for distributions are charged directly to participant accounts. Certain investment related expenses are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements.

Subsequent Events - The Plan's management has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued.

Note 3 - Fair Value Measurements

GAAP provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than the quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs that are significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts - Accounts primarily consist of mutual funds that are valued consistent with the valuation description noted above, and interest-bearing cash, which is valued at cost plus accrued interest, which approximates fair value.

Variable Annuity Contracts - Valued based on the NAV of the fund and the quoted market prices of the underlying investments.

Note 4 - Certified Information

Certain information in the accompanying financial statements and supplementary information related to investments held as of December 31, 2024 and 2023, and investment income or loss for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company and Empower Annuity Insurance Company of America, qualified institutions. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

Note 5 - Party-in-Interest Transactions

Plan investments include mutual funds managed by Fidelity and its affiliates and variable and fixed annuity contracts issued by Empower. Transactions with such investments are party-in-interest transactions. The Plan pays certain expenses related to plan operations to various service providers. These transactions are also party-in-interest transactions.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Hospital has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their account balances.

Note 7 - Tax Status

The Hospital adopted an Eisenhower Carlson PLLC 403(b) volume submitter plan document. Eisenhower Carlson PLLC received an approval letter from the IRS dated June 2, 2023, which states that the form of the plan document satisfies the applicable provisions of Section 403(b) the Internal Revenue Code. The Plan's management believes that the Plan is designed and currently being operated in a manner that would not jeopardize the tax benefits associated with these arrangements. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 - Delinquent Contributions

The Employer determined there were instances during 2024 in which participant deferral contributions were not deposited by the Employer as plan assets within the time limitation stipulated under the Department of Labor's regulations. Delinquent contributions are prohibited party-in-interest transactions under ERISA and also represent related party transactions between the Plan and the plan sponsor. In total, \$962 of deferral contributions were identified as delinquent. The Employer is currently working with Fidelity to calculate and remit lost earnings associated with these delinquent deposits.
