## Report of Independent Auditors

To the Plan Administrator of the

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the EMCOR Facilities Services, Inc. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

## Notes to Financial Statements

December 31, 2024

### **1. Description of the Plan**

The following description of the EMCOR Facilities Services, Inc. Field Employees 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete information regarding the Plan’s provisions.

#### **a. General**

The Plan is a profit sharing and voluntary 401(k) savings plan sponsored by EMCOR Facilities Services, Inc. (the “Company”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). All regular, non-union commercial services field employees of the Company are eligible to participate in the Plan on the first of any calendar month.

T. Rowe Price Trust Company (the “Trustee”) is the trustee and custodian for the Plan. The Trustee holds the Plan assets and is responsible for executing investment transactions.

The Company has evaluated all subsequent events for the Plan through October 13, 2025, the date these financial statements were available to be issued.

#### **b. Contributions**

Participants may contribute any whole percentage of their compensation from 1% to 50% as a basic contribution, subject to limits based on Internal Revenue Service (“IRS”) guidelines. Additionally, Plan participants may change the percentage of compensation deferred at any time. Contributions made by Plan participants may be stopped at any time. The Company may make a discretionary contribution after the end of the Plan year, not to exceed 5% of the participant’s compensation. No such discretionary contributions were made in 2024. Certain participating groups are eligible for a periodic Company match or a Company contribution.

#### **c. Participant Accounts**

Participants are permitted to direct their investments into different investment options in increments of 1% and participants may change their elections at any time. Any new election may apply to future contributions or to existing account balances, as the participant elects. Employer contributions, if any, are invested in the same investment funds and at the same investment percentages elected by participants for their own future contributions. Each participant’s account is credited with the participant’s contribution, the Company’s matching contribution, if any, and Plan earnings or losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

## Notes to Financial Statements (continued)

### 1. Description of the Plan (continued)

#### d. Vesting

All participants are vested immediately in their voluntary contributions plus earnings thereon. Vesting in discretionary, matching, or other Company contributions that may be made to the Plan plus earnings thereon is based on years of continuous service. Participants are vested according to the terms of the Plan.

Forfeitures of non-vested matching contributions are used to reduce future Company contributions or to pay Plan administrative expenses. Total forfeited balances of terminated participants' non-vested accounts were zero as of December 31, 2024 and 2023. Total forfeitures used in 2024 were \$93,475.

#### e. Withdrawals and Distributions

Generally, participants may not withdraw funds until after termination of employment or until attaining age 59½, subject to certain limitations. A participant may, however, apply in writing to the administrator of the Plan at any time for an emergency "hardship" withdrawal. Such a withdrawal may only be made for an immediate and severe financial need and may not exceed the amount needed to meet the cost of the hardship.

Upon termination of employment for any reason, other than death, the participant may elect to receive a lump-sum cash payment as soon as practicable after the valuation date following the date of termination. Alternatively, a terminated participant who has attained age 59½ may elect to receive periodic partial distributions of their vested account balance. Terminated participants with account balances greater than \$5,000 may also elect to leave their investments in the Plan until they either reach the statutory age requiring distribution or they consent to receive payment.

Upon the death of a participant, a single lump-sum distribution will be made to the participant's beneficiary or beneficiaries.

### **1. Description of the Plan (continued)**

#### **f. Participant Loans**

Generally, participants may borrow from their fund accounts a minimum of \$1,000 to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, unless loan proceeds are used for the purchase of a principal residence, in which case the loan term can be extended to 15 years. A participant may not have more than one loan outstanding at any time. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with the prevailing interest rate charged by commercial lenders. Interest rates on existing loans range from 3.25% to 9.50%. Principal payments and interest are paid through payroll deductions.

#### **g. Administrative Expenses**

Administrative expenses of the Plan are paid by the Plan or by the Company, depending on the nature of the expense.

#### **h. Plan Termination**

Although the Company has no intention to terminate the Plan, the Company reserves the right to amend, modify, or discontinue the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### **2. Summary of Significant Accounting Policies**

#### **a. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### **b. Payment of Benefits**

Benefits are recorded when paid.

#### **c. Notes Receivable from Participants**

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

### 2. Summary of Significant Accounting Policies (continued)

#### d. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

#### e. Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Net appreciation in the fair value of investments includes realized gains and losses on investments sold or disposed of during the year and unrealized gains and losses at year-end.

### 3. Investments

All investment information disclosed in the accompanying financial statements and supplemental schedule including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, dividends and interest income on notes receivable from participants for the year ended December 31, 2024, were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the Trustee.

### 4. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

#### 4. Fair Value Measurements (continued)

The three levels of the fair value hierarchy are described below:

Level 1 – Unadjusted quoted market prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- quoted prices for similar assets and liabilities in active markets
- quoted prices for identical or similar assets or liabilities in markets that are not active
- observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3 – Significant unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based upon the lowest level input that is significant to the fair value measurement in its entirety.

Following is a description of the valuation methodologies used for assets and liabilities measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – Valued at the net asset value, based on quoted market prices in active markets, of shares held by the Plan at year end.

Common/collective trusts – Measured at net asset value (“NAV”), as determined by the asset manager, for shares held by the Plan at year end. Such NAV has a readily determinable fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of assets available for benefits.

### 7. Party-in-Interest Transactions

The Plan holds investments in certain assets which are managed by T. Rowe Price, the trustee of the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

### 8. Income Tax Status

The Plan has received a determination letter from the IRS dated June 24, 2014, stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (the "Code") and, therefore, the related trust is exempt from taxation. Subsequent to this determination by the IRS, the plan was amended. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan as amended is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
