### *Disclaimer of Opinion*

We were engaged to audit the financial statements of Sharp Healthcare 403(b) Tax Deferred Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matters described in the *Basis for Disclaimer of Opinion* section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

### *Basis for Disclaimer of Opinion*

Prior to January 1, 2009, records were maintained at a contract, not a plan level; therefore, management has not maintained and did not provide sufficient accounting records and supporting documentation relating to certain annuity contracts and custodial accounts issued to current and former employees, and supporting documentation is not adequate to assure the completeness and accuracy of the amounts included in the financial statements. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the financial statements have been affected by these conditions.

As described in Note 2, the Plan has excluded from investments in the accompanying statements of net assets available for benefits certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, pursuant to the Department of Labor's Field Assistance Bulletin ("FAB") No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded in the accompanying statement of changes in net assets available for benefits. Accounting principles generally accepted in the United States of America (GAAP) require that these accounts and the related income and distributions be included in the accompanying financial statements.

### *Responsibilities of Management for the Financial Statements*

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP), and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.



In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

***Auditor's Responsibilities for the Audit of the Financial Statements***

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America (GAAS) and to issue an auditor's report. However, because of the matters described in the *Basis for Disclaimer of Opinion* section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

***Supplemental Schedule Required by ERISA***

We were engaged for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule of Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Because of the significance of the matters described in the *Basis for Disclaimer of Opinion* section of our report, it is inappropriate to and we do not express an opinion on the supplemental schedule referred to above.

### 1. Description of Plan

The following description of the Sharp Healthcare 403(b) Tax Deferred Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan covering eligible employees of Sharp HealthCare (the Principal Employer), and certain affiliated companies that are part of the 501(c)(3) organization and that have met certain eligibility requirements. Eligible employee must be full-time, part-time, or per-diem employees.

The affiliated entities of the 501(c)(3), each of which is owned or managed by the Principal Employer, that also sponsor the Plan, are as follows: Sharp Grossmont Hospital, Sharp Memorial Hospital, Sharp HealthCare, Sharp Chula Vista Medical Center, and Sharp Coronado Hospital and Healthcare Center. The Principal Employer and the affiliated entities are referred to together herein as the "Employers".

The Plan provides participants with a salary deferral option pursuant to Section 403(b) of the Internal Revenue Code. The Company serves as the administrator of the Plan. The Plan engages Lincoln Financial Group Trust Company (Trustee or Lincoln Financial Group) to hold and invest Plan assets and execute Plan transactions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### *Contributions*

Eligible employees may elect to defer a flat dollar amount or 1%-80% of pay period compensation, up to certain limits, as defined in the Plan. The Plan allows both pre-tax and Roth after-tax contributions. Participants who had attained age 50 by year end could also make catch-up contributions. There are no employer contributions to the Plan. A participant may, with the consent of the Plan administrator, make a rollover contribution to the Plan. Rollover contributions are assets transferred to the Plan from a qualified retirement savings plan in which an employee participated prior to employment with the Employers. Participants with 15 years or more of service are eligible for a special catch-up election of up to \$3,000 annually (\$15,000 lifetime maximum for 2024 and 2023). If both the age 50 catch-up and the special catch-up apply, the special catch-up applies first to its maximum extent, followed by the age 50 catch-up limit.

Contributions are subject to certain Internal Revenue Code (IRC) limitations.

#### *Contract Exchanges*

Employees have the option to exchange an existing contract from a 403(b) tax sheltered annuity contract established within the Plan prior to 2009.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions, rollover contributions from an employee's previous plan(s), and an allocation of the Plan's earnings and charged with an allocation of the Plan's losses and administrative expenses. Allocation of the Plan's earning or losses

and certain administrative expenses are based on each participant's account balance or participant requested services, as defined. Contributions to participant accounts are invested based upon participant-directed allocations. The benefit to which a participant is entitled is the benefit that can be provided by the participant's account.

### ***Vesting***

Participants are always 100% vested in their voluntary contributions and the allocated earnings thereon. There are no employer contributions.

### ***Payment of Benefits***

Participants are entitled to receive payment of their benefits in the event of retirement, death, disability, termination of employment, or attainment of age 59½. Distribution may be taken as a lump sum payment equal to the value of the participant's account balance. The Plan permits involuntary cash out distributions for those terminated participants whose account balance is \$7,000 or less.

Upon termination of employment, the Participant may elect to receive a lump-sum payment or defer the receipt of payment according to Plan provisions.

### ***Notes Receivable from Participants***

Participants may borrow from their participant accounts a minimum of \$1,000 not to exceed a maximum of \$50,000, or 50% of the participant's vested account balance, whichever is less. Participants are allowed a maximum of one loan outstanding. The notes are secured by the participant's vested account balances and are payable not to exceed five years, except for funds used to acquire a principal residence, which must have a repayment period within a reasonable time commensurate with the repayment period permitted by commercial lenders for similar loans. Interest rates must be commensurate with the interest rates charged by persons in the business of lending money for loans under similar circumstances. The notes are repaid ratably and directly by participants. These loans are subject to certain restrictions as defined by the Plan document and applicable restrictions under the IRC.

### ***Hardship Withdrawals***

Participants may withdraw all or a percentage of their pre-tax account balances upon approval of the Plan Administrator and subject to IRC hardship withdrawal rules. The recordkeeper limits Participants to a total of two hardship withdrawals in a 12-month period, if eligible.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### *Annual Reporting Requirements*

Prior to January 1, 2009, records were maintained at a contract level, not Plan level, and certain vendors administratively decided not to provide accounting records and supporting documentation at the participant or plan level relating to certain annuity and custodial accounts issued to current and former employees. As such, the Plan sponsor has not been able to produce sufficient records and supporting documents relating to certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009. As a result, the completeness and the accuracy of the annuity and custodial accounts, related investment income, and distributions related to these accounts, if any, could not be determined.

Additionally, certain plan assets are excluded from investments in the accompanying statements of net assets available for benefits, including certain annuity and custodial accounts issued to former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded from the accompanying statement of changes in net assets available for benefits.

Specifically, the administrator of a 403(b) plan does not need to treat annuity contracts and custodial accounts as part of the employer's Title I plan or as plan assets for purposes of ERISA's annual reporting requirements provided that:

- The contract or account was issued to a current or former employee before January 1, 2009.
- The employer ceased to have any obligation to make contributions (including employee salary reduction contributions), and in fact ceased making contributions to the contract or account before January 1, 2009.
- All of the rights and benefits under the contract or account are legally enforceable against the insurer or custodian by the individual owner of the contract or account without any involvement by the employer.
- The individual owner of the contract is fully vested in the contract or account.

The amount of these excluded annuity contracts and custodial accounts, and the related income and distributions are not determinable. Accordingly, no auditing procedures were performed related to these excluded undeterminable amounts. U.S. GAAP requires that these accounts and the related income and distributions be included in the accompanying financial statements.

### *Use of Estimates*

The preparation of the financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts, which are stated at contract value (see Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Contribution Receivable***

Participant contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance. Any accrued but unpaid interest is de minimis. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employers. Expenses that are paid by the Employers are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments. The plan further maintains an expense account to pay administrative and other Plan expenses, funded by fees received from eligible investments. Total fees received to pay administrative fees in December 31, 2024 were \$832,626. Assets in the expense account are invested in Lincoln Financial Group Stable Value Annuities and amounted to \$1,577 and \$1,113 as of December 31, 2024 and 2023, respectively.

## **3. Fair Value Measurements**

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.

- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds* - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-Directed Brokerage Account* - These accounts are comprised of mutual funds and money market funds. The mutual funds and money market funds are valued at the NAV that is quoted on an active market and is determined based on the fair value of the underlying assets at the end of each day.

*Pooled Separate Account (PSA)* - Valued at the NAV of the units of the PSA. The NAV, as provided by the trustee of the PSA, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The fair value of the underlying investments, which can consist of a single mutual fund or multiple securities, is determined using market quotations or prices obtained from independent pricing sources. The unit value of the pooled separate account is based upon significant observable inputs. NAV would not be used if it was probable that the investment would not be traded at NAV. The PSA provides for daily redemptions by the Plan at reported NAV with no advance notice. There are no unfunded commitments related to these investments. The initial pricing input is the quoted price obtained for the underlying mutual fund which is then adjusted to apply separate account expenses. This investment is a direct filing entity.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 4. Tax Status

The Plan uses a pre-approved plan document sponsored by Lincoln Retirement Services Company LLC. Lincoln Retirement Services Company LLC received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the IRC. Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

## 5. Investment in Fully Benefit-Responsive Investment Contract

In 2009, the Plan entered into a fully benefit-responsive investment contract in the form of an insurance contract with Lincoln National Life Insurance Company (Lincoln National). Currently Lincoln Investment Advisors Corporation serves as the advisor for the Lincoln Financial Group Stable Value Annuities (insurance contract). Lincoln National maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for

participant withdrawals and administrative expenses. The contract is a traditional contract and is included in the financial statements at contract value as reported to the Plan by Lincoln National.

Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participant withdrawals and transfers from the insurance contract are paid at contract value but funded through the market value liquidation of the underlying investments, which also impacts the interest crediting rate. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The crediting interest rates were approximately 3.0% for the years ended December 31, 2024 and 2023. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than a 3.0% effective annual interest rate. Such interest rates are reviewed on a quarterly basis for resetting.

In certain circumstances, the amount withdrawn from the contract would be payable at fair value rather than at contract value. These events include termination of the Plan, a material adverse change to the provisions of the Plan, a Principal Employer election to withdraw from a contract in order to switch to a different insurance provider, or if the terms of a successor plan (in the event of the spin-off or sale of a division) do not meet the contract issuer's underwriting criteria for issuance of a new contract. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable. The Lincoln Stable Value Fund is compared to the liquidity of Lincoln National. The contract will transact at contract value provided Lincoln National remains liquid. Review of Lincoln National audited financial statements did not show an excess of liabilities over assets for December 31, 2024 or 2023.

### **6. Related Party and Party-in-Interest Transactions**

Certain Plan investments are invested in the Lincoln Stable Value Contract and the Lincoln National Variable Annuity Account, both offered by the LNLIC. Both LNLIC and Lincoln Retirement Services Company, LLC, the Plan's recordkeeper, have the same parent company, Lincoln Financial Group. As such, recordkeeping expenses paid to Lincoln National Corporation and transactions for the Lincoln Stable Value Contract and the Lincoln National Variable Annuity Account qualify as party-in-interest transactions. Additionally, notes receivables from participants are considered exempt party-in-interest transactions.

### **7. Plan Termination**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

### **8. Risks and Uncertainties**

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.
