Note 1. Description of the Plan

General

The following description of the Health Benefits Plan for the Employees of Stockman Financial Corp. (the Plan) provides only general information about the Plan's provisions. Participants should refer to the plan document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the plan administrator.

Generally, the Plan provides health and welfare benefits to employees who work on a continuing and regular basis of at least 17.5 hours per week. Employees are eligible the first day of the month following the completion of 59 days of work.

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Benefits

The Plan provides medical, dental, vision, prescription, and short-term disability benefits to eligible associates of Stockman Financial Corp. (the Sponsor) and their eligible dependents as defined by plan documents. The trust funds certain health and welfare benefits provided by the Sponsor. Long-term disability, accidental death and dismemberment, and life insurance benefits are provided through insurance contracts. The Plan also provides continuation of certain benefits upon termination of employment through the *Consolidated Omnibus Budget Reconciliation Act* (COBRA).

Stop-Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-funded benefits. The Plan is responsible for individual claims up to \$200,000 per year, not to exceed an overall aggregate limit that varies with the number of active participants. The insurance carrier may increase the Plan's responsibility for individual claims for specified individuals on an annual basis during policy renewal.

Insured Benefits

The Plan fully insures the life insurance (basic, supplemental, and dependent), accidental death and dismemberment, and long-term disability benefits through insurance contracts. Premiums for life insurance and accidental death and dismemberment programs are recorded as premium payments in the accompanying statements of changes in net assets available for benefits. Premiums for the long-term disability program are paid to the insurance company from the general assets of the Sponsor.

Self-Insured Benefits

The Plan is "self-insured" for medical, dental, vision, prescription, and short-term disability benefits up to individual and aggregate stop loss limits. The claims for self-insured benefits (other than short-term disability) are processed by the Plan's third-party claims processor under administrative services only (ASO) arrangements. The claims processor pays claims directly to, or on behalf of participants, and is then reimbursed by the Plan's 419(a) trust. Despite the Plan's utilization of a third-party claims processor, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

The Plan has flexible spending account (FSA) arrangements for health care and dependent care reimbursements that are funded solely by active employee contributions. The FSA's allow eligible participants to be reimbursed tax free for qualified health care and dependent care expenses subject to annual limitations established under the Plan. The employer is not permitted to refund any part of the FSA balances to the employee; the accounts cannot be used for anything other than qualified health care and dependent care expenses; remaining amounts are not portable upon termination once the employee leaves the employer; any unused amount is forfeited back to the plan sponsor. \$500 of unused FSA amounts remaining at the end of the Plan year may be carried over to the next Plan year to pay for qualifying expenses in addition to the amount elected for that year.

Contributions

In addition to deductibles and copayments, participants may contribute specified amounts, based on applicable monthly premiums for their respective benefit elections. Participants pay the full cost of supplemental and dependent life insurance and supplemental accidental death and dismemberment insurance programs, based on the current group rate premium cost. The Sponsor pays the full cost of basic life insurance and basic accidental death and dismemberment insurance.

The Sponsor makes contributions to the Plan as needed to fund stop loss insurance and claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Sponsor on a pay-as-you-go basis.

Plan Termination

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Sponsor or be used for purposes other than for the exclusive benefit of the Plan's participants.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, IBNR, eligibility credits, claims payable and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Premiums paid by the 419(a) trust are recorded as premium payments in the accompanying statements of changes in net assets available for benefits.

Claim payments are recorded when submitted to the Plan by the third-party claims processor for reimbursement. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as due to claims processor in the accompanying statements of plan's benefit obligations. Amounts funded by the Plan that have yet to be paid by the claims processor are recorded as a prepaid asset in the statements of plan's benefit obligations. Short-term disability payments are processed by the Sponsor and paid from the general assets of the Sponsor. These payments are recorded as claims paid in the accompanying statements of changes in net assets available for benefits.

Stop Loss

Premiums for stop loss insurance are included in premium payments in the accompanying statements of changes in net assets available for benefits. Stop loss refunds totaling approximately \$144,000 and \$287,000 have been netted with claims paid in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively.

Refunds

Refunds due from the Plan's PBM are recorded when earned. Refunds due as of the financial statement date have been reported as a receivable, with the offset being netted against claims paid. Pharmacy rebates totaling approximately \$284,000 and \$209,000 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively.

Flexible Spending Accounts

Included in the accompanying statements of net assets available for benefits are amounts available to reimburse participants for qualifying medical expenses as of December 31, 2024 and 2023, totaling approximately \$84,000 and \$110,000, respectively. Claims incurred before plan year-end that were submitted after year-end (but before the date defined by the Plan agreement) totaled approximately \$70,000 and \$66,000 relating to 2024 and 2023, respectively. Forfeited amounts are used by the Sponsor to offset Sponsor contributions in the year forfeited.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion on fair value measurements.

Interest income is recorded on the accrual basis.

Administrative Expenses

Administrative expenses incurred in the administration of the Plan that are paid by the Plan include managed care fees and medical administrative fees. These expenses are recorded as deductions in the accompanying statements of changes in net assets available for benefits. Expenses that are paid by the Sponsor, such as professional fees, are excluded from these financial statements.

Benefits Obligations

Plan obligations on December 31, 2024 and 2023 for health claims incurred by participants, but not reported at that date, are estimated based on an analysis of claims paid subsequent to the Plan year-end. Such estimated amounts are included in the accompanying statements of Plan's benefit obligations.

Note 3. Disclosures About Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Money market deposit accounts: Valued at the carrying value, which approximates fair value, based on the amount of net contributions plus any investment earnings allocated to the account.

Note 4. Tax Status

The trust established to hold the Plan’s assets is intended to qualify pursuant to Section 419(a) of the Internal Revenue Code (IRC) and, accordingly, the trust’s net investment income is exempt from income taxes. The Sponsor believes that the trust, as amended, continues to qualify and to operate in accordance with applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Plan investments are money market deposit accounts held by Stockman Bank. Stockman Bank is affiliated with Stockman Financial Corp. and, therefore, transactions involving these funds qualify as exempt party-in-interest transactions. As described in Note 2, the Plan has several arrangements with service providers. Such providers are parties in interest under ERISA. The Plan paid approximately \$189,000 and \$172,000 of recordkeeping and Plan management fees during 2024 and 2023, respectively. The Sponsor provides certain administrative services at no cost to the Plan.

Claims that have been processed and approved for payment at year-end, but not paid and claims incurred but not reported are not presented as liabilities or claims paid in the accompanying financial statements, but are recorded on the Form 5500 as a liability.

Note 7. Risks and Uncertainties

The estimated liability for claims incurred but not reported is based on historical trend information, which is subject to change. Due to uncertainties inherent in the estimation process, it is at least reasonably possible that changes in this estimate in the near term would be material to the financial statements.

Note 8. Concentration of Credit Risk

The Plan maintains its cash accounts at one financial institution. The Plan's balance at the financial institution was in excess of the federal insurance limits by approximately \$7,073,000 and \$6,465,000 as of December 31, 2024 and 2023, respectively.

Note 9. Plan Amendments

Effective January 1, 2023, the Specialty Pharmacy Copay Assistance Program in Plan I had a name change for the Telemedicine – SaveOn Program and Discount Card Program.

Effective January 1, 2023, in Plan II – HDHP, within “Pharmacy Benefit”, “Specialty Pharmacy Copay Assistance Program” is added immediately following “CIGNA 90 NOW”.

Effective May 12, 2023, in Plan I and Plan II – HDHP, COVID 19 changes within the plan. It is no longer considered a national emergency.

Effective August 31, 2023, in Plan I and Plan II – HDHP, some home delivery pharmacy charges changed. Benefits are payable up to \$5,000 maximum lifetime benefit, limited to the following: coach airfare. If driving, IRS standard mileage rate reimbursement. Meals limited to \$50 per day per person. Lodging not to exceed \$125 per day.

Effective April 1, 2024, in Plan I and II – HDHP, the Waiting Period to become eligible will not apply to an employee who becomes eligible as a result of the acquisition of the Montana Central Insurance Agency.
