### TO THE PLAN ADMINISTRATOR AND TRUSTEES OF ECHELON SUPPLY & SERVICE, INC. 401(K) PLAN

#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of **Echelon Supply & Service, Inc. 401(k) Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Echelon Supply & Service, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## **Opinion**

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. ## **Responsibilities of Management for the Financial Statements**



### NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

#### NOTE 1 – GENERAL DESCRIPTION OF THE PLAN

---

The following brief description of Echelon Supply & Service, Inc. 401(k) Plan (the “Plan”), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan under Section 401(a) of the Internal Revenue Code (“IRC”) and includes a Section 401(k) salary deferral arrangement. The salary deferral portion covers substantially all employees of Echelon Supply & Service, Inc. (the “Company”) who have completed sixty days of service and are twenty-one years of age or older. The profit-sharing portion covers all employees of the Company who have completed one full year of service consisting of at least 1,000 hours, are twenty-one years of age or older, and are employed as of the last day of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Effective January 1, 2023, the Plan merged with the Berg-Nelson Company, Inc. 401(k) Plan, which transferred their assets to the Plan and adopted the Plan’s provisions, and will operate as one plan under the Echelon Supply & Service, Inc. 401(k) Plan.

##### **Contributions**

Each year, participants may contribute a percentage of their pre-tax annual compensation, as defined by the Plan, subject to maximum limitations established by the IRC. Participants may also contribute amounts representing distributions from other qualified defined contribution or benefit plans. In addition, participants who meet certain age requirements are allowed to make catch-up elective deferrals.

Discretionary contributions may be made at the option of the Company's management. Contributions are subject to certain limitations. The Company elected not to make discretionary contributions for the years ended December 31, 2024 and 2023.

##### **Participant Accounts**

Each participant’s account is credited with the participant's elective salary deferral contribution, allocation of any employer discretionary contribution and Plan earnings, and rollover contributions. Allocations are based on participant earnings or account balances, as defined by the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their elective salary deferral contributions, rollover contributions, plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service.

**Payment of Benefits**

Upon termination of service due to disability or retirement, a participant or beneficiary may elect to receive either a lump-sum amount equal to the vested value of the participant's account or annual installments over a period selected by the participant or beneficiary, which may not exceed the participant's or beneficiary's life expectancy. For termination of service due to other reasons, a participant or beneficiary may receive the value of the vested interest in the participant's account as a lump-sum distribution.

Hardship withdrawals are permitted in the event of immediate and heavy financial need. Participants may elect to receive a hardship withdrawal in an amount equal to the value of their elective salary deferral contributions, not including earnings.

**Forfeitures**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$42,000 and \$37,000, respectively. These forfeitures can be used to reduce the plan administrative expenses or the employer discretionary contributions. Plan administrative expenses were reduced by approximately \$5,500 and \$6,400 for the years ended December 31, 2024 and 2023, respectively, from forfeited non-vested accounts.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms range from one to five years or up to 10 years for the purchase of a primary residence. Notes are secured by the balance in the participant's account and bear interest at prime plus 1.00%. Participants are permitted to have only one loan outstanding at a time. Principal and interest are paid ratably through payroll deductions.

**NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES**

---

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of the financial statements in conformity with generally accepted accounting principles requires Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from these estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the fully-benefit responsive investment contract with an insurance company, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodian and record-keeper. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net investment gain (loss) includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

**NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES – Continued**

**Risks and Uncertainties**

The Plan provides for various investment options in any combination of various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Notes Receivable from Participants**

Notes to participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in the participant's outstanding loan balance. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net investment gain (loss) from investments.

**Subsequent Events**

Plan management has evaluated subsequent events from December 31, 2024 through October 8, 2025, which is the date the financial statements were available to be issued. Management has determined no such events have occurred.

**NOTE 3 – FINANCIAL INFORMATION CERTIFIED BY PLAN CUSTODIAN**

---

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator has obtained a certification from Voya Retirement Insurance and Annuity Company, the custodian of the Plan, that all of the information provided by them is complete and accurate. Information included in the accompanying financial statements and supplemental schedule as of and for the years ended December 31, 2024 and 2023 pertaining to investments, notes receivable from participants, interest income, net investment gain (loss) and all information in the supplemental schedule is presented in reliance solely upon those certifications.

**NOTE 4 – FAIR VALUE**

---

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) No. 820, “*Fair Value Measurements*” are described as follows:

Level 1        Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities that the Plan can access at the measurement date.

Level 2        Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3        Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**NOTE 4 – FAIR VALUE – Continued**

---

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There has been a change in the methodologies used at December 31, 2024 in regard to the Voya Fixed Account (see Note 5). There have been no other changes in the methodologies used at December 31, 2024 and 2023.

*Money Market Fund:* Valued at the shared net asset value, based on quoted market prices in active markets, or shares held by the Plan.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Investment Contract with Insurance Company:* An investment contract with Voya Retirement Insurance and Annuity Company that guarantees principal and a guaranteed minimum interest rate ("GMIR") for the life of the product as well as two declared interest rates; a current rate, determined at least monthly, and a guaranteed minimum floor rate declared for a defined period (currently one calendar year). The current rate, the guaranteed minimum floor rate and the GMIR are expressed as annual effective yield. Plan Management had previously determined the investments are not fully-benefit responsive due to restrictions that apply to transfers and withdrawals from the accounts. The market value was determined by comparing the contract agreement to an applicable rate, the fixed account interest rate, and the date of contract issuance. As discussed in Note 5, Plan Management has reevaluated the contract as of January 1, 2024, and determined the contract to be fully-benefit responsive and is now reported at contract value for the Plan year ended December 31, 2024.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 – CHANGE IN CLASSIFICATION OF INVESTMENT CONTRACT**

During the year ended December 31, 2024, the Plan re-evaluated the terms of its investment contract with Voya Retirement Insurance and Annuity Company and determined that the contract now meets the criteria to be classified as fully benefit-responsive under FASB ASC 962-325-35-9. As a result, the Plan changed the measurement of this investment contract from fair value to contract value in the statement of net assets available for benefits, effective January 1, 2024. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The change in classification was applied prospectively as the effect on prior periods was not material to the financial statements. Accordingly, prior period amounts have not been restated.

The total contract value of the investment contract as of December 31, 2024 was \$959,804.

**NOTE 6 – GUANANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY**

---

The Plan invests in the Voya Fixed Account, a group annuity contract issued by Voya Retirement Insurance and Annuity Company. The Voya Fixed Account is a fully benefit-responsive investment contract, measured at contract value, which represents contributions made under the contract, plus credited earnings, less participant withdrawals and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. While participant-initiated transactions (e.g., withdrawals, loans, distributions, and transfers to non-competing funds) are permitted at contract value, transfers to certain competing funds may be subject to an equity wash provision, which requires balances to first be transferred into a non-competing option for a stated period. Withdrawals initiated by the Plan (such as contract termination or bulk transfers not initiated by participants) may be subject to a market value adjustment (MVA) or surrender charge. These provisions do not affect the fully benefit-responsive status of the investment, as participants may access contract value for all plan-permitted transactions.

The interest credited to participant accounts is determined periodically by the insurance company and is not less than the guaranteed minimum rate specified in the contract.

**NOTE 7 – RELATED-PARTY AND PARTIES IN INTEREST TRANSACTIONS**

---

Plan investments are managed by Voya Retirement Insurance and Annuity Company, the custodian as defined by the Plan, and therefore recordkeeping, loan, and benefit payment processing transactions qualify as party-in-interest transactions. Fees incurred and paid directly by the Plan participants for recordkeeping, loan and benefit payment processing to Voya Retirement Insurance and Annuity Company were approximately \$11,300 and \$13,900 for the years ended December 31, 2024 and 2023, respectively.

**NOTE 8 – INCOME TAX STATUS**

---

The Company has adopted the Voya Retirement Insurance and Annuity Company Non-Standardized Defined Contribution Plan. The Plan obtained its latest determination letter on June 30, 2020, in which the IRS ruled that the non-standardized prototype plan of Voya Retirement Insurance and Annuity Company Plan is acceptable under Section 401(a) of the IRC. Although the Plan has been amended since the date of the letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As the Plan is tax-exempt, the Plan administrator has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 9 – PLAN TERMINATION**

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.
