Their audit report dated July 24, 2024 indicated that in their opinion (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Note 1 - Description of Plan

The following description of the AI Signal Research, Inc. 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of AI Signal Research, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Trustees are responsible for oversight of the Plan.

Eligibility

Participation in the Plan is available to all eligible employees of the Company, excluding nonresident aliens, leased employees, and residents of Puerto Rico. Employees are automatically enrolled in the Plan and are eligible to receive employer contributions after completing one year of service.

Contributions

Participant Salary Deferral – Participants become eligible on their date of hire. Each year, participants may contribute up to 100% of pretax annual compensation, as defined by the Plan, up to maximum amounts established by the Internal Revenue Service (IRS). Participants 50 years old or older during the Plan year are eligible to make catch-up contributions, up to maximum amounts established by the IRS. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants made pretax contributions of \$1,989,585 for the year ended December 31, 2024.

Participant Roth Deferral - Participants may designate some or all of the salary deferral as a Roth Deferral at the time the participant makes his or her deferral election. Once made, this election is irrevocable (that is, a Roth Deferral cannot be later re-characterized as a pretax salary reduction). The amount of the Roth Deferral is included in the participants' income for tax purposes, and the income tax withholding amounts are deducted from the remainder of compensation, not from the Roth Deferral amount. Participants made Roth contributions of \$249,436 for the year ended December 31, 2024.

Prevailing Wage Rate - For participants performing work under a prevailing wage contract, the Company makes prevailing wage rate contributions in an amount equal to the fringe benefit amount determined according to the prevailing rate schedule for each participant reduced by contributions made to other plans that count toward satisfying the fringe rate stated in the prevailing rate schedule. The Company made a prevailing wage rate contribution of \$608,321 for the year ended December 31, 2024.

Employer Safe Harbor Nonelective - The Company contributes to the Plan an amount equal to 3% of each eligible participant's compensation, as defined by the Plan, for the Plan year. The Company made an employer safe harbor contribution of \$612,520 for the year ended December 31, 2024.

Employer Matching - The Company may elect to make matching contributions equal to a discretionary percentage of the participant's elective contributions that are not in excess of 6% of the participant's compensation. The Company's matching contributions in any Plan year will not exceed 4% of the participant's compensation. The Company did not make a matching contribution for the year ended December 31, 2024.

Employer Profit Sharing - The Company may also elect to make a discretionary profit-sharing contribution based on eligible compensation to participants employed on the last day of the Plan year. The Company did not make a profit-sharing contribution for the year ended December 31, 2024.

Investment Options

Participants direct the investment of their contributions, as well as Company contributions, into various investment options offered by the Plan. As of December 31, 2024 and 2023, the Plan offered money market funds, shares of registered investment companies, which invest in various combinations of stocks, bonds, and other investment securities and a fully benefit-responsive guaranteed investment contract.

Vesting

Participants are vested immediately in their voluntary contributions, the Company's safe harbor nonelective, prevailing wage contributions, discretionary matching, and discretionary profit-sharing contributions, plus actual earnings thereon.

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of the Company's contributions and Plan earnings based on participant's specific investments and account balances. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at a fixed rate ranging from 3.25% to 9.50%, which are commensurate with the Plan's participant loan policy. A loan is considered in default if the missed loan payment is not remitted by the last day of the calendar quarter following the calendar quarter in which the required payment was due but not made. Principal and interest are paid ratably through payroll deductions. Loan terms may not be greater than five years unless the loan is used for purchase of primary residence. The maximum number of loans a participant may have outstanding at any time is one, unless one loan is a principal residence loan amortized for a period greater than five years, or there was more than one loan outstanding at the time this loan policy took effect, January 1, 2013. The Plan allows participants to rollover loans directly into another plan without a mandatory cash out provision.

Payment of Benefits

Benefits commence upon one of several dates: retirement, disability, death, hardship distributions, or termination of employment. Benefits are distributed by means of either direct rollover, lump sum distribution, or by one of various conventional annuity options.

Note 2 - Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments in the fully benefit-responsive investment contract are reported at contract value. The Plan's investments in all of the mutual funds are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recognized when paid generally in accordance with the Company's payroll schedule. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator considers the participant loan to be in default, the participant loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan Document

Payment of Benefits

Benefit payments to participants are recorded when requested by participant.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain expenses related to the administration of the Plan are allocated to the participant's account, in accordance with the Plan document, and are included in administrative expenses. Fees related to the administration of notes receivable from participants and payment of benefits to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Recent Accounting Pronouncements

The AICPA Financial Reporting Executive Committee (FinREC) approved enhance accounting updates related to accounting for revenue sharing arrangements in accordance with Financial Accounting Standards Board (FASB) ASC No. 606, *Revenue from Contracts with Customers*. Revenue sharing amounts are not considered revenue under ASC No. 606 due to the fact that they are intended to reduce administrative costs for the plan and not paid to the plan for delivering or producing goods, rendering services or undertaking other activities for the investment manager. A plan should consider all relevant facts and circumstances, including the terms of the agreement to determine the appropriate presentation of revenue sharing amounts. The presentation should be applied on a consistent basis and the plan should consider whether the presentation of revenue sharing amounts is a significant accounting policy that should be disclosed in the notes to the financial statements. If significant, the notes to the financial statements include a description of revenue sharing arrangements including how such arrangements are presented in the financial statements. The adoption did not have a material impact to the Plan's financial statements.

Recent Legislative Developments

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the years ended December 31, 2024 and 2023. Plan management continues to evaluate the impact of the optional provisions of SECURE 2.0 and awaiting additional guidance from the Internal Revenue Service (IRS) and Department of Labor. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements for the plan years ended December 31, 2024 and 2023.

The Plan Sponsor operationally implemented various changes and will timely amend the Plan for these changes.

Note 3 - Information Prepared and Certified by Custodian

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Reliance Trust Company (the Custodian of the Plan) as of and the for the years ended December 31, 2024 and 2023.

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, included in the Plan's financial statements and supplemental schedules that was prepared by or derived from information provided by the Custodian and furnished to the Plan Administrator.

Note 4 - Fair Value Measurements

Financial Accounting Standards Board (FASB) ASC 820, *Fair Value Measurements and Disclosures*, established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Shares of registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5 - Guaranteed Investment Contract with Insurance Company

The Plan's investments include a benefit-responsive guaranteed contract with Standard Insurance Company. The Standard Stable Asset A is a guaranteed general account backed group annuity contract that has been issued by Standard Insurance Company. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Note 5 - Guaranteed Investment Contract with Insurance Company

Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Contract value, as reported to the Plan by Standard Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. As of December 31, 2024, the Plan Sponsor has no intention to terminate the contract; therefore, contract value represents fair value.

The Standard Stable Asset A is a group annuity contract with a fixed rate of interest. The guaranteed crediting rate is determined by calculating the weighted average of its underlying guaranteed interest funds; however, it may not be less than 1% annually. The crediting rate established in the contract is reset on a quarterly basis. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, changes to the Plan's prohibition on competing investment options, deletion of equity wash provisions, and the liberalization of plan withdrawal or transfer rules. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

Note 6 - Related-Party and Party in Interest Transactions

Reliance Trust Company is the Custodian as defined by the Plan. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan made direct payments to service providers of \$123,220 which was not covered by revenue sharing. The Plan Sponsor pays directly any other fees related to the Plan's operations.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100% vested in their employer contributions.

Note 8 - Tax Status

The underlying Standard Retirement Services, Inc. non-standardized pre-approved profit sharing plan with CODA has received an opinion letter from the IRS dated June 30, 2020 which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has been amended since receipt of the opinion letter, the Plan Administrator is taking steps to bring the Plan in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Company has taken a significant uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 - Risks and Uncertainties

The Plan invests in a variety of investments. Investments in general are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10 - Prohibited Transactions

During the Plan year ended December 31, 2024, participant contributions and loan repayments totaling \$70,257 were not remitted to the Plan within the period prescribed by DOL regulations. These transactions constitute non-exempt party-in-interest transactions or prohibited transactions described by ERISA. The Company is in the process of correcting these transactions. The related net earnings are expected to be remitted to the Plan during 2025.

Note 11 - Transfer of Plan Assets and Loan Balances

During 2024, the Company permitted the transfer of loan balances and related account balances totaling \$133,375 and \$851,018 respectively, into the Plan. These transfers were the result of a government contract transition under which certain participants of the Astrion Retirement Plan became participants in the Plan.

Note 12 - Subsequent Events

Plan Amendment

Effective April 1, 2025, the Plan was amended to include the ability for participants to change or revoke their salary deferral elections at any time, with modifications effective as soon as administratively feasible after received by the Administrator.

Date of Management's Review

Management has evaluated subsequent events through October 10, 2025, the date which the financial statements were available to be issued.
