Note 1 - Plan Description

The following description of Marshall, Gerstein & Borun LLP Salary Savings & Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Marshall, Gerstein & Borun LLP (the "Company"). Participants are eligible to participate in the Plan after completing one year of service, defined as completion of 1,000 hours of service, and attaining the age of 21. Participants may join the Plan on the first day of the Plan year and the first day of the seventh month of the plan year. The Company also sponsors a new hire plan for employees who have not met the service requirements of the Plan. Once the eligibility requirements of the Plan are met, participant balances in the new hire plan are transferred to the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides for employee 401(k) deferral contributions up to 90 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions in addition to their regular deferral contributions. Participants have the option to designate all or a portion of their contributions as Roth 401(k) contributions, which are made out of after-tax earnings. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans other than after-tax contribution accounts. Once an employee is eligible to participate in the Plan, employee deferral contributions are automatically made at the rate of 3 percent of the employee's eligible compensation unless the employee elects a different deferral rate or elects not to participate in the Plan.

The Company may make discretionary matching and nonelective contributions. During 2024, the Company made matching contributions equal to 100 percent of participants' deferral contributions up to the first 1 percent of compensation up to a maximum benefit of \$1,500. Equity partners do not participate in the discretionary matching contributions. During 2024, the Company made nonelective contributions equal to 5 percent of participants' compensation for employees with one year of service; 7 percent of participants' compensation for employees hired on or after January 1, 2002 with at least two years of service; and 9 percent of participants' compensation for participants hired on or before December 31, 2001 on the first \$150,000 of compensation. Additional amounts were contributed so that participants received 4.45 percent on all compensation up to the IRS maximum. For participants who have been equity partners of the Company for four years or more and are at least 36 years old as of the beginning of the plan year, 13.33 percent of their compensation is contributed by the Company. However, in practice, this contribution for the equity partners has been paid by the equity partners by monthly deductions taken from their distribution payments. Compensation, as defined by the Plan, is limited to the IRS maximum of \$345,000.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the funds held in their accounts into various investment options made available through the Plan, including self-directed brokerage accounts. Participants may change their investment options on a daily basis.

Note 1 - Plan Description (Continued)

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Employer contributions vest according to the following schedule:

The vesting schedule above applies to participants hired after January 1, 2002. Participants hired before January 1, 2002 are fully vested upon employment.

Benefit Payments

Upon termination of employment, participants may elect to receive the value of the vested interest in their accounts. Distributions may be in the form of lump-sum payments, a series of installment payments, partial withdrawals, or annuities. If the participant's account balance exceeds \$5,000, such participant shall have the right to defer payment until legally required to receive minimum distributions. In-service withdrawals of all or any portion of vested account balances starting at age 59½ are also permitted by the Plan.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited account balances totaled \$48,268 and \$18,388, respectively. During 2024, forfeitures of \$82,000 were used to reduce company contributions.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50 percent of their vested account balances or \$50,000, reduced by the highest outstanding balance of plan loans during the one-year period ending on the day before the loan is made. The notes receivable are secured by the balance in the participant's account and bear interest at rates equal to the local prime rate at the beginning of the month of issuance plus 0.5 percent. Principal and interest are paid ratably through semimonthly payroll deductions. A participant may have only two outstanding loans at any one time.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Fidelity Management Trust Company or its affiliates. Fidelity Management Trust Company is the Trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

The Plan's investments are stated at fair value.

The common/collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments. Mutual funds are valued based on quoted market prices reported in active markets. The self-directed brokerage accounts consist primarily of investments in mutual funds and common stocks valued on quoted market prices reported in active markets. The self-directed brokerage accounts also include certificates of deposit, which are valued at fair value based on their outstanding balances. See Note 4 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off against the participant's account balance when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 30, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Fidelity Management Trust Company (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
