### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the accompanying financial statements of Stoddard Baptist Nursing Home 401(k) Plan and Trust (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) audit. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Stoddard Baptist Nursing Home 401(k) Plan and Trust’s financial statements performed in accordance with ERISA section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Stoddard Baptist Nursing Home 401(k) Plan and Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.





## **Responsibilities of Management for the Financial Statements**

**Note 1 - Description of Plan**

The following description of the Stoddard Baptist Nursing Home 401(k) Plan and Trust, (the “Plan”), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering substantially all employees of Stoddard Baptist Nursing Home, (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The plan was established January 1, 1995 and restated effective January 1, 2022 to be in compliance with CARES Act provisions.

**Plan administration**

All assets of the Plan are held by the trustees, Principal Life Insurance Company and Principal Trust Company.

**Eligibility**

All employees who have reached 21 years of age and three months of service are eligible to participate in the Plan. Employees who are part time or seasonal employees or nonresident aliens are excluded from participating in the Plan.

**Contributions**

The Plan provides for participant contributions of pretax annual compensation, as defined in the Plan. Eligible employees may contribute a percentage of compensation. An employee’s contribution may not exceed 90% of their compensation. Rollovers of pre-tax contributions from another qualified plan may also be accepted by the Plan.

**Employer contributions**

The Plan provides for discretionary employer matching contribution, as determined by the Board. Matching contributions of 20% of deferrals up to \$2,600 per participant were made in 2024 and 2023. Matching contributions of \$81,931 and \$87,700 were made for the Plan year 2024 and 2023.

**Participant accounts**

Each participant’s account is credited with the participant’s contributions and allocations of (a) the Company’s contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Participant investment options**

Under the Plan, participants may direct the investment of both the Company and his or her contributions. Participants may change their investment options daily.

**Participant notes**

Participants may borrow from their fund accounts up to a maximum of \$50,000. Total loans outstanding may not exceed 50% of a participant’s vested account balance. Repayment terms for the loan are no more than five years, unless the purpose of the loan is for the purchase of a primary residence, in which case the term may be in excess of five years to a maximum of 10 years, with the loan balance amortized in equal installments over the life of the loan. The loans are secured by no more than 50% of the participant’s vested account balance. The interest rate will be determined by the Plan Administrator and, in determining the interest rate, the Plan Administrator will take into consideration interest rates currently being charged on similar commercial loans by persons in the business of lending money. Principal and interest are paid ratably through payroll deductions.

**Payment of benefits**

Participants shall be 100% vested in their accrued benefits upon satisfying the normal or early retirement age under the Plan. The normal retirement age/date is the date on which a participant reaches age 65. The Plan allows for in-service withdrawal at age 59 ½. A participant, upon termination or retirement, may request a lump-sum payment of their total vested benefits. Upon termination or retirement, vested balances less than \$5,000 will be paid out to the participant.

The Plan also allows, in certain hardship situations as defined by the Plan, participants to withdraw from their account balance while actively employed. These hardship withdrawals are subject to Internal Revenue Code restrictions and penalties.

**Vesting**

Participants are immediately 100% vested in any elective deferrals and rollover contributions, plus actual earnings thereon. Participants are vested in Company contributions based on the following table:

**Forfeitures**

Forfeiture of the Company’s matching contributions are used to reduce Company contributions, used to pay Plan expenses or allocated as additional non-elective discretionary contributions.

During the Plan years ending December 31, 2024 and 2023, forfeitures of \$3,135 and \$2,959 were received. During 2024 and 2023, \$7,666 and \$3,009 were used for administrative fees. At December 31, 2024 and 2023, available forfeitures totaled \$2 and \$4,500 , respectively.

**Note 2 - Summary of Significant Accounting Policies**

**Basis of accounting**

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

**Investment valuation and income recognition**

Investments in mutual funds are stated at quoted market price and are valued on a daily basis. Investments in common collective trusts, pooled separate accounts, and insurance company general accounts are valued at fair value or contract value depending on the contract. Purchases and sales of securities are recorded on a trade-date basis. In accordance with the policy of stating investments at current fair value, net realized and unrealized appreciation and depreciation are reflected in the statement of changes in net assets available for plan benefits. Interest income is recorded on the accrual basis. Dividends are recorded at the ex-dividend date.

As described under FASB ASC 962-325-35 "*Plan Accounting – Defined Contribution Pension Plans*", the Plan values all fully-benefit responsive contracts at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

**Participant notes receivable**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued by unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Interest income on participant loan receivables is recognized in the period in which it is earned and is recorded as interest income on the statements of changes in net assets available for benefits.

**Payment of benefits**

Benefit payments to participants are recorded upon distribution.

**Excess contributions**

Excess contributions are the result of over funding for highly compensated employees following the year-end compliance testing. The excess funds are distributed to these employees the following year.

**Administrative expenses**

Investment manager fees and broker commissions are paid by the Plan and recorded as reductions in participant allocations. All other administrative expenses are paid by the Company.

**Concentration of credit risk**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 3 – Fair value measurements

FASB ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023. These methodologies have not changed from those used in the prior year.

*Mutual funds* are valued based on quoted actively traded market price.

*Common collective trusts and pooled separate accounts* are valued based on the net asset value of the underlying securities.

The preceding methods described may produce a fair value calculation that may not be indicative of realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 4 – Investment in common collective trust and guaranteed income account**

The Plan has one guaranteed income account, Principal Fixed Income Guaranteed Option. The account is included in the financial statements at contract value as reported by the Plan. The contract value of the guaranteed income account at December 31, 2024 and 2023 is \$1,468,986 and \$1,407,253. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is 1.55% and 1.55% - 1.75% during the years ended December 31, 2024 and 2023. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the Plan's ability to transact at contract value. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974. The Plan administrator does not believe that any events that would limit the Plan's ability to transact a contract value with Plan participants are probable of occurring.

**Note 5 – Plan termination**

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants will become 100% vested in their accounts.

**Note 6 – Income tax status**

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024 and 2023, no uncertain tax positions are taken or are expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to December 31, 2021.

**Note 7 – Information prepared and certified by the trustee**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company and Principal Life Insurance Company, (the trustees of the Plan) as of December 31, 2024 and 2023 and for the years then ended

**Note 8 – Party-in-interest**

The Plan’s sponsors, trustees, and key management are also participants in the Plan. Their account balances totaled approximately 5% of the net assets available for benefits as of December 31, 2024 and 2023.
