Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following brief description of Guthrie 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Prior to January 1, 2015, certain employees of Guthrie Medical Group, P.C. (Guthrie Medical) and The Guthrie Clinic ("Guthrie Clinic" or "Plan Sponsor") and their tax-exempt affiliates were permitted to participate in the Plan. Effective January 1, 2015, all employees of Guthrie Medical, Guthrie Clinic and their tax-exempt affiliates ceased to actively participate in the Plan and instead are permitted to make deferrals to and receive matching contributions under Guthrie 403(b) Retirement Savings Plan. Employees of the Twin Tier Management Corporation and any other taxable affiliate of Guthrie Medical or Guthrie Clinic may continue to participate in the Plan.

General

The Plan is a defined contribution plan covering substantially all employees of certain participating taxable employers, as defined in the Plan document, who are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by the Plan Sponsor. Teachers Insurance and Annuity Association (TIAA), College Retirement Equities Fund (CREF), and Fidelity Investments Institutional Operations Company, Inc. (Fidelity Investments) are the Plan's recordkeepers. Fidelity Management Trust Company (Fidelity) is the custodian and trustee of certain Plan's assets. TIAA and CREF are the insurance companies of the Plan. TIAA, CREF, and Fidelity provide the investment options for the Plan participants.

Contributions

The Plan Sponsor automatically enrolls and sets an elective deferral amount at 3% of eligible compensation for eligible participants, and the participant's deferral rate is automatically increased by 1% each year, up to a maximum of 6%, unless the participant elects not to defer any amount. Participants in the Plan may contribute a percentage of their compensation up to the maximum amount allowed by the IRS, as defined in the Plan document. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan allows for employer matching contributions equal to 50% of a maximum of 6% of an employee's elected deferral. Additionally, the Plan allows for an annual age-based contribution made in an amount equal to a percentage of the participant's compensation based on the employee's age as of the last day of the plan year, as follows:

Contributions (Continued)

Participants direct the investment of all contributions into various investment options offered by the Plan. Participants in the Plan can rollover their account balances from other eligible retirement plans into the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of (a) the employer's contributions and (b) Plan earnings and losses, and is charged with an allocation of administrative and investment expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested in elective deferrals made into the Plan. Participants who are terminated prior to normal retirement age, for any reason other than death or disability, become fully vested in employer contributions after attaining three years of service. Participants are fully vested in employer contributions in an event of death or disability. The Plan has no partial vesting provisions.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, the normal form of payment is a lump-sum distribution. A participant may elect to receive his or her benefit payment in regular annual installments over a period not to exceed ten years. Benefits are recorded when paid.

Hardship Withdrawals

Hardship withdrawals from the Plan are permitted from participant accounts. All hardship withdrawals must comply with the rules relating to hardships, which are uniformly applicable to all participants.

Notes Receivable from Participants

The Plan provides that participants may borrow the lesser of \$50,000 or 50% of their vested account balance, but not less than \$1,000. The loan shall be repaid by the participant on at least a quarterly basis, but in not over a period greater than five years, unless the loan is taken for the purpose of purchasing a primary residence, in which case the loan may be repaid over a period not greater than 15 years. The loans are collateralized by the balance in the participant's account. The loans bear interest at a rate commensurate with local prevailing rates as determined by the investment provider in conjunction with federal regulations.

Forfeited Accounts

Forfeitures of non-vested account balances are used to reduce the Plan contributions and/or to pay for administrative expenses. There were unallocated forfeitures in the amount of \$169,603 and \$195,255 as of December 31, 2024 and 2023, respectively. Forfeitures in the amount of \$58,802 and \$33,955 were applied to employer contributions for the years ended December 31, 2024 and 2023, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared in conformity with accounting principles generally accepted in the United States of America (GAAP).

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investments

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan utilizes Group Retirement Annuity (GRA) contracts, which are included in the non-benefit responsive fixed annuity contract on the statements of net assets available for benefits. Plan contributions are maintained in separate accounts. Under GRA contracts, lump-sum withdrawals are not permitted. Participant initiated transfers or withdrawals may only be made in ten annual installments over a period of approximately nine years.

The Plan has a fully benefit-responsive fixed annuity contract. Plan contributions are maintained in separate accounts. The accounts are credited with contributions and earnings on the underlying investments and are charged for Plan withdrawals. Earnings on the underlying investments are guaranteed by TIAA at a 1%-3% interest rate.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions, based upon the terms of the plan documents. No allowance was deemed necessary at December 31, 2024 and 2023.

Fair Value Measurement - Definition and Hierarchy

Financial Accounting Standards Board *Accounting Standards Codification 820* (ASC Section 820) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC Section 820 are described below:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurement - Definition and Hierarchy (Continued)

The following is a description of the valuation methodology used for assets measured at fair value.

Money market funds: Valued using closing quoted prices in active markets.

Registered investment companies: Valued using closing quoted prices in active markets.

Pooled separate account: A separate account invested in real estate properties and real estate related investments that are valued using closing quoted prices in active markets.

Non-benefit responsive fixed annuity contract: Value is calculated as accumulated cash contributions and interest credited to the Plan's contract, less any withdrawals.

Common collective trust: Valued at net asset value (NAV) as a practical expedient to determine fair value.

The methods previously described may produce a fair value calculation that may not be indicative of net realizable values or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There were no changes in valuation methodologies during the years ended December 31, 2024 and 2023.

Risks and Uncertainties

The Plan provides for various investment options in any combination of selected investment securities. Investment securities are exposed to various risks, such as interest rate, currency, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

The Plan's expenses are paid directly by the Plan or the Plan Sponsor, as provided by the plan document. Expenses that are paid by the Plan Sponsor are excluded from these financial statements.

Investment advisory management fees and certain other expenses are charged to Plan participants and netted with the net appreciation in fair value of investments.

Estimates

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Common Collective Trust Fund

Fidelity Managed Income Portfolio II

The common collective trust is invested in short-term bonds and other fixed income securities. The NAV of the fund is principally derived from the contractual terms of the underlying contracts. The fund purchases third-party wrap contracts designed to maintain a constant NAV and to provide for the payment of participant-directed withdrawals and exchanges at book value under most circumstances. The NAV of the fund is then calculated daily and posted by Fidelity. Self-directed accounts are primarily invested in cash, certificate of deposits, mutual funds, common stock, U.S. government and agency obligations, real estate mutual funds and corporate bonds.

The investment strategy of the common collective trust fund is to preserve principal while earning interest with the goal of maintaining a stable NAV of \$1 per share.

Transactions out of the common collective trust fund can be made any business day; however, the participant is limited to one per calendar quarter and must be an active employee over the age of 59 and ½ year old. The fund does not have any unfunded commitments.

4. TAX STATUS

The Internal Revenue Service has determined and informed the Plan by letter dated March 4, 2016, that the Plan and related trust were designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the letter, the Plan's administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their employer contributions.

As such, transactions between TIAA, CREF, Fidelity Investments, Fidelity and the Plan qualify as party-in-interest transactions. Additionally, notes receivable from participants qualify as party-in-interest transactions.

9. SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.
