Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the BroadcastMed 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statement of Net Assets Available for Plan Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

1. Description of the Plan

The following description of the BroadcastMed 401(k) Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed defined contribution 401(k) plan, covering substantially all eligible employees of BroadcastMed, LLC (the Employer, Plan Sponsor or Company), as defined in the Plan Agreement. The Plan was established by the Employer on January 1, 1999. The Plan covers all employees upon reaching age 21, excluding non-resident aliens and Puerto Rico residents, who complete 400 hours of service within three months. If this service requirement is not met, employees become eligible after one year of service. Eligible employees can enroll at the start of the first pay period after meeting eligibility requirements. Effective January 1, 2025, the Plan was amended to provide eligibility to employees upon attainment of age 21 and completion of 90 days of service, replacing the prior 400-hour/three-month requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Sponsor is also the Plan Administrator, with the trustees of the Plan being officers of the Company. As Plan Administrator, the Plan Sponsor has the exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan.

Effective January 1, 2025, the Plan was amended, changing its name from BroadcastMed 401(k) Plan to Conexiant 401(k) Plan.

The Plan's custodians are Empower Annuity Insurance Company of America (EAICA) and Empower Trust Company, LLC (ETC) (collectively, Empower). EAICA is also the Plan's recordkeeper.

Contributions

Participants may elect to contribute up to 90% of their annual pretax or after-tax compensation, as defined in the Plan, subject to limitations by the Internal Revenue Code (IRC). Participants who are eligible to make elective deferrals under the Plan and who have attained the age of 50 before the close of the plan year are also eligible to make catch-up contributions subject to the maximum limitation imposed by the IRC. Rollover contributions representing distributions from other qualified defined contribution or defined benefit plans are permitted by the Plan.

The Plan may elect to make discretionary matching and discretionary profit-sharing contributions to the Plan, in amounts determined by the Company according to Plan provisions. Employer discretionary matching contributions are allocated based on the participant's elective deferral not to exceed 4%. There were no discretionary matching or discretionary profit-sharing contributions for the year ended December 31, 2024.

The Employer's safe harbor matching contribution is equal to 100% of the participant's elective deferrals up to 3% of their eligible compensation, plus 50% of the participant's elective deferrals between 3% and 5% of eligible compensation, as determined on an annual basis. The safe-harbor matching contribution for the year ended December 31, 2024 was approximately \$692,300.

Participant Accounts

Each participant's account is credited with the participant's contribution and their allocations of (a) the Employer safe harbor matching, Employer discretionary matching and Employer discretionary profit-sharing contributions, if any, (b) Plan earnings (losses) and (c) administrative expenses. Plan earnings (losses) and expenses are allocated to participant accounts based on participant account balances, or as a specific dollar amount based on number of participants in the plan, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions, and all Employer contributions (including safe harbor, discretionary matching, and discretionary profit-sharing contributions) and accrued earnings thereon.

Participant Notes Receivable

Participants may borrow from their account a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balance. Note terms range from one to five years, with the exception of notes whose proceeds are used for the purchase of a participant's primary residence, which must be repaid over a reasonable period of time, as determined by the Plan Administrator. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with the local prevailing prime interest rate plus 2% as determined by the Plan Administrator. Principal and interest is paid ratably through payroll deductions. Participants may not have more than two loans outstanding at any given time.

Payment of Benefits

Participants may elect to withdraw all or a portion of their Rollover account at any time. Upon retirement from service, total and permanent disability, termination of employment or death, participants will receive a lump-sum distribution in accordance with the provisions of the Plan. Participants who have reached age 59 ½ may elect to withdraw all or a portion of their vested account balance while still employed by the Employer.

In the event of death, benefits are payable to the participant's surviving spouse or designated beneficiary. Terminated participants with vested account balances equal to or less than \$5,000 may be involuntarily removed from the Plan with a lump-sum distribution.

During 2023, the Plan adopted a provision of the Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE) Act 2.0, which increased the age of the required distributions to begin from 72 to 73.

Hardship Withdrawals

Hardship distributions are permitted from the participant vested elective deferral accounts subject to limitations imposed by the IRC.

Forfeitures

Forfeitures of non-vested discretionary profit-sharing contributions may be used to pay administrative expenses and reduce Employer contributions to the Plan. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,323 and \$12,362, respectively. During 2024, approximately \$13,900 of forfeitures were used to offset Employer contributions. There were no forfeitures used to pay administrative expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Valuation of Investments and Income Recognition

Investments are reported at fair value, except for a fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3).

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fully Benefit-responsive Investment Contracts

Authoritative guidance defines the circumstances in which an investment contract is considered fully benefit-responsive and provides certain reporting and disclosure requirements for fully benefit-responsive investment contracts held by defined contribution, health and welfare and pension plans.

The Plan has an investment in the Empower Investments Fixed Account – Series Class I, which is a group annuity contract issued and backed by Empower that meets this requirement. The Plan's investment in this fund, which represents contributions and reinvested interest income, less withdrawals and expenses, plus or minus net participant-directed transfer activity with the Plan's other investment funds, is recorded at contract value.

Participant Notes Receivable

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest and are secured by the balance in the participant's account. Interest income on participant notes receivable is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when incurred. A receivable is considered past due if payment has not been received within the stated terms. Delinquent participant notes receivable are reclassified as distributions based on terms of the Plan document. No allowance for credit losses have been recorded as of December 31, 2024 and 2023.

Contributions

Participant elective deferral contributions and Employer safe harbor matching contributions are recorded with each payroll period when the Employer remits the payroll deductions for investment into the Plan. Employer discretionary matching contributions and Employer discretionary profit-sharing contributions are recorded and remitted annually, if applicable.

Payment of Benefits

Benefits are recognized when paid to participants or their designated beneficiaries.

Administrative Revenue and Expenses

Certain expenses incurred in the administration of the Plan are paid by the Employer, unless the Employer directs that such expenses shall be paid by the Plan. Expenses that are paid by the Employer are excluded from these financial statements. Participant notes receivable setup and maintenance fees are paid directly by the participants through a reduction in their account and are included in administrative expenses. Investment management and recordkeeping fees, if applicable, are paid by the Plan through revenue sharing as a reduction of investment income (net appreciation or depreciation) and not reflected separately in the Statement of Changes in Net Assets Available for Plan Benefits.

Administrative revenue arises when investment managers return a portion of the investment fees to the recordkeeper to offset the administrative expenses. Any excess resulting from this revenue credit remains in an unallocated account from which future Plan expenses can be paid or allocated to participant accounts. The Plan held unallocated administrative revenues, including interest thereon, of approximately \$36,600 and \$12,800 at December 31, 2024 and 2023, respectively. During 2024, no administrative revenues were used to reduce Plan expenses.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options with various investment objectives. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

The Plan invested in five mutual funds that accounted for approximately 59% of total Plan investments as of December 31, 2024. The Plan invested in three mutual funds that accounted for approximately 38% of total Plan investments as of December 31, 2023.

Financial Instruments with a Concentration of Credit Risk

The Plan's investments are held by two custodians. The Plan's exposure to credit risk is associated with the outside entities non-performance of their fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

Subsequent Events

Management has evaluated subsequent events through October 6, 2025, which is the date these financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

As of December 31, 2024 and 2023, the Plan's investments in mutual funds are reported at level 1 within the fair value hierarchy.

4. Fully Benefit-responsive Investment Contract

The Plan's investment in the Empower Investments Fixed Account - Series Class I, a group annuity contract, is a fully benefit-responsive investment contract. The account is credited with participant contributions, plus earnings, and charged for participant withdrawals and administrative expenses. Contributions to this account are deposited into Empower's general account, which primarily invests in bonds, commercial mortgages, and private equity.

The insurance company is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The specified minimum crediting rate is 0%. The crediting interest rate was 1.41% and 1.23% as of December 31, 2024 and 2023, respectively.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Certain events limit the Plan's ability to transact with Empower. Such events include the following: amendments to the Plan documents, changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the Company or other Company events that cause a significant withdrawal from the Plan, or the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Employer believes the occurrence of such events that would also limit the Plan's ability to transact at contract value with Plan participants is not probable.

5. Plan Termination

The Employer expects to continue the Plan indefinitely. However, the Employer reserves the right to amend the Plan or contributions thereto, at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting Plan assets for purposes other than for the exclusive benefit of the Plan participants. Any Plan termination would be subject to the provisions of ERISA. If the Plan is terminated, the participants would become fully vested and entitled to receive all amounts credited to their accounts.

6. Income Tax Status

The Plan is an adoption of a non-standardized pre-approved defined contribution plan which received an opinion letter from the Internal Revenue Service (IRS) dated May 26, 2021. The Plan has been amended since receiving the opinion letter in order to comply with the latest applicable tax laws and regulations. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Summary of Financial Data Certified by the Custodians

The following is a summary of financial information and data certified by the custodians of the Plan:

8. Differences from Form 5500

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500, and these financial statements are a result of different classifications between line items. Total Plan assets are in agreement.

9. Related Party Transactions and Party-in-Interest Transactions

Plan investments are held and managed by Empower, the custodian and recordkeeper of the Plan. Fees paid for investment management services are paid directly to UBS Financial Services Inc. (UBS). Fees paid for third party administrative services are paid directly to Pension Consultants, Inc. (PCI). Therefore, these transactions qualify as party-in-interest transactions. The Plan made direct payments of approximately \$31,000 to UBS, approximately \$3,400 to PCI, and approximately \$36,500 to Empower for the year ended December 31, 2024. In addition, participant notes receivable also qualify as party-in-interest transactions.

10. Non-exempt Transactions

During the years ended December 31, 2023, and 2022, the Employer failed to remit participant contributions of \$348,498 and \$15,147, respectively, to the Plan on a timely basis as prescribed in the applicable Department of Labor Regulation 29 CFR 2510.3-10. Defined contribution plans must remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld or received by the Employer.

During 2022, the Employer remitted untimely participant contributions of \$15,147 due to the Plan for the year ended December 31, 2022. During 2023, the Employer remitted untimely participant contributions of \$348,498 due to the Plan for the year ended December 31, 2023. During 2024, the Employer remitted the lost earnings associated with these late remittances.
