Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 - DESCRIPTION OF THE PLAN

The following brief description of the Medical Group of Beverly Hills, Inc. 401(k) Profit Sharing Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more specific provisions.

A. General

The Plan is a defined contribution plan that was established by Medical Group of Beverly Hills, Inc. (the "Company") to provide retirement benefits for eligible employees, as defined in the Plan document. The plan administrator believes the Plan is designed and operated in compliance with the applicable requirements of the Internal Revenue Code (the "Code") and provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

B. Administrative Expenses

Certain plan investment and administrative expenses are paid by the Company; all other fees are paid by the Plan.

C. Eligibility

All employees are eligible to participate in the Plan upon attaining age 21.

D. Participant Contributions

Participants may elect to have the Company contribute their eligible pre-tax compensation, as defined in the Plan, up to the amount allowable under the Plan document and the Code. Catch-up contributions are permitted.

Participants are allowed to make rollover contributions of amounts received from other tax-qualified retirement plans subject to approval of the plan administrator. Such contributions are deposited in the appropriate investment funds in accordance with the participant's investment directions.

E. Employer and Other Contributions

For each Plan year, the Company may make profit sharing contributions to the Plan. Profit sharing contributions totaled \$1,000,000 for 2024. \$3,009,035 was contributed by Cedars-Sinai Medical Care Foundation (the "Foundation") in 2024 and vests in accordance with the profit sharing schedule in Note 1-G.

F. Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, Company profit sharing and Foundation contributions and an allocation of Plan earnings or losses and expenses. Plan assets are invested based solely on instructions received from participants.

G. Vesting

Participants are immediately vested in their elective deferral contributions and rollover contributions plus actual earnings thereon. Vesting in Company profit sharing and Foundation contributions is based on the following schedule:

Participants also become fully vested upon reaching normal retirement age (65), upon death while still employed by the Company, upon termination by reason of disability or upon termination of the Plan by the Company.

H. Payment of Benefits

Upon termination of service, death, disability or retirement, a participant or beneficiary may choose to maintain his or her account in the Plan or receive benefits in a lump sum payment equal to the value of the participant's account balance. If a terminated participant's account balance is between \$100 and \$5,000 and no distribution election has been received from the participant or beneficiary of the account, the account will be rolled over to an individual retirement account at the direction of the plan administrator. If such account does not exceed \$100, the balance will be paid in a lump sum distribution. The Plan allows for hardship withdrawals.

I. Notes Receivable from Participants

The Plan allows participants to borrow not less than \$1,000 but up to the lesser of \$50,000 or 50% of their vested account balance. A loan is secured by a participant's vested account balance, bears interest at a rate commensurate with the interest rates charged by persons in the business of lending money under similar circumstances and must be repaid to the Plan in five years unless the loan is used for the purchase of a principal residence, in which case the maximum repayment period is twenty years. Notes receivable from participants at December 31, 2024 carry interest rates ranging from 5.25% to 10.50%.

J. Forfeitures

Forfeitures of nonvested account balances are applied first to restore the forfeited portions of Company contribution accounts of rehired participants. Any remaining forfeitures are used to offset plan expenses, applied to reduce future Company contributions, or allocated to participants. At December 31, 2024 and 2023, the Plan held \$227,282 and \$83,822 of unused forfeitures, respectively. Forfeitures totaled \$141,559 for the year ended December 31, 2024 and \$150 was used to pay fees in December 2024.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

C. Risks and Uncertainties

Plan investments include securities that are exposed to various investment risks such as interest rate, market fluctuations and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the financial statements.

NOTE 3 - PARTIES-IN-INTEREST TRANSACTIONS

Certain investments held by the Plan are issued and managed by Empower Trust Company, LLC, Empower Annuity Insurance Company of America or one of its affiliates. Transactions related to these investments qualify as party-in-interest transactions; however, they are exempt from the prohibition under ERISA.

NOTE 4 - INCOME TAX STATUS

The Plan has been amended since receiving its latest favorable determination letter dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code. The Company believes that the Plan is being operated in accordance with and continues to qualify under the applicable requirements of the Code and related state statutes, and that the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The accounts of participants affected by a partial or complete termination of the Plan are non-forfeitable and will be determined as of the termination date, which will be treated as the valuation date.

NOTE 6 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEES

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the trustees of the Plan.

NOTE 7 - FAIR VALUE MEASUREMENTS

GAAP establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability. The following tables summarize the Plan's investments at December 31 based on the inputs used to value them:

Level 1 investments consist of mutual and exchange traded funds valued at their quoted market prices. Purchases and sales of securities are recorded on a trade date basis. Interest and dividends are recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Mutual funds capital gain distributions are included in dividend income. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 8 - FIXED ANNUITIES

The fixed annuities ("contracts") that participants may invest in are 7-year contracts with their own unique interest rates, which last one calendar quarter. The trustee maintains the contributions in the Company's general funds. The contracts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contracts are included in the financial statements at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their matured contract at contract value. Maturing contracts that are not redirected into another investment option will automatically roll into another certificate with the same maturity at the current rate of interest.

There are no reserves charged against the contract value for credit risk of the contract issuer or otherwise. The average yield and crediting interest rates were approximately 1.41% and 1.30% for 2024 and 2023, respectively. Such rates are reviewed on a quarterly basis for resetting.
