INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
Quincy Mutual Fire Insurance Company 401(k) Profit Sharing Plan and Trust

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Quincy Mutual Fire Insurance Company 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. Notes to Financial Statements

A. Description of Plan:

The following description of the Quincy Mutual Fire Insurance Company 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan is a defined contribution plan covering all eligible participants of Quincy Mutual Group, Inc. (“QMG”) and Patrons Oxford Insurance Company (“Patrons”), (collectively the “Company”) that includes a 401(k) and a profit-sharing benefit.

Effective January 1, 2024, entry into the Plan occurs daily, with eligibility based on the following requirements:

401(k): Immediately at the start of employment

Profit sharing: At least 1,000 hours of service for the Plan year for all employees and employed on December 31 except if retirement occurred during the year

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

2. Contributions

Participants may contribute amounts on a pre-tax or post-tax (Roth) basis up to the maximum amount established by the Internal Revenue Service each year. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation, and their contributions are invested in a designated fund until changed by the participant. The Company contributes 100% of the first 1% of compensation that a participant contributes to the Plan and then 50% of the next 5% of the participant’s compensation. In addition, the Company may make additional profit-sharing contributions at the discretion of the Board of Directors. For the year ended December 31, 2024, the Company made profit sharing contributions of 5% of the participants’ eligible wages. All contributions are subject to certain limitations imposed by the Plan and the Internal Revenue Code.

3. Participant Accounts

Each participant’s account is credited with the participant’s voluntary contribution, the Company’s contributions, and the allocation of the earnings of the mutual fund investments which are net of any administrative expenses of the funds. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

4. Investment Options

Participants may direct their contributions into any of the mutual funds offered by the Plan, which are held at T. Rowe Price. These funds include a variety of investment options with various objectives and degrees of financial risk allowing participants to build diversified investment portfolios.

5. Vesting

Participants are vested immediately in their own contributions and earnings thereon. Company contributions, which include discretionary contributions and earnings, are based on separate vesting schedules depending on the participant's completion of 1,000 hours of service, the type of contribution; 401(k) matching or profit sharing, and the applicable contribution period.

The Company 401(k) matching contributions are fully vested after two years whereas the profit sharing contribution has a graded vesting schedule which allows a participant's vesting to begin after two years of continuous service with full vesting occurring after six years. Participants are also fully vested upon reaching normal retirement ages, death or total disability.

6. Payment of Benefits

Upon termination of employment for any reason, including death, disability, or retirement, the participant or their beneficiary will receive an amount equal to the value of the participant's vested interest in his or her account. An election is made by the participant or their beneficiary as to the form of payment (direct rollover, annuity or cash payment). In the absence of an executed election form, the Plan distributes benefit amounts less than \$5,000 in cash; amounts greater than \$5,000 remain credited to the participant's account until an election is made. The Plan also provides for in-service withdrawals by participants who have attained the age of 59 ½. Upon financial hardship, a participant is entitled to the value of his or her deferral accounts, but not the earnings thereon, which is payable immediately in a lump sum distribution.

7. Forfeited Accounts

If a participant terminates employment before becoming 100% vested, the non-vested portion of the account balance will be forfeited based on the termination date. Forfeited account balances are used to reduce future contributions that are to be made by the Company. There were forfeitures totaling approximately \$0 and \$61,500 for the years ended December 31, 2024 and 2023, respectively, which were used to reduce the employer contributions. Forfeited non-vested account balances totaled \$10,137 and \$5,591 at December 31, 2024 and 2023, respectively.

8. Notes Receivable from Participants

Notes receivable from participants represent participant loans. Any active participant may apply for a loan in an amount limited to 50% of the participant's vested interest in their account, with a minimum of \$1,000 and maximum of \$50,000. All loans will bear an interest rate equal to the prime rate of interest on the date the loan is approved with a repayment schedule over a reasonable period of time not to exceed the earlier of five years or the Normal Retirement Age. At December 31, 2024 and 2023, interest rates on outstanding loans ranged from 3.25% to 8.50%.

All payments of principal and interest made by the participant are credited only to the account of such participant. The repayment of existing loans outstanding is received each pay-period through direct after-

tax payroll deductions. Fees in connection with processing loan applications are paid from participant accounts.

B. Summary of Accounting Policies:

1. Basis of Presentation

The accompanying financial statements are prepared on the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America (“GAAP”).

2. Investment Transactions and Income Recognition

Purchases and sales of shares in mutual funds are recorded based on the share values reported by the funds on the day of the transaction. Interest income is recognized when earned and dividends are accrued based on the rate per share declared on the ex-dividend date.

The Plan presents in the Statement of Changes in Net Assets Available for Benefits, the net appreciation (depreciation) in fair value of investments, which consists of realized gains or losses, and the unrealized appreciation (depreciation) on those investments.

Other income represents income received from revenue sharing arrangements with T. Rowe Price Trust Company. During 2024, the Plan received \$128,095 of revenue sharing which was allocated to eligible participants.

3. Risks & Uncertainties

The Plan provides for various mutual fund investment options including equities, fixed income and other securities. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

4. Payment of Benefits

Benefit distributions are recorded when paid.

5. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued, but unpaid, interest. Interest income on notes receivable from participants is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

6. Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

7. Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

C. Certification by the Investment Custodian:

Information presented in the accompanying statements and schedule as of December 31, 2024 and 2023, and for the year ended December, 31 2024, for investments, notes receivable from participants, investment income and interest income on notes receivable from participants was derived, without audit, from information certified to be complete and accurate by T. Rowe Price Trust Company, the custodian, as permitted by the election made by the plan administrator under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

D. Fair Value Measurements:

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Assets valued using the net asset value practical expedient are not required to be reported within the hierarchy.

The following is a description of the valuation methodology used for assets measured at fair value:

Money Market and Mutual Funds

Money market and mutual funds are valued using Level 1 inputs, which consist of the quoted price of shares held by the Plan at year end.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no transfers between levels of investments during the year ended December 31, 2024.

E. Contributions Receivable:

The Company's Board of Directors approved an employer discretionary profit-sharing contribution for 2024 and 2023. This employer profit sharing contribution is credited to the participants' accounts and is subject to the Plan's vesting schedule. The Plan receivables at December 31, 2024 and 2023 represented discretionary profit-sharing contributions of \$1,036,728 and \$993,520, respectively.

Discretionary receivables are remitted to the Plan by March of the subsequent Plan year, whereas the employee and employer contributions for the last pay-period are received by the Plan no later than the first week of the new Plan year.

F. Related Party and Party-in-Interest Transactions:

Plan investments are shares of mutual funds managed by T. Rowe Price Retirement Plan Services. T. Rowe Price Trust Company is the custodian as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants qualify as party-in-interest transactions.

G. Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts.

H. Tax Status:

The Internal Revenue Service has determined and informed the Company by letter dated August 19, 2020, that the Plan is designed in accordance with Section 401 of the Internal Revenue Code (IRC) and the regulations issued thereunder. The Plan has been amended since receiving the determination letter. The Plan Administrator and the Plan's tax counsel believe that the Plan is designed and continues to operate in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

I. Subsequent Events:

The Plan evaluates subsequent events through the date which the financial statements were available for issue. For the year ended December 31, 2024, this date was August 13, 2025.

Effective January 1, 2025, the Plan was restated. The significant changes to the Plan, as a result of the restatement, include allowing participants to roll over Roth amounts from other plans.
