### NOTES TO THE FINANCIAL STATEMENTS

#### NOTE 1 - DESCRIPTION OF PLAN

The following description of the Woodland Clinic Medical Group 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document, as amended, for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan originally effective January 1, 2012 and covers employees of Woodland Clinic Medical Group (the Company). The Plan excludes nonresident aliens, employees covered by a collective bargaining agreement, and leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended, and the Internal Revenue Code (IRC), and has been amended at various dates through December 31, 2024 to comply with applicable laws and regulations.

An employee becomes eligible to participate in the Plan on the entry date immediately following the date the employee is hired. Participants, other than highly compensated employees, are also eligible for safe harbor matching contributions on the date of commencement of employment. Participants classified as highly compensated employees are eligible for Company match contributions once they have completed one year of service with at least 1,000 hours of service since the date of commencement of employment. All employees are eligible to receive a Company nonelective contribution if they have been employed at least one year and have 1,000 or more hours of service during the Plan year.

#### Plan Administration

The Company is the administrator of the Plan and is responsible for managing its day-to-day operations. The Plan's trustee, Fidelity Management Trust Company (Fidelity), is responsible for the recordkeeping, custody, and management of the Plan's assets.

#### Contributions

The 401(k) salary deferral option allows employees to defer a portion of their salaries for income tax purposes through contributions to the Plan. Participants may contribute up to 80% of eligible Plan year compensation up to the maximum allowed under the IRC, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company provides safe harbor matching contributions to eligible employees. The safe harbor match is 100% of the participant's elective deferrals that do not exceed 3% of compensation plus 50% of the participant's elective deferrals in excess of 3% but not to exceed 5% of compensation. For the year ended December 31, 2024, the Company made safe harbor contributions of \$202,774.

#### NOTE 1 - DESCRIPTION OF PLAN – CONTINUED

##### Contributions – Continued

The Company also provides matching contributions to eligible participants who are highly compensated employees equal to 50% of the participant's contributions up to 6% of the participant's total eligible compensation. For the year ended December 31, 2024, the Company made matching contributions of \$901,725. Additionally, the Company provides a nonelective contribution to eligible participants ranging from 3% to 8% of the participant's total eligible compensation based upon their age as of January 1 of each Plan year and employment classification. For the year ended December 31, 2024, the Company made nonelective contributions totaling \$2,403,380.

Safe harbor contributions of \$4,593, matching contributions of \$48,282, and nonelective contributions of \$2,403,380 are included in employer contributions receivable on the accompanying statement of net assets available for benefits as of December 31, 2024.

Participants may also make a rollover contribution to the Plan that is not matched by the Company. Rollover contributions are assets transferred to the Plan from a qualified plan in which an employee participated prior to employment with the Company. During the year ended December 31, 2024, there were \$881,548 in rollover contributions transferred to the Plan.

Participants direct the investment of their contributions and their share of the Company's contributions into various investment options offered by the Plan, and they may change their investment elections anytime.

##### Participant Accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions (including those rolled over from another qualifying plan or trust) and related employer contributions, as well as the participant's share of the Plan's income and expenses. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Vesting

Participants are immediately fully vested in their salary deferral as well as Company safe harbor matching contributions plus or minus the related investment gains and losses. Vesting in the Company's matching contributions is based on years of continuous service as defined. Participants become 20% vested after completing one year of service, 40% after two years of service, 60% after three years of service, and 80% after four years of service. After five years of service, all Company matching contributions are 100% vested.

#### NOTE 1 - DESCRIPTION OF PLAN – CONTINUED

##### Vesting – Continued

Vesting in the Company's nonelective contributions is based on years of continuous service as defined. After three years of service, all Company nonelective contributions are 100% vested. A participant is also fully vested in the Company matching and nonelective contributions upon death or upon becoming totally and permanently disabled.

##### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum limited to the lesser of: (1) \$50,000 or (2) 50% of the participant's vested account balance. Each note receivable is secured by the balance of the participant's account and bears a reasonable rate of interest that is determined by the plan administrator, and must repaid on an installment basis via ACH payments over a period not to exceed five years, unless the loan is used by the participant to acquire a primary residence. The interest rates ranged from 4.25% to 9.50% as of December 31, 2024 and 2023.

##### Payment of Benefits

On termination of service, death, disability, or retirement, a participant (or participant's beneficiary in the event of death) will receive either a lump-sum amount or a series of installments over a period of time equal to the value of the participant's vested interest in his or her account. Participants should refer to their Plan agreement for more information.

##### Hardship Withdrawals

Participants may withdraw their vested contributions in the event of hardships as defined by the Plan document. Hardship distributions are distributed as a lump-sum.

##### Forfeitures

Any participant who terminates employment prior to the normal retirement date for reasons other than death or disability, forfeits all nonvested contributions. Forfeitures of terminated participants' nonvested accounts may be used to pay administrative expenses or to reduce any Company contributions to the Plan. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$46,941 and \$2,665, respectively. Forfeitures in the amount of \$2,163 were used to offset administrative expenses for the year ended December 31, 2024. No forfeitures were used to offset Company contributions during the year ended December 31, 2024.

#### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

##### Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the dates of the financial statements, and the reported amounts of additions and deductions during the reporting period. The most important of these estimates and assumptions relate to fair value measurements of the Plan's investments. These and other estimates and assumptions are based on the best available information but actual results could be materially different from those estimates.

##### Risks and Uncertainties

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the amounts reported in the accompanying statements of net assets available for benefits.

##### Valuation of Investments

In accordance with GAAP, all assets of the Plan are stated at fair value or amounts approximating fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and trustees.

##### Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when earned. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a distribution based on the terms of the Plan document.

#### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – CONTINUED

##### Recognition of Income

Sales and purchases are accounted for on a trade date basis, and interest income is recorded on the accrual basis. Dividends, if declared, are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold during the year as well as held at year-end.

##### Payment of Benefits

Benefit payments to participants are recorded when paid.

##### Administrative Expenses

All reasonable expenses related to Plan administration are paid from Plan assets, except to the extent expenses are paid by the Company. Expenses paid directly by the Company are excluded from these financial statements. In addition, certain investment related expenses are included in net appreciation (depreciation) in fair value of investments.

##### Recent Accounting Pronouncements

In the normal course of business, the Plan evaluates new accounting pronouncements to determine the potential impact they may have on its financial statements. Based upon this review, the Plan does not expect any of the recently issued accounting pronouncements, which have not already been adopted by the Plan, to have a material impact on its financial statements.

##### Subsequent Events

The Plan evaluated for recognition or disclosure subsequent events through the report issuance date and determined that no such events were identified.

#### NOTE 3 - TAX STATUS

The Plan obtained its latest determination letter dated August 1, 2017, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The plan administrator believes that the Plan is designed and operated in compliance with applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

#### NOTE 3 - TAX STATUS – CONTINUED

In accordance with GAAP, the Plan management is required to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to tax examinations for years prior to 2021.

#### NOTE 4 - PLAN AMENDMENT AND TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan document to discontinue its contributions at any time and to amend or terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, the participants' account balances fully vest, and they would be distributed.

#### NOTE 5 - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Pursuant to that regulation, the plan administrator has instructed the independent auditors not to perform any auditing procedures with respect to information certified by the trustee. Accordingly, the trustee of the Plan has certified to the completeness and accuracy of investments reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, as well as the related investment activity reflected in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

#### NOTE 6 - FAIR VALUE MEASUREMENTS

The fair value hierarchy prioritized the inputs to valuation techniques used to measure fair value into three levels, with the highest priority given to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority given to unobservable inputs (Level 3). The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

- *Interest-bearing cash:* Valued at cost plus accrued interest, which approximates fair value.
- *Mutual funds:* Valued at quoted market prices of shares held by the Plan at year-end.
- *Self-directed brokerage accounts:* The self-directed brokerage accounts are comprised of interest-bearing cash, common stock, and mutual funds, which are valued at the closing price reported on the active market in which the individual securities are traded.
- *Common/collective trust fund:* Valued using the market approach at a unit price (net asset value as a practical expedient) determined by the portfolio's sponsor based on the fair value of underlying investments held by the common collective trust fund on the last business day of the Plan year.

In accordance with GAAP, common/collective trust funds are not classified in the fair value hierarchy table. The fair values are included in the table to allow reconciliation of the fair value hierarchy to the fair value of investments per the statements of net assets available for benefits.

### NOTE 6 - FAIR VALUE MEASUREMENTS – CONTINUED

The common/collective trust fund measured at net asset value (NAV) may impose, in its sole discretion, a prior notice period of up to 12 months for Plan initiated withdrawal of assets. They may also require that within 90 days from withdrawal from the fund, money from the fund cannot be invested directly into a competing fund, such as a money market fund. There are currently no redemption restrictions or unfunded commitments on these investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
