Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of *Insight Enterprises, Inc. 401(k) Plan* (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

(1) Description of the Plan

The following description of the Insight Enterprises, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

A. General – The Plan, which commenced on July 1, 1991, is a defined contribution plan covering substantially all United States employees of Insight Enterprises, Inc. and subsidiaries (the "Company" or "Plan Sponsor") who are over 17 years of age. Employees may enroll in the Plan immediately upon meeting the eligibility requirement. The Plan recognizes predecessor employee service of an acquired company as service in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Fidelity Management Trust Company ("Fidelity") is the custodian and trustee and Fidelity Workplace Services LLC ("FWS") is the recordkeeper of the Plan. Fidelity holds the Plan's investment assets, executes investment transactions and receives daily feeds indicating the value of Plan assets. FWS provides services relating to the processing of distributions and notes receivable from participants, maintenance of account balances, and allocation of Plan earnings, losses, and contributions.

On December 20, 2024, the Retirement Plan Committee authorized the merger of the SADA Systems, Inc. 401(k) Retirement Plan (the "SADA Plan"), sponsored by the Company, into the Plan. Plan assets totaling approximately \$43,253,000 were transferred into the Plan from the SADA Plan on December 23, 2024. Existing plan provisions from the SADA Plan were incorporated into a plan amendment on December 20, 2024.

Insight Enterprises, Inc. acquired InfoCenter.io Corporation (Infocenter) on May 1, 2024. On August 23, 2024, all of Infocenter's assets were transferred into the Plan, of which approximately \$5,465,000 is included in rollover contributions and approximately \$101,000 of loans are included in plan transfers. Infocenter employees became eligible to participate in the Plan on May 1, 2024.

B. Contributions – Participants may elect to defer up to 60% of pre-tax, after-tax, or Roth basis earnings, as defined in the Plan, not to exceed the limits of the Internal Revenue Code (the "IRC"). Participant contributions under the IRC Section 401(k) were subject to an annual maximum of \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. In addition, the Plan allows participants attaining the age of 50 before the end of the Plan year to make additional catch-up contributions not exceeding \$7,500 per year for the years ended December 31, 2024 and 2023.

The Company may make discretionary matching contributions according to the Plan. The discretionary match provided to participants was equivalent to 50% of elective deferrals up to 6% of each participant's eligible compensation on a per-pay-period basis.

The Plan has an automatic enrollment feature where participants are automatically enrolled in the Plan at a pre-tax contribution rate of 3%. These contributions begin approximately 30 days after the participant's date of hire, unless a participant makes an election to contribute a different percentage or declines participation in the Plan. These participants' investments will default to one of the T. Rowe Price target date funds, based upon each participant's projected retirement date, unless otherwise directed by the participant.

The Company may also allocate discretionary matching contributions to participants who experience retirement, total disability, or death within the Plan year. In addition, the Company may make discretionary profit-sharing contributions in amounts and at times determined by its board of directors. No such contributions were made in 2024 and 2023.

The Plan also provides for an employer match applicable to participants designated as Infocenter employees. For these participants, the employer may make a discretionary matching contribution equal to 5% of the employee's contribution to the Plan. The match is determined at the employer's discretion each year, and there is no stated maximum limit on the amount that may be matched under this provision. Employer matching contributions, if any, are funded and credited to participant accounts according to the Plan's terms.

The Plan allows up to 95% of a participant's account to be self-directed through a brokerage account. The Company may discontinue contributions on behalf of certain highly compensated individuals to assure compliance with the IRC non-discrimination rules.

- C. Participant accounts** – Each participant's account is credited with their elective deferral contribution, an allocation of Company discretionary matching and profit-sharing contributions, if any, and an allocation of investment earnings and losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- D. Vesting** – The Plan's vesting schedule was amended as of February 6, 2023. Beginning on this day, participants hired on or after February 6, 2023, will now vest according to a 3-year cliff vesting schedule. All employees hired prior to February 6, 2023, are employed as of that date, and have completed at least 1 hour of service, will follow a new 3-year graded vesting schedule as follows:

Participants become 100% vested in their account balance upon reaching normal retirement age, total and permanent disability, death, or plan termination.

- E. Notes receivable from participants** – A participant may borrow from his or her account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of his or her vested account balance. A participant may not have more than one note outstanding at a time. Note terms range from one to five years, except that the note term may be as long as ten years if the purpose is for the purchase of a primary residence. The note is secured by the balance in the participant's account and bears interest at the prime rate plus 1%, which is fixed at the time the note is made. Interest rates on participant notes receivable outstanding at December 31, 2024 ranged from 3.25% to 9.50%. Principal and interest is paid ratably through payroll deductions. Upon termination from employment, the note receivable may be repaid by participants via ACH transfer on a monthly basis in accordance with the terms and conditions described to the participant in the service set-up process.

F. Distribution of benefits – Distribution of benefits is available upon retirement, reaching retirement age, reaching the age of 59½, performing qualified military service, death, total and permanent disability, or termination. Additionally, a participant may withdraw all or a portion of their rollover or after-tax contributions at any time. Benefits are paid in one lump-sum payment. On termination of service, distribution of balances in excess of \$5,000 may be deferred until normal retirement age and then paid. Participants may withdraw or borrow from their account as set forth in the provisions of the Plan document for hardship or loans.

G. Forfeitures – At December 31, 2024 and 2023, forfeited non-vested amounts outstanding totaled approximately \$142,000 and \$10,000, respectively. These amounts will be used to reduce future employer contributions, to the extent made by the Company, or to pay Plan expenses in accordance with Plan documents. Forfeitures of non-vested employer contributions used to reduce employer matching contributions were approximately \$1,572,000 and \$1,255,000 during 2024 and 2023, respectively. There were no forfeitures of non-vested employer contributions used to pay Plan expenses in 2024 and 2023.

H. Plan termination – The Company expects the Plan to continue without interruption but reserves the right to amend or terminate the Plan or to reduce, temporarily suspend, or discontinue contributions under the Plan subject to the provisions set forth in ERISA. In the event the Plan terminates, net assets of the Plan will be allocated in accordance with the terms of the Plan agreement.

(2) Significant accounting policies

Basis of accounting – The accompanying financial statements of the Plan are prepared on the accrual basis of accounting and present the net assets available for benefits and changes in those net assets.

Investment valuation and income recognition – Investments in shares of registered investment companies are stated at net asset values. The self-directed brokerage account investments in mutual funds are also stated at net asset values. Net asset values are readily determinable fair values of those shares as they are published daily and are the basis for current transactions. Common stock, corporate bonds, preferred stock, warrants, and interest-bearing cash in the self-directed brokerage accounts are valued at the closing price reported on the active market on which the securities are traded. Investments in common/collective trusts are stated at unit value, or the equivalent of net asset value, which is a practical expedient for estimating the fair value of these investments. Investments in common/collective trusts may be redeemed daily with a notice period of one day and had no unfunded commitments as of December 31, 2024 and 2023.

The net appreciation/depreciation in the fair value of investments reflects the change in fair value of the investments held at year end and realized gains and losses on investment transactions during the year. Certain investment related expenses are included in net appreciation/depreciation of fair value of investments. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance plus accrued interest. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Payment of benefits – Benefits are recorded when paid.

Administrative expenses – Reasonable and necessary expenses incurred in the administration of the Plan are paid from Plan assets or paid by the Company, either directly or through the use of forfeited non-vested employer contributions. Expenses paid by the Company are not reflected in the accompanying statements of changes in net assets available for benefits.

Exemption from income taxes – The Plan has adopted an amended and restated pre-approved defined contribution plan document entitled Fidelity Basic Plan Document No. 17 (the “Pre-Approved Plan Document”). The Pre-Approved Plan Document received an opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, stating that the Pre-approved Plan Document was designed in accordance with the applicable sections of the IRC. The Pre-approved Plan Document has been amended since receipt of the opinion letter. The Plan Sponsor and the trustee of the Plan believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Accordingly, no provision for income taxes has been made in the accompanying financial statements.

Use of estimates – The preparation of financial statements in conformity with accounting standards generally accepted in the United States of America requires the Plan Sponsor to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Risks and uncertainties – The Plan assets are invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Party-in-interest transactions – The Company is the Plan Sponsor and provides all employer contributions to the Plan. Therefore, these transactions qualify as party-in-interest transactions. Certain Plan investments are shares of registered investment companies and self-directed brokerage accounts managed by Fidelity. Fidelity is the custodian and trustee, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fidelity Workplace Services LLC is the recordkeeper, as defined by the Plan and, therefore, qualifies as a party-in-interest. The Plan also incurred other professional services fees related to consulting and advisory services, which qualify as party-in-interest transactions. Payments to the recordkeeper and for other professional services fees are reported as administrative expenses on the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

The Plan Sponsor has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan's trustee has certified that the following data included in the accompanying financial statements and supplemental schedule of assets (held at end of year) is complete and accurate:

- Investments in registered investment companies, investments in self-directed brokerage accounts, investments in the common/collective trust, and notes receivable from participants as shown in the statements of net assets available for benefits.
- Interest income on notes receivable from participants, as shown in the statements of changes in net assets available for benefits.
- Net appreciation in fair value of investments, as shown in the statements of changes in net assets available for benefits.
- Interest and dividends, as shown in the statements of changes in net assets available for benefits.
- Schedule H, line 4(i) – schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

(4) Fair value measurement

FASB Accounting Standards Codification Topic 820, *Fair Value Measurement* ("FASB ASC 820") establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 2 describes the valuation methodologies used for assets measured at fair value. The methods described in Note 2 may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
