## NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

### 1. Description Of The Plan

The following description of the McCormack Baron 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### General

The Plan, which has been adopted by McCormack Baron Salazar, Inc. as Plan Sponsor (the Company), is a defined contribution plan that includes a 401(k) provision. The Plan covers all employees of the Company who are 18 or older except for union, leased, nonresident alien, seasonal, and those employees whose regularly scheduled hours are less than 1,000 hours of service annually. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Fidelity Management Trust Company (Fidelity) is the Plan's trustee and Fidelity Workplace Services LLC is the Plan's recordkeeper.

#### Contributions

Each year, participants may defer salary up to 100% of compensation, as defined in the Plan. Participants age 50 and older are eligible to make additional catch-up contributions. The Plan allows participants to make Roth after-tax contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their pre-tax deferral rate set at 3% of eligible compensation and their contributions invested in a default investment fund until changed by the participant. Participants may also contribute amounts representing distributions from other qualified plans (rollover).

The Plan provides for Company safe harbor qualified nonelective contributions equal to 3% of eligible compensation for each eligible participant who completes one year of service.

The Plan also provides for the Company to make discretionary employer matching contributions, which are based upon determination by the Board of Directors. The Company elected not to make a discretionary matching contribution in 2024 or 2023.

### Notes To Financial Statements (*Continued*)

In addition, the Plan provides that the Company may make discretionary profit sharing contributions for each eligible participant who completes 1,000 hours of service and is employed on the last day of the Plan year. The discretionary contribution is allocated at varying rates to defined classifications of participants as permitted under Internal Revenue Code (IRC) regulations. The Company elected not to make a discretionary profit sharing contribution in 2024 or 2023.

Contributions are subject to certain Internal Revenue Service (the IRS) limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant's deferral contributions, the Company's contributions, and an allocation of Plan's earnings (losses) and charged with withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined in the Plan Document. The benefit to which a participant was entitled is the benefit that can be provided from the participant's vested account balance.

#### **Investment Options**

Upon enrollment in the Plan, a participant is permitted to direct contributions in a variety of investment options.

#### **Notes Receivable From Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balance. The term of the loans cannot exceed five years, except for a loan that is used to acquire a principal residence. The loans must be adequately secured by the participant's vested account balance and bear interest at prevailing market rates. Participants may only have one loan outstanding at any time. Principal and interest are paid ratably through payroll deductions.

#### **Vesting**

Participants are immediately vested in their salary deferral, rollover and nonelective safe harbor contributions. Vesting in the matching and profit sharing contributions is based on years of service. A participant is 20% vested after two years of credited service and earns additional vesting in increments of 20% until 100% vesting is attained after six years of credited service. A participant becomes fully vested upon attainment of the normal retirement age of 65, death, or disability.

#### **Forfeitures**

Forfeitures are used to pay administrative expenses of the Plan or offset future Company contributions. For the year ended December 31, 2024, no forfeitures were used to pay administrative expenses. During 2023, \$8 in forfeitures were used to pay administrative expenses. As of December 31, 2024 and 2023, forfeited nonvested balances amounted to \$13,824 and \$12,005, respectively.

#### **Payment Of Benefits**

Benefit payments are made upon termination of employment, retirement, death, or disability. The normal form of retirement benefit is a lump-sum payment. Qualified optional forms of benefit payments include installment payments and partial withdrawals.

In the event that the vested portion of the participant's account does not exceed \$1,000, the balance shall be distributed in a lump sum as soon as administratively feasible. Vested amounts exceeding \$1,000 but less than \$5,000 are rolled in to an IRA if no cash distribution election is made by the participant.

Participants over the age of 59-1/2 may withdraw any portion of their vested account balance prior to termination of employment.

#### **Administrative Expenses**

The Plan Sponsor pays certain administrative expenses, such as trust fees. Other expenses, such as commissions and administrative fees, are paid by the Plan.

## **2. Summary Of Significant Accounting Policies**

#### **Basis Of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting.

#### **Estimates And Assumptions**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

#### **Investment Valuation And Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net change in fair value of investments includes the Plan's gains and losses (realized and unrealized) on investments bought and sold as well as held during the year.

#### **Contributions Receivable And Credit Loss Policy**

Amounts due for contributions are stated at the amount that management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This assessment considers historical experience, current conditions and, when appropriate, reasonable and supportable forecasts.

The Plan has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 or 2023.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at the unpaid principal balance plus accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when incurred. Delinquent notes receivable are recorded as a distribution based upon the terms of the Plan Document.

#### **Payment Of Benefits**

Benefits are recorded when paid.

#### **Subsequent Events**

Management evaluates subsequent events through the date financial statements were available for issue, which is the date of the Independent Auditors' Report.

### 3. Certified Investment Information

#### **4. Fair Value Measurements**

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

#### **Collective Trust Funds**

Valued at the net asset value (NAV) of units of the individual funds. The NAV, as provided by the trustees of the invested funds, is used as a practical expedient to estimate fair value and is calculated daily by the trustee. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. All collective trust funds have daily redemption frequencies at NAV with no redemption notice periods, and file annual reports on Form 5500 as direct filing entities. There are no capital commitments related to any of the Plan's collective trust funds.

#### **Mutual Funds**

Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 5. Transactions With Parties In Interest

Certain plan assets are managed by an affiliate of Fidelity. The Plan also pays administrative fees to Fidelity Workplace Services LLC for recordkeeping services. In addition, at December 31, 2024 and 2023, the Plan had notes receivables from participants. These transactions qualify as exempt parties in interest transactions under ERISA.

### **6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### **7. Income Tax Status**

The Plan uses a pre-approved defined contribution plan document sponsored by FMR, LLC. FMR, LLC received an opinion letter from the IRS dated June 30, 2020, which states that the pre-approved plan document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. The Plan has been amended since the date of the adoption. However, the Plan Administrator believes that the Plan, as amended, is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan was qualified and the related trust was tax exempt as of the financial statement date. As such, no income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Company identified certain operational errors relating to participant and Company contributions. Plan management has developed a plan to take necessary corrective actions to ensure the Plan maintains its tax qualified status.

### **8. Risks And Uncertainties**

Investments are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
