INDEPENDENT AUDITORS' REPORT

To the Plan Sponsor of

SADA SYSTEMS, INC. 401(k) RETIREMENT PLAN

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audit of the financial statements of **SADA Systems, Inc. 401(k) Retirement Plan** (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 20, 2024, the related statement of changes in net assets available for benefits for the period then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of December 20, 2024 and for the period then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statements section:

- The amounts and disclosures in the accompanying 2024 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying 2024 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors’ Responsibilities for the Audit of the 2024 Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on these financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan’s internal control. Accordingly, no such opinion is expressed.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2024 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Auditors' Report on the 2023 Financial Statements

Predecessor auditors performed an audit of the 2023 financial statements of the Plan. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the Plan that were certified by a qualified institution. Their report dated September 30, 2024, indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agreed to or is derived from the certified investment information, was presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

December 20, 2024 and December 31, 2023

(1) Description of the Plan

The following brief description of the SADA Systems Inc. 401(k) Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more specific provisions.

A. General – The Plan was a defined contribution plan that was established January 1, 2011, to provide benefits to eligible employees of SADA Systems, Inc. (the "Company"). The plan administrator believes the Plan was designed and operated in compliance with applicable requirements of the Internal Revenue Code (the "Code") and provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

On December 20, 2024, the Special Committee authorized the Merger of the Plan into the Insight Enterprises, Inc. 401(k) Plan (the "Insight Plan"), a retirement plan sponsored by Insight Enterprises, Inc. Plan assets totaling approximately \$43,253,000 were transferred to the Insight Plan on December 20, 2024.

B. Administration and expenses – Fidelity Management Trust Company served trustee and third-party administrator responsible for maintaining participant records. Therefore, these transactions qualify as party-in-interest transactions. Administration, custodial and investment management fees were charged directly to Plan investment funds and were factored into each fund via a reduction in investment return. Certain fees including withdrawal and participant loan administration fees were charged directly to participants. These administrative expenses totaled \$4,950 for the period ended December 20, 2024. The Company paid a majority of other costs of administering the Plan.

C. Eligibility – Essentially all employees of the Company were eligible to participate in the Plan. Effective August 30, 2021, the Plan was amended to specifically exclude employees covered by a collective bargaining agreement and non-resident aliens from participating in the Plan and requiring a 1,000 hour service requirement for part-time employees and interns to participate in the Plan. Substantially all employees of the Company who had attained age 21 were eligible to make elective contributions to the Plan upon satisfying eligibility requirements. Eligible employees could enter the Plan immediately and participate in elective deferrals. After completing one year of service, 1,000 hours of work, an employee could participate in Company matching and profit sharing contributions.

D. Contributions – Participants could elect to make pre-tax and/or Roth after-tax contributions to the Plan up to the amount allowable under Code regulations. Participants age 50 and older could elect to make additional catch-up contributions as allowed under Code regulations. Participants who made pre-tax contributions to the Plan received an equivalent reduction in taxable compensation. Participants were also allowed to make rollover contributions of amounts received from other tax-qualified retirement plans subject to the approval of the plan administrator.

Effective February 22, 2021, the Company matched 50% of a participant's deferrals up to 6% of their eligible compensation. The Company's matching contributions were discretionary. The Company matched 50% of participants' deferrals up to 6% of their eligible compensation during 2024. The Company could also make discretionary profit sharing contributions. The Company did not make any discretionary profit sharing contributions to the Plan for the period ended December 20, 2024.

E. Participant accounts – Each participant's account was credited with the participant's contributions, rollovers, Company contributions, and the participant's share of investment earnings or losses and expenses. Plan assets were invested based solely on instructions received from participants.

F. **Vesting and forfeitures** – Participants were immediately 100% vested in their accounts attributable to elective contributions, rollovers and related earnings. From January 1, 2021 through February 21, 2021, vesting in the employer contributions and earnings thereon was based on years of continuous services as follows:

Forfeitures of terminated participants' non-vested accounts could be used to pay Plan administrative expenses or to reduce future Company contributions. During the period ended December 20, 2024, forfeitures of approximately \$113,000 were used to reduce a true up amount related to employer matching contributions related to the 2023 plan year. The balance of unapplied forfeitures was \$0 at December 20, 2024 and approximately \$5,000 at December 31, 2023.

G. **Notes receivables from participants** – The Plan allowed participants to borrow not less than \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. A loan was secured by a participant's vested account balance, bore interest at a fixed rate based on available market financing rates at loan inception and would be repaid to the Plan within a five-year period, unless a loan was used for the purchase of a principal residence in which case the repayment period would be extended to a maximum of thirty years. Principal and interest were paid ratably through payroll deductions. Notes receivable from participants at December 31, 2023 carried interest rates ranging from 4.25% to 9.50% and maturities through June 2032. Notes receivable were measured at their unpaid principal balance plus accrued interest. Delinquent notes were recorded as a distribution based on the terms of the Plan document.

H. **Payment of benefits** – Normal retirement age under the Plan is age 65. Upon termination of service, death, disability, retirement or attainment of age 59½, a participant or beneficiary could maintain his or her account in the Plan or choose to receive vested benefits in a lump sum or installments. Hardship distributions were permitted under limited circumstances, as defined in the Plan and approved by the plan administrator. Benefits were recorded when paid.

I. **Plan termination** – As of December 20, 2024, the Plan was terminated and the assets were transferred to the Insight Plan.

(2) Summary of significant accounting policies

Basis of accounting – The accompanying financial statements of the Plan were prepared in conformity with accounting principles generally accepted in the United States of America (GAAP) on the accrual basis of accounting. Accordingly, income and contributions were recognized when earned and expenses were recorded when incurred.

Management’s use of estimates – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investment valuation and income recognition – Investments in shares of mutual funds were stated at net asset values. Net asset values are readily determinable fair values of those shares as they are published daily and are the basis for current transactions. Investments in the common/collective trust were stated at unit value, or the equivalent of net asset value, which is a practical expedient for estimating the fair value of these investments. Investments in the common/collective trust could be redeemed daily with a notice period of one day and had no unfunded commitments as of December 31, 2023.

The net appreciation in the fair value of investments reflects the change in fair value of the investments held at year end and realized gains and losses on investment transactions during the year. Certain investment related expenses are included in net appreciation of fair value of investments. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Risks and uncertainties – The Plan’s exposure to credit loss in the event of nonperformance of investments was limited to the carrying value of such instruments. The Plan’s exposure to interest rate risk, credit risk and market risk were dictated by the Plan’s provisions as well as those of ERISA and the participants’ investment preference. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of these investments, it was at least reasonably possible that changes in risks in the near term could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Notes receivable from participants – Notes receivable from participants were measured at their unpaid principal balance plus accrued interest. Fees related to the administration of notes receivable from participants were charged directly to the participant’s account and are included in administrative expenses.

Payment of benefits – Benefits were recorded when paid.

Subsequent events – The Plan’s management had evaluated subsequent events through October 10, 2025, which was the date the financial statements were available to be issued.

(3) Income tax status

The Plan has adopted an amended and restated pre-approved defined contribution plan document entitled Fidelity Basic Plan Document No. 17 (the “Pre-Approved Plan Document”). The Pre-Approved Plan Document received an opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, stating that the Pre-approved Plan Document was designed in accordance with the applicable sections of the IRC. The Pre-approved Plan Document has been amended since receipt of the opinion letter. The Plan Sponsor and the trustee of the Plan believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Accordingly, no provision for income taxes has been made in the accompanying financial statements.

(4) Financial information certified by the trustee

The Plan Sponsor has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan's trustee has certified that the following data included in the accompanying financial statements is complete and accurate:

- Investments in mutual funds, investments in the common/collective trust, and notes receivable from participants as shown in the statements of net assets available for benefits.
- Interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits.
- Net appreciation in fair value of investments, as shown in the statement of changes in net assets available for benefits.
- Interest and dividends, as shown in the statement of changes in net assets available for benefits.

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

(5) Fair value measurements

FASB Accounting Standards Codification Topic 820, *Fair Value Measurement* ("FASB ASC 820") establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The Plan held no investments as of December 20, 2024.
