- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other matter - supplemental schedule required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such supplementary information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures. These additional procedures included comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplemental schedule that agreed to or is derived from

the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A - PLAN DESCRIPTION

The following description of the UL LLC Financial Security Plan (the Plan) provides only general information. Participants should refer to the Plan document for more complete information.

General

The Plan, a defined contribution plan covering substantially all employees of Underwriters Laboratories LLC (the Company), is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Company's Total Rewards Team controls and manages the Plan's operation and administration. Fidelity Management Trust Company (FMTC) serves as the trustee of the Plan.

Contributions

Eligibility to participate in the Plan is determined based on employment with the Company and begins from the date of hire. Eligible participants are enrolled automatically in the Plan with a pretax deferral of 3% of base pay in the first year of service that will increase each anniversary of the participant's start date by 1%, up to a maximum of 10%. Participants can opt out of automatic enrollment by electing not to contribute to the Plan or to contribute a different percentage of eligible pay. The Company matches up to 100% of the first 3% of base pay, and up to 50% of the next 4% of base pay contributed to the Plan as before-tax, or Roth 401(k).

Participants who attain age 50 before the end of the Plan year are eligible to make catch-up contributions. Contributions can be made on an elective deferral basis to a before-tax or Roth account on an after-tax basis, but are limited to a maximum amount per the Internal Revenue Service (IRS) regulations.

The Company also makes a retirement contribution to eligible participants' 401(k) accounts. For Plan years beginning before December 31, 2016, employees who have completed one or more years of service and are not earning Benefit Service as defined in the UL Retirement Income Plan LLC because the employee's hire date is after December 31, 2001, or they elected to receive the retirement contribution during the election period in February 2002, are eligible for retirement contributions. For Plan years beginning on and after January 1, 2017, with respect to participants whose date of hire was before January 1, 2017, the Company makes a retirement contribution equal to 4% to 6% of a participant's base pay on behalf of every eligible Plan participant, based on the below chart, depending on years of service as of January 1, 2017, with no subsequent increases for years of service after January 1, 2017.

<u>Years of Service</u>	<u>Retirement Contribution</u>
Less than 1	0%
1 - 9	4%
10 - 19	5%
20+	6%

For Plan years beginning on and after January 1, 2017, with respect to participants whose date of hire is on or after January 1, 2017, the amount of such employer retirement contribution shall equal 4% of the participant's base pay.

Consumer Testing Laboratories employees (CTL) who were participants in the Plan on May 31, 2019, ceased to be employed by CTL and became employees of UL Verification Services. Effective January 1, 2021, CTL employees are eligible to receive a retirement contribution. The amount of such employer retirement contribution shall equal 4% of the participant's base pay.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's retirement contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan and Plan losses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

According to specific terms of the Plan and subject to IRS regulations, a participant may generally borrow up to half of his or her vested account balance, up to a maximum of \$50,000. The term of the loan may range from one to 10 years from the date of the loan, with respect to a loan used for the acquisition of a principal residence of the participant (a Residence Loan), or five years from the date of the loan, with respect to a loan used for any purpose other than the acquisition of a principal residence of the participant (a General Loan). Loans are secured by the balance in the participant's vested account and interest is payable at the prime rate plus one percentage point, determined at the time the loan is made. Principal and interest are paid ratably through semimonthly payroll deductions. During any Plan year, a participant may request one Residence Loan and one General Loan. No more than one Residence Loan and one General Loan may be outstanding at any time.

Investments

Participants direct the investment of their accounts into various investment options offered by the Plan. In addition, participants can elect to invest their Plan assets in individual securities by establishing a Plan level brokerage account. If a participant is automatically enrolled, his or her contributions are invested in an applicable lifecycle fund based on the participant's age until the participant changes his or her election.

Vesting

Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested in the Company's matching contributions after two years of service, and all retirement contributions after five years of service. Prior to completing two or five years of vesting service, if a participant terminates employment with the Company for reasons other than disability or death, whether or not voluntarily, he or she shall forfeit a percentage of the portion of his or her accounts derived from the Company's matching and retirement contributions made under the Plan.

Forfeited Accounts

Upon termination of employment, participants forfeit their non-vested balance. Forfeited balances from terminated participant accounts are allocated as of the end of the Plan year in which the forfeiture occurs. These amounts are applied to reduce future Company contributions and may also be used to pay Plan administrative expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$62 thousand and \$30 thousand, respectively, which will be used to reduce future Company contributions. During the year ended December 31, 2024, Company contributions were reduced by approximately \$1.7 million from forfeited non-vested accounts. During the year ended December 31, 2024, administrative expenses of approximately \$20 thousand were paid from forfeited non-vested accounts.

Revenue Sharing

FMTC provides participant revenue-sharing credits to the Plan. The participant revenue-sharing credits are allocated each quarter to participants who invest in the investment options under the Plan for which the

trustee receives compensation. Total credits of approximately \$321 thousand were applied to participant accounts during 2024 and are recorded as revenue-sharing income in the accompanying statement of changes in net assets available for benefits.

Payment of Benefits

Upon termination of employment, participants with an account balance of \$1 thousand or more may elect to receive either a lump-sum distribution equal to the value of the participant's vested interest in his or her account or monthly installments or may elect to defer receipt of their balance. Participants with a balance less than \$1 thousand automatically receive a lump-sum distribution.

In-service withdrawals are available in certain limited circumstances, as defined by the Plan. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan.

Administrative Expenses

Administrative expenses of the Plan are paid by either the Plan or the Plan's sponsor, as provided in the Plan document. Administrative expenses include recordkeeping and trustee fees. Expenses relating to purchases, sales or transfers of the Plan's investments are charged to the particular investment fund to which the expenses relate.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). See Note D for further discussion and disclosures related to fair value measurements.

Shares of mutual funds are valued at quoted market prices, based on net asset value (NAV) of shares held by the Plan at year-end.

The collective trust is valued at the NAV of units held. The NAV is used as a practical expedient to estimate fair value. There are no redemption restrictions or unfunded commitments for the collective trusts valued at NAV.

The majority of the investments in the self-directed brokerage accounts consist of cash, mutual funds and common stock that are valued using quoted market prices.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The net appreciation in the fair value of investments consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments. The net realized gain or loss on investments is the difference between the proceeds received and the costs of investments sold determined on an average cost basis. Unrealized appreciation (depreciation) on the fair value of investments is the difference between the fair value at year-end and the fair value at the beginning of the year.

Effective October 1, 2022, employees of Underwriters Laboratories Standards & Engagement Inc. (ULSE) and Underwriters Laboratories Research Institutes (ULRI) were no longer eligible employees under the Plan. Account balances of affected participants were spun-off to a newly created plan called ULSE & ULRI Financial Security Plan (ULSE & ULRI Plan). This transaction allowed for mirror investment line-up created under ULSE & ULRI Plan through FMTC and assets were transferred in-kind. As a result, effective as of the spin-off date, a master trust was created for the separately managed Fixed Income Fund. For this limited purpose, the trust agreement was amended to include the ULSE & ULRI Plan's participation in the Fixed Income Fund which became the UL LLC Fixed Income Master Trust (Master Trust) in October 2022.

The Plan's fully benefit-responsive investment contracts held in the Master Trust, as of December 31, 2024 and 2023, are valued at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. See Note E for Master Trust and fully benefit-responsive investment disclosures.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued, but unpaid interest. Interest income on notes receivable from participants is recorded when earned. Related fees are recorded as administrative expenses and are expensed when incurred. If a participant ceases making loan repayments and the Plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

NOTE C - INFORMATION CERTIFIED BY TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, FMTC, the trustee, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value, Plan's interest in the Master Trust, notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

NOTE D - FAIR VALUE MEASUREMENTS

Fair value is defined as the exit price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

Level 1 - Unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.

Level 2 - Inputs other than quoted prices in active markets for identical assets and liabilities that are observable, either directly or indirectly, for substantially the full term of the asset or liability.

Level 2 inputs include the following:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in markets that are not active.
- Observable inputs other than quoted prices that are used in the valuation of the assets or liabilities.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability. Also included in Level 2 are investments measured using NAV per share, or its equivalent, that may be redeemed at that NAV at the period end date or in the near term without redemption restrictions.

Level 3 - Unobservable inputs for the asset or liability. Level 3 inputs include management's own assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

Inputs are used in applying various valuation techniques and broadly refer to the assumptions that market participants use to make valuation decisions, including assumptions about risk. Inputs may include price information, volatility statistics, specific and broad credit data, liquidity statistics and other factors. A financial instrument's level within the fair value hierarchy is based on the lowest level of any input significant to the fair value measurement.

The valuation methods described in Note B may produce a fair value calculation that may not indicate net realizable value or reflect future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - PLAN'S INTEREST IN A MASTER TRUST

As noted in Note B, the Master Trust's underlying investments are primarily fully benefit-responsive investments contracts and therefore, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to this account. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses, and is the amount the Plan participant will receive if he or she transfers or surrenders his or her funds out of the guaranteed investment contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuers.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Examples of such events include (1) transfers of assets from the fund into a competing investment option (2) when total distributions and transfers in the fund exceed certain levels and (3) withdrawals prompted by certain events (such as plan termination, partial plan termination, facility closings, changes in laws and regulations, etc.). The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable to occur.

Although the assets are commingled in the Master Trust, FMTC maintains supporting records for the purpose of allocating the net gain or loss of the investment account to the participating plans. Investment (loss) income and investment expenses relating to the Master Trust are allocated to the individual plans based upon the balances of participant accounts in each plan.

NOTE F - PARTY-IN-INTEREST AND RELATED-PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Fidelity Investments, a company related to FMTC, the Fixed Income Fund and a collective trust fund are managed by FMTC. In addition, the Plan provides a self-directed brokerage account option for participants through the Fidelity BrokerageLink, which is managed by Fidelity Investments and also holds underlying investments managed by Fidelity Investments. Since FMTC is the Plan's trustee, these transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.

NOTE G - PLAN TERMINATION

Although it has not expressed the intent, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions set forth in ERISA. Should the Plan terminate, participants would become 100% vested in Company contributions.

NOTE H - INCOME TAX STATUS

The IRS has determined and informed the Company by a letter dated December 30, 2015, that the Plan and its related trust were designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires the Plan's management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan administrator analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan recognized no liability or disclosures related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE I - RISKS AND UNCERTAINTIES

The Plan invests in investment securities that are exposed to risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term. The changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE J - SUBSEQUENT EVENTS

Plan management has evaluated the Plan's December 31, 2024 financial statements for subsequent events through October 13, 2025, the date the financial statements were available to be issued. Plan management is not aware of any subsequent events that would require recognition or disclosure in the financial statements.
