We have performed audits of the financial statements of LVMH Affiliates' 401(k) Plan, Wines & Spirits (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

## Notes to Financial Statements

### Note 1. Plan Description

The following description of the LVMH Affiliates' 401(k) Plan, Wines & Spirits (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

As of December 31, 2024, the following companies, Moët Hennessy USA, Inc, Domaine Chandon, Inc., Newton Vineyards, LLC and Woodinville Whiskey Company, LLC (collectively, the Company) are participating in the Plan.

#### General

The Plan sponsor is LVMH Moët Hennessy Louis Vuitton Inc., and is a deferred salary plan, which provides retirement benefits for all eligible employees of the employers listed above. The LVMH Retirement Plans Committee oversees governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees. The plan administrator, who is an officer of LVMH Moët Hennessy Louis Vuitton Inc., has entered into a trustee agreement with Fidelity Management Trust Company (Fidelity) (the Trustee) to provide custodial and recordkeeping services to the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Participants may make pre-tax contributions to the Plan through payroll deductions. Total contributions may not exceed the lesser of 75 percent of the participant's pre-tax annual compensation subject to Internal Revenue Service (IRS) annual calendar year maximums. The Plan allows for participating employees who have attained age 50 during the plan year to make catch-up contributions, also subject to the IRS annual calendar year maximums. In addition, the Plan accepts qualified plan rollovers from eligible participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4 percent of eligible compensation, increasing annually by 1 percent until reaching 7 percent, and their contributions invested in a designated balanced fund until changed by the participant.

The Company matches 50 percent of eligible compensation that a participant contributes to the Plan up to 7 percent of base pay. Additional discretionary contributions may be contributed at the option of the Plan's Board of Trustees. No additional discretionary contributions were made during the year.

Participants direct the investment of their contributions and their Company contributions into various investment options offered by the Plan.

#### Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the amount of the vested balance in the participant's account.

## Notes to Financial Statements

### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of participant's accounts plus actual earnings thereon is based on years of continuous service. A participant is 100 percent vested after three years of credited service.

### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1 percent, as determined as of the first day of each calendar quarter. Only one loan may be outstanding at any time, may have a maximum term of five years, unless it is for the purchase of the participant's principal residence in which case the term would be extended to ten years, and must be repaid through payroll deductions over the term of the loan.

### **Payment of Benefits**

Participants' vested account balances are payable on retirement. The normal retirement age under the Plan is 65. Withdrawals are permitted beginning at age 59½ in case of disability, death or termination of employment. Upon reaching age 59½, withdrawals of all or a portion of the participant's account may be withdrawn, even if the participant is still actively employed.

Participants electing final distributions will receive payment in the form of a lump sum amount or installment payments equal to the value of their vested account.

### **Forfeited Accounts**

Upon termination, participants forfeit their non-vested account balances. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$218,777 and \$172,533, respectively. These accounts will be used to reduce future Company contributions and to pay Plan expenses. During 2024 and 2023, Company contributions were reduced by \$14,852 and \$12,191 and Plan expenses of \$33,725 and \$41,562 were paid from forfeited non-vested accounts, respectively.

## **Note 2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (US GAAP) requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

## Notes to Financial Statements

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded at the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Contributions**

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### **Plan Management's Review of Subsequent Events**

The Plan has evaluated subsequent events and transactions through October 14, 2025, the date that the financial statements were available to be issued.

### **Note 3. Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity.

### Note 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market fund: Valued using the NAV of the fund shares.

Collective trust fund: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the investments in the collective trust, less any liabilities. Transactions may occur daily. Were the Plan to initiate a full redemption of the common collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the common collective trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

### Note 5. Related Party Transactions and Party in Interest Transactions

Certain investments of the Plan are shares of mutual funds and a collective trust managed by Fidelity Investments. Fidelity Management Trust Company (the trustee) is a related party to Fidelity Investments and, therefore, these transactions qualify as party-in-interest transactions. All investment fund earnings or losses posted to each Plan participant's account are net of investment management fees charged by each investment fund under the Plan.

Effective July 1, 2019, Fidelity provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement (MSA) between the Company and Fidelity. Fidelity receives revenue from mutual fund service providers for services Fidelity provides to the funds. This revenue is used to offset certain amounts owed to Fidelity for its administrative services to the Plan.

If the revenue received by Fidelity from such mutual fund service providers exceeds the amount owed under the MSA, Fidelity remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024 and 2023, there were excess amounts totaling \$336,1369 and \$109,619, respectively. The Plan or Plan Sponsor may make a payment to Fidelity for administrative expenses not covered by revenue sharing.

### **Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their Company contributions.

### **Note 7. Tax Status**

Effective February 1, 2022, the Plan adopted a nonstandardized prototype defined contribution profit sharing plan with Internal Revenue Code Section 401(k) Cash or Deferred Arrangement (CODA) which received a favorable opinion letter from the IRS dated June 30, 2020. The Plan has been amended since the date of the last amendment covered by the above mentioned determination letter. However, Plan management believes that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that some changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

We have performed audits of the financial statements of LVMH Affiliates' 401(k) Plan, Wines & Spirits (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

## Notes to Financial Statements

### Note 1. Plan Description

The following description of the LVMH Affiliates' 401(k) Plan, Wines & Spirits (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

As of December 31, 2024, the following companies, Moët Hennessy USA, Inc, Domaine Chandon, Inc., Newton Vineyards, LLC and Woodinville Whiskey Company, LLC (collectively, the Company) are participating in the Plan.

#### General

The Plan sponsor is LVMH Moët Hennessy Louis Vuitton Inc., and is a deferred salary plan, which provides retirement benefits for all eligible employees of the employers listed above. The LVMH Retirement Plans Committee oversees governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees. The plan administrator, who is an officer of LVMH Moët Hennessy Louis Vuitton Inc., has entered into a trustee agreement with Fidelity Management Trust Company (Fidelity) (the Trustee) to provide custodial and recordkeeping services to the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Participants may make pre-tax contributions to the Plan through payroll deductions. Total contributions may not exceed the lesser of 75 percent of the participant's pre-tax annual compensation subject to Internal Revenue Service (IRS) annual calendar year maximums. The Plan allows for participating employees who have attained age 50 during the plan year to make catch-up contributions, also subject to the IRS annual calendar year maximums. In addition, the Plan accepts qualified plan rollovers from eligible participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4 percent of eligible compensation, increasing annually by 1 percent until reaching 7 percent, and their contributions invested in a designated balanced fund until changed by the participant.

The Company matches 50 percent of eligible compensation that a participant contributes to the Plan up to 7 percent of base pay. Additional discretionary contributions may be contributed at the option of the Plan's Board of Trustees. No additional discretionary contributions were made during the year.

Participants direct the investment of their contributions and their Company contributions into various investment options offered by the Plan.

#### Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the amount of the vested balance in the participant's account.

### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of participant's accounts plus actual earnings thereon is based on years of continuous service. A participant is 100 percent vested after three years of credited service.

### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1 percent, as determined as of the first day of each calendar quarter. Only one loan may be outstanding at any time, may have a maximum term of five years, unless it is for the purchase of the participant's principal residence in which case the term would be extended to ten years, and must be repaid through payroll deductions over the term of the loan.

### **Payment of Benefits**

Participants' vested account balances are payable on retirement. The normal retirement age under the Plan is 65. Withdrawals are permitted beginning at age 59½ in case of disability, death or termination of employment. Upon reaching age 59½, withdrawals of all or a portion of the participant's account may be withdrawn, even if the participant is still actively employed.

Participants electing final distributions will receive payment in the form of a lump sum amount or installment payments equal to the value of their vested account.

### **Forfeited Accounts**

Upon termination, participants forfeit their non-vested account balances. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$218,777 and \$172,533, respectively. These accounts will be used to reduce future Company contributions and to pay Plan expenses. During 2024 and 2023, Company contributions were reduced by \$14,852 and \$12,191 and Plan expenses of \$33,725 and \$41,562 were paid from forfeited non-vested accounts, respectively.

## **Note 2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (US GAAP) requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

## Notes to Financial Statements

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded at the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Contributions**

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### **Plan Management's Review of Subsequent Events**

The Plan has evaluated subsequent events and transactions through October 14, 2025, the date that the financial statements were available to be issued.

### **Note 3. Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity.

### Note 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market fund: Valued using the NAV of the fund shares.

Collective trust fund: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the investments in the collective trust, less any liabilities. Transactions may occur daily. Were the Plan to initiate a full redemption of the common collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the common collective trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

### Note 5. Related Party Transactions and Party in Interest Transactions

Certain investments of the Plan are shares of mutual funds and a collective trust managed by Fidelity Investments. Fidelity Management Trust Company (the trustee) is a related party to Fidelity Investments and, therefore, these transactions qualify as party-in-interest transactions. All investment fund earnings or losses posted to each Plan participant's account are net of investment management fees charged by each investment fund under the Plan.

Effective July 1, 2019, Fidelity provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement (MSA) between the Company and Fidelity. Fidelity receives revenue from mutual fund service providers for services Fidelity provides to the funds. This revenue is used to offset certain amounts owed to Fidelity for its administrative services to the Plan.

If the revenue received by Fidelity from such mutual fund service providers exceeds the amount owed under the MSA, Fidelity remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024 and 2023, there were excess amounts totaling \$336,1369 and \$109,619, respectively. The Plan or Plan Sponsor may make a payment to Fidelity for administrative expenses not covered by revenue sharing.

### **Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their Company contributions.

### **Note 7. Tax Status**

Effective February 1, 2022, the Plan adopted a nonstandardized prototype defined contribution profit sharing plan with Internal Revenue Code Section 401(k) Cash or Deferred Arrangement (CODA) which received a favorable opinion letter from the IRS dated June 30, 2020. The Plan has been amended since the date of the last amendment covered by the above mentioned determination letter. However, Plan management believes that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that some changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
