### **Opinion**

We have audited the accompanying financial statements of Northern Colorado Anesthesia Professionals, PLLC 401k Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.



**Note 1 - Description of Plan**

The following description of the Plan provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all regular employees of Northern Colorado Anesthesia Professionals, PLLC (the Plan Sponsor or NCAP) who have completed 1,000 hours of service in the calendar year beginning on the employee's commencement date and ending 12 months following the original commencement date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and has been amended to incorporate legislative change under the Economic Growth Tax Relief Reconciliation Act (EGTRAA).

The Retirement Investment Committee of NCAP administers the Plan. Matrix Trust Company ("Matrix") serves as custodian and TPP Retirement Plan Specialists, LLC manages Plan assets and maintains the Plan's records.

The Plan was established on January 1, 1998. The Plan was restated effective January 1, 2022 in order to comply with the applicable requirements of the Internal Revenue Code (IRC). No changes were made to the provisions of the Plan. The Plan has adopted a TPP Retirement Specialists, LLC Volume Submitter Defined Contribution Plan that complies with all applicable requirements as set forth by the IRC.

Contributions - Participants may defer before-tax or after-tax (Roth) contributions up to a maximum of 100% of their total compensation each year instead of receiving that amount in cash. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The amount of the deferral is limited to the maximum allowed by law. The Plan also allows rollover contributions from qualified plans. Participant contributions are withheld from the participants' payroll each pay period. Effective January 1, 2022, the Plan includes an automatic deferral arrangement which applies to employees hired on or after January 1, 2021. Each participant will be automatically enrolled at 3% of compensation and increasing by 1% each plan year until the amount withheld reaches 6% of compensation. A participant may elect to opt out of the plan or select an alternative deferral amount by completing a salary reduction agreement, as defined by the Plan.

**Note 1 - Description of Plan** (continued)

NCAP makes non-elective safe harbor contributions, discretionary non-elective profit sharing contributions and discretionary match contributions to the Plan. In order to receive these contributions, participants must be active during the year of the contribution, as well as have worked at least 1,000 hours during the eligibility period. Non-elective safe harbor employer contributions of 3% of eligible wages totaling \$884,291 were contributed to the Plan during the year ended December 31, 2024. Non-elective profit sharing employer contributions of 2% up to 7.333% of eligible wages based on employee classification totaling \$1,359,117 were contributed to the Plan during the year ended December 31, 2024.

Discretionary employer match of 50% up to 6% of employee deferrals on eligible wages may be made to the Plan. Whether or not these contributions are made is determined on an annual basis. Employer discretionary match contributions totaling \$850,041 were contributed to the Plan during the year ended December 31, 2024.

Participant Accounts - Each participant's account is credited with the participant's contribution and allocation of (a) the Employers' contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in all elective deferral contributions into the Plan as well as non-elective safe harbor employer contributions, discretionary matching contributions, and non-elective profit sharing contributions.

Notes Receivable From Participants - Participants may borrow from their fund accounts up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The notes receivable are secured by the balance in the participants' account and bear interest at the annual prime rate, plus 2%, as defined by the Plan document. The interest rates on outstanding notes receivable from participants ranged from 5.25% - 10.50% as of December 31, 2024 with maturity dates through January 2028. Interest income on notes receivable from participants is recognized in the period it is earned. Installment payments including principal and interest on the notes receivable are withheld from the participants' payroll every pay period.

**Note 1 - Description of Plan** (continued)

Payment of Benefits - Upon death, disability, retirement, or termination of service, a participant can elect to receive either a lump-sum distribution equal to the vested value of the participant's account, or installments under a life annuity plan. Participants may not make withdrawals from their accounts prior to retirement at age 59 and a half, except in the event of disability, death, termination of employment or notice of hardship, without being subject to certain restrictions and penalties.

Forfeitures - Forfeitures are used to reduce future employer contributions or pay administrative expenses as defined in the Plan document. At times, forfeitures result from over-funded employer contributions. Forfeitures in the amount of \$3,180 were used to pay administrative expenses during the year ended December 31, 2024. There were no forfeitures available as of December 31, 2024 and 2023.

**Note 2 - Summary of Accounting Policies**

Basis of Accounting - The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and third-party administrators. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Contributions - Contributions from Plan participants and the Employer are recorded in the year in which participant compensation is earned.

Notes Receivable From Participants - Notes receivable from participants are considered in default at the end of the current period set forth by the separate loan procedures, for which there is any outstanding payment due (principal or interest). At this date, the entire outstanding principal and accrued interest shall be distributed or deemed distributed to the participant. For the year ended December 31, 2024, there were no distributions that resulted from defaulted loans.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employers. Expenses that are paid for by the Employers are excluded from these financial statements. Fees related to the administration of notes receivable from participants and fees paid related to benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation (depreciation) of fair value of investments.

Subsequent Events - The Plan administrator has evaluated all subsequent events through October 9, 2025, the date the financial statements were available to be issued.

**Note 3 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

Level 1 Fair Value Measurements - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in an active market which the Plan has the ability to access at the measurement date.

Level 2 Fair Value Measurements - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in an active market;
- Quoted prices for identical or similar assets or liabilities in an inactive market;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Fair Value Measurements - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund and are classified as Level 1 investments. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Outside self-directed brokerage accounts:* Accounts primarily consist of mutual funds and common stocks, but also include REITs and ETFs. These accounts are held in a platform not maintained by the custodian.

*Self-directed brokerage accounts:* Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices. These self-directed brokerage accounts are held in a platform maintained by the custodian and valued as level 1 investments.

*Common collective trust:* Valued at the net asset value (NAV) of units of a bank collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

**Note 4 - Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated for any reason, all participants are 100% vested, and the Plan administrator is to distribute each participant's interest to the participant or beneficiary.

**Note 5 - Tax Status**

The Plan adopted a prototype plan from its third-party administrator. The prototype plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Volume Submitter Defined Contribution Plan with CODA, as designed, is in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6 - Information Prepared and Certified by Custodian**

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the custodian.

**Note 7 - Related-Party and Party-In-Interest Transactions**

The Plan held investments, including shares of mutual funds of registered investment companies, of the custodian during the year ended December 31, 2024. Administrative fees were paid to the record-keeper, investment advisor, and third-party administrator during the year ended December 31, 2024. Notes receivable from participants are held by participants of the Plan. Accordingly, these notes qualify as party-in-interest transactions.
