**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Tax-deferred Annuity Plan of Outreach Development Corporation (the "Plan") provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

**A. General**

The Plan is a defined contribution plan covering all full-time employees of Outreach Development Corporation (the "Organization" or "Sponsor"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**B. Contributions**

Each year, participants may contribute up to the maximum allowed by law of annual pretax compensation, as defined in the Plan. Participants who attained age 50 before the plan yearend are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently provides multiple mutual funds and an insurance investment contract as investment options for participants. The Plan accepts rollover contributions. Contributions to the Plan are subject to certain limitations.

**C. Participant Accounts**

Each participant's account is credited with the participant's contribution and an allocation of plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**D. Vesting**

A participant is immediately vested in their contributions plus actual earnings thereon.

**E. Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account or annual installments over ten years. For termination of service for other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution. Benefits are recorded when paid.

**F. Participant Loans**

Participants may borrow from their fund accounts (outside the Plan) a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account and bear interest at the highest rate of 5.85% and lowest rate of 5.68% and are generally payable in installments over periods ranging from one to five years (unless the loan is used for the purchase of a primary residence, in which case the repayment period may be up to ten years). As of December 31, 2024 and 2023, such collateral amounted to \$30,993 and \$34,490, respectively, which is included in the investments on the accompanying statements of net assets available for benefits.

A loan that is considered in default is reported as a deemed distribution which is a taxable event for the participant. As of December 31, 2024 and 2023, there were no defaulted loans.

**G. Expenses**

Certain expenses of maintaining the Plan are paid by the Organization and are excluded from these financial statements. Expenses paid by the Plan's participants consist of investment advisory services and transactional processing fees. Investment-related costs are included in net appreciation (depreciation) in the value of investments.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting and Use of Estimates**

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**B. Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains on investments bought and sold as well as held during the year.

**C. Payment of Benefits**

Payment of benefits is recorded when paid.

**D. Subsequent Events Evaluation by Management**

Management has evaluated subsequent events for disclosure and recognition in the financial statement through October 14, 2025, the date the financial statements were available to be issued.

**NOTE 3 – INVESTMENTS INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIANS AS COMPLETE AND ACCURATE**

As noted in the independent auditor's report, the Plan Sponsor has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") *Rules and Regulations for Reporting and Disclosure* under ERISA. Accordingly, as permitted under such election, the following information was certified as complete and accurate by Mutual of America ("Mutual") and was not subjected to any auditing procedures performed by the independent auditors except for comparing such information to information included in the Plan's financial statements.

Mutual has certified to the completeness and accuracy of the investments included in the financial statements as of December 31, 2024 and 2023, and investment activity included in the financial statements for the year then ended as summarized below:

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board Accounting Standards Codification (“FASB ASC”) 820, “Fair Value Measurement,” provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the assets or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual of America Interest Accumulation Account**

The Mutual of America Interest Accumulation Account is credited with interest at a rate determined by Mutual of America. Mutual of America reserves the right to change the interest rate applicable to amounts held in the interest accumulation account at its discretion. If funds are transferred to another funding vehicle or investment, they may be subject to market value adjustments. The interest Accumulation account is carried at contract value.

**Mutual Funds**

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Changes in Fair Value Levels**

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. We evaluated the significance of transfers between levels based on the nature of the financial instrument and the size of the transfer relative to total net assets available for benefits. There were no transfers for the years ended December 31, 2024, and 2023.

Mutual funds carried at fair value as December 31, 2024 and 2023 were classified as Level 1 and amounted to \$6,332,501 and \$5,507,107, respectively.

**NOTE 5 - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are managed by Mutual of America. Mutual of America is the Custodian defined by the Plan; therefore, these transactions qualify as exempt party-in-interest transactions under ERISA. The sponsor paid certain fees relating to administrative expenses outside of the Plan.

Participants who are active employees may borrow from their accounts, and such loans qualify as exempt party-in-interest transactions under ERISA.

Certain administrative functions are performed by officers or employees of the Employer who may also be participants in the Plan. No such officer or employee receives compensation from the Plan.

Fees incurred by the Plan for the investment management services are reflected as administrative fees in the accompanying financial statements and amounted to \$1,189 for the year ended December 31, 2024.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA.

**NOTE 7 - TAX STATUS**

The Plan has adopted an approved prototype plan document which received Internal Revenue Service ("IRS") approval. The Employer believes that the Plan is designed and operating according to applicable sections of the Internal Revenue code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to multiple risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amount reported in the statement of net assets available for benefits.
