Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Klaussner Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 (in Liquidation) and 2023 (in Liquidation), and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 (in Liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 (in Liquidation) and 2023 (in Liquidation), and for the year ended December 31, 2024 (in Liquidation), stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Basis of Accounting

As discussed in Note 1 to the financial statements, the Plan was terminated effective August 7, 2023, and management determined liquidation was imminent. As a result, the Plan has changed its basis of accounting from the ongoing basis to the liquidation basis used in presenting the 2024 and 2023 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule listed in the table of contents is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Description of Plan

The following description of the Klaussner Retirement Savings Plan (“Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan was a defined contribution plan that covered all full-time employees of Klaussner Furniture Industries, Inc.; Klaussner Corporate Services, Inc.; and Prestige Fabricators, Inc. (the “Companies”), who were at least eighteen years old and had at least thirty days of service. The plan administrator controls and manages the operation and administration of the Plan. Great-West Trust Company, LLC (“Great-West”) serves as the trustee of the Plan (the “trustee”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Plan Status

Effective August 7, 2023, the Plan was terminated as a result of the closure of the Plan sponsor. In accordance with accounting principles generally accepted in the United States of America (“GAAP”), the Plan has changed its basis of accounting used to value the Plan assets from the ongoing basis to the liquidation basis as of August 7, 2023.

Contributions

Each year, participants could contribute up to 80% of annual compensation, as defined in the Plan, subject to Internal Revenue Code (“IRC”) limitations. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also make Roth after-tax contributions and could contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. For employees hired after April 1, 2015, upon becoming eligible to participate, an automatic 5% of compensation would be deferred on the eligible employee’s behalf until changed by the employee. If no alternative election was made, the automatic deferral would escalate at a rate of 1% each year, up to a maximum of 8%. The Companies made matching contributions equal to 100% of up to the first 3% of participant’s pre-tax annual compensation. The Companies’ Board of Directors could also elect to make a discretionary contribution to the Plan. No such election was made for the year ended December 31, 2024. Contributions were subject to certain limitations.

Investment Options

Participants could direct the investment of their accounts into various investment options offered by the Plan. The Plan offered mutual funds and a stable value collective trust fund as investment options for participants.

Participant Accounts

Each participant’s account was credited with the participant’s contributions and allocations of the Companies’ contributions, and Plan earnings (losses), and charged with benefit payments and allocations of administrative expenses. Allocations were based on participant earnings, or account balances, as defined. The benefit to which a participant was entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants were immediately vested in their contributions and the Companies' matching contributions plus actual earnings thereon for all Companies with the exception of Ellis, Style Craft and Sofa Express (former participating employers of the Plan). Former employees of Ellis and Style Craft who were participants in the Plan were fully vested as of April 1, 2015. Former employees of Sofa Express who were participants in the Plan were vested at a rate of 25% after two years of service, increasing 25% for each additional year of service. A participant was 100% vested after five years of service. Any former Sofa Connection employees with two years of credited service as of January 1, 2005 are vested at a rate of 50% after two and three years of service, 75% after four years of service, and 100% after five years of service. A participant was vested in the Companies' discretionary contribution plus actual earnings thereon at the rate of 25% after two years of service, increasing 25% for each additional year of service. A participant was 100% vested after five years of credited service.

All participants became 100% vested in their accounts as of August 7, 2023, the date the Plan was terminated.

Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the excess of the highest outstanding balance of loans from the Plan to the participant during the past 12 months, or 50% of their vested account balance. The loans were secured by the balance in the participant's account and bear interest at the Prime Rate published in the Wall Street Journal on the first business day of the month the loan is originated. At December 31, 2024, outstanding loans bore interest rates ranging from 3.25% to 8.50%. Principal and interest were paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant could elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or various installment options as provided by the Plan. For termination of service due to other reasons, a participant could receive the value of the vested interest in his or her account as a lump-sum distribution. Amounts contributed on a before-tax basis could only be withdrawn upon demonstration of financial hardship, disability, or after the participants reached the age of 59.5 years.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$69,349 and \$46,199, respectively. These accounts could be used to reduce Company contributions or pay administrative expenses. During 2024, forfeitures of \$39,488 were used to pay administrative expenses.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the liquidation basis of accounting in conformity with GAAP.

Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

Investments Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income on notes receivables from participants is recorded on the accrual basis. Other interest income is recorded when received. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded upon distribution.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Companies, as provided by the plan document. Certain administrative functions are performed by employees of the Companies. No such employee receives compensation from the plan. Expenses relating to specific participant transactions (notes receivable from participants and distributions) are charged directly to the participant's account.

Subsequent Events

The Plan has evaluated subsequent events through June 24, 2025, the date the financial statements were available to be issued.

As of May 2, 2025, all assets were liquidated from the Plan.

Note 3. Fair Value Measurements

Fair value, as defined under GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based upon the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of fair value assets and liabilities, and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

Stable Value Collective Trust Fund

The Plan invests in a stable value collective trust fund for which quoted prices are not available in active markets for identical instruments. The Plan utilizes the net asset value (“NAV”) per share provided by the trustee as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. The stable value collective trust fund is not required to be classified within a level on the fair value hierarchy.

Note 6. Tax Status

The Plan has not obtained a determination letter from the Internal Revenue Service (the “IRS”) stating that the Plan was in compliance with the applicable requirements of the IRC. The Plan is relying on IRS approval of the prototype standardized profit sharing plan with CODA that it is utilizing. The IRS has determined and informed the plan sponsor by a letter dated June 30, 2020, that the plan document was designed in accordance with the applicable sections of the IRC. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, the plan administrator believes that the plan was qualified and the related trust was tax exempt as of the financial statement date.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
