We have performed audits of the accompanying financial statements of SEED Beauty 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **NOTE 1 - DESCRIPTION OF THE PLAN**

SEED Beauty 401(k) Savings Plan (the "Plan") is a defined contribution plan covering substantially all employees of SEED Beauty LLC (the "Company"). The Plan was established on July 1, 2019 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The assets of the Plan are held in a trust by John Hancock Trust Company LLC.

THE PLAN DOCUMENT INCLUDES DETAILED RULES FOR EACH SITUATION. PARTICIPANTS AND OTHER INTERESTED PARTIES SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

**A. Eligibility**

Company employees, except for those covered by a collective bargaining agreement, nonresident aliens, and leased employees, are eligible to participate in the Plan after having completed three months of service and attaining age 21.

**B. Benefits**

Distributions of a participant's account are made upon termination of service, death, disability or retirement. Normal retirement age is 65. A participant or beneficiary may elect to receive a single lump-sum payment equal to the value of his or her vested interest in their account. Terminated participants with account balances of \$5,000 or less can be distributed whether or not requested. Additionally, an in-service distribution can also be made to participants who have attained the age of 59-1/2, upon disability or when experiencing financial hardship.

**C. Vesting**

Participants are immediately 100% vested in their account.

**D. Contributions**

Participants may contribute up to 100% of eligible compensation, as defined in the Plan, subject to Internal Revenue Code (IRC) limitations.

The Plan provides participants the option to elect pre-tax and/or Roth contributions.

The Plan calls for a Company safe harbor matching contribution equal to 100% of a participant's salary deferral up to 3% of eligible compensation plus 50% of a participant's salary deferral between 3% to 5% of compensation. Safe harbor Company matching contributions for the year ended December 31, 2024 were \$473,732.

**E. Notes Receivable from Participants**

The Plan allows participants to borrow not less than \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. A loan is secured by a participant's account balance, bears interest equal to 1% above the prime rate. The loan must be repaid to the Plan in five years unless the loan is used for the purchase of a principal residence, in which case the maximum repayment period is 15 years. The plan administrator establishes the specific terms and conditions of loans to participants.

**G. Administrative Expenses**

Some administrative expenses are paid by the Plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**B. Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

**C. Investment Valuation and Income Recognition**

The participants select how their share of plan assets will be invested among those investment vehicles made available.

GAAP requires additional disclosures about fair value measurement and establish a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1 measurements) and lowest priority to unobservable inputs (level 3 measurements).

The following are the major categories of assets and liabilities measured at fair value on a nonrecurring basis, using the following fair value hierarchy and related valuation methodologies:

Level 1 – Inputs are quoted prices in active markets.

Level 2 – Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

The following tables summarize the Plan's investments based on the inputs used to value them, at December 31:

Level 1 investments consist of mutual funds reported at fair value based on quoted market prices. The common/collective trust funds are value at net asset value. The objectives of the funds are to maintain safety and preservation of principal and accumulated interest. There are no restrictions on redemptions and no unfunded commitments to purchase additional shares of the common/collective trusts.

Interest and dividends are recorded on the accrual basis. Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend rate. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**D. Risks and Uncertainties**

Plan investments are exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the risk associated with investments, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and statement of changes in net assets available for benefits.

**NOTE 3 - INCOME TAX STATUS**

The Plan is based upon a Prototype Non-Standardized Profit Sharing Plan with CODA document that received an opinion letter dated June 30, 2020 from the Internal Revenue Service which stated that

the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The plan administrator believes that the Plan is currently being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 4 - PLAN TERMINATION**

Although it has not expressed an intent to do so, the Company has the right under the Plan to discontinue its contributions subject to the provisions of ERISA. In the event of Plan termination, Plan assets will be distributed to participants based upon the participants' account balances at the time.

**NOTE 5 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023, and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedule were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock Trust Company LLC, the trustee of the Plan.

**NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are issued or managed by the trustee or its affiliates. Transactions in these investments, while considered party-in-interest transactions under ERISA regulations, are permitted under provisions of the Plan and are specifically exempt from the prohibitions of party-in-interest transactions under ERISA.

**NOTE 7 - STABLE VALUE FUND**

The Plan maintains a fully benefit-responsive group annuity contract with New York Life Insurance Company ("New York Life"). The credited rates are determined in accordance with contract terms and are net of contributions made to the contract plus interest credited, plus dividends, and minus expenses withdrawn.

The value of the group annuity contracts that New York Life reports is at contract value. Contract value represents the amount participants would receive if they were to initiate a benefit-responsive transaction under the terms of the ongoing Plan. New York Life believes that it is reasonable to conclude that the Stable Fund meets the requirements for the fully benefit-responsive investment contracts and as such are shown at contract value.

The crediting rates are based on a formula established by New York Life, but may not be less than 0%. The crediting rates are reviewed on a monthly basis for resetting. The fund calculates the average yield and crediting rates as of December 31 of each year. The average yields were 4.00% and 3.66% and the crediting rates were 3.73% and 3.86% for the years ended December 31, 2024 and 2023, respectively.

**NOTE 8 - RECLASSIFICATION**

Certain balances from the 2023 financial statements year were reclassified to conform to the 2024 presentation. The reclassification had no effect on prior year net assets available for benefits.

**NOTE 9 - SUBSEQUENT EVENTS**

Management has evaluated subsequent events through October 2, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
