The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

### **1. DESCRIPTION OF PLAN**

The following description of the V Cruises US LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan was established effective January 1, 2015, and most recently restated effective January 1, 2021. The Plan is a defined contribution plan covering substantially all employees of V Cruises US LLC (the “Employer” or “Company”), except for employees whose employment is governed by a collective bargaining agreement, employees who are nonresident aliens who receive no earned income from sources within the United States, and other defined classes. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligible employees have completed 250 hours of service within 3 consecutive months from the initial date of employment and have attained age 21. Notwithstanding the foregoing, any eligible employee who has completed one year of service shall be deemed to have met the service requirement. Employees eligible to participate in the Plan can enroll in the Plan immediately on the day they satisfy the eligibility requirements.

#### **Contributions**

The Plan allows for both pre-tax and Roth elective salary deferrals. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Rollover contributions are subject to the terms of the Plan and are fully vested and non-forfeitable. The Company makes safe harbor nonelective contributions equal to 3% of each participant's eligible compensation, as defined. In addition, the Company may make discretionary matching contributions equal to a uniform percentage of a participant's elective deferrals, up to 6% of compensation. During the year ended December 31, 2024 the Company made safe harbor nonelective contributions and matching contributions of approximately \$1,703,000 and \$1,089,000, respectively, to the Plan. Contributions are subject to certain statutory limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and Company matching contributions, if any, as well as allocations of the Company's safe harbor nonelective contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined.

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their balances into various investment options offered by the Plan. If participants do not select an investment option, their accounts under the Plan are automatically invested in the Plan's Qualified Default Investment Alternative ("QDIA"), unless the employee elects otherwise. The Plan has elected the JPMorgan SmartRetirement Fund series as its QDIA.

#### **Vesting**

Participants are vested immediately in their contributions, the Company's matching contributions, and safe harbor non-elective contributions, plus actual earnings thereon.

#### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable from participants are secured by the balance in the participant's account. The loan interest rate, determined on the loan issue date, is set at 1% above the prime rate, as defined. The interest rate on outstanding loans at December 31, 2024 ranged from 4.25% to 9.50% per annum. Principal and interest is paid ratably through payroll deductions.

#### **Payment of Benefits**

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or a partial withdrawal. In-service distributions are available for participants who have attained age 59½ years of age or as hardship withdrawals, as defined by the Plan document.

#### **Suspense Account**

The Company uses its suspense accounts to reduce employer contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, suspense accounts totaled \$2 and \$2 respectively. During the year ended December 31, 2024, the Company did not use any funds from the Plan's suspense account to reduce employer contributions.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

#### **Contributions**

Contributions from Plan participants are recorded in the year in which the participant contributions are withheld from compensation. Employer contributions from the Company are based off compensation paid to the participants during the year.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are

charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net change in fair value of investments.

#### **3. CERTIFIED INFORMATION**

Certain information related to investments and unallocated cash disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments, at fair value, and unallocated cash held at December 31, 2024 and 2023, and net change in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank (the custodian of the Plan).

#### **4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### ***Mutual Funds***

Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are deemed to be actively traded.

#### ***Interest Bearing Cash***

Schwab Bank Savings is an FDIC insured interest bearing money market deposit account that is held for investment purposes. The fair value is the amount payable on demand at the reporting date.

#### **5. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS**

CMC Advisors, Inc. is the Plan's investment advisor, and therefore certain transactions qualify as exempt party-in-interest transactions. Fees of approximately \$50,000 were paid to CMC Advisors, Inc. from the Plan during the year ended December 31, 2024.

CMC Interactive, LLC is the Plan's third party administrator and recordkeeper and therefore certain transactions qualify as exempt party-in-interest transactions. Fees of approximately \$20,000 were paid to CMC Interactive, LLC from the Plan during the year ended December 31, 2024.

Participant contributions not transmitted by the Company within the time period set forth in the Department of Labor's regulation CFR 2510.3-102 are considered nonexempt prohibited transactions under ERISA. Participant contributions remitted during the period that constitute nonexempt prohibited transactions was reported by the Plan in the accompanying supplemental schedule as required.

#### **6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will remain 100% vested in their employer contributions.

#### **7. TAX STATUS**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **9. SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

In February 2025, the Company entered into agreements whereby Schwab Retirement Plan Services, Inc. and Charles Schwab Trust Bank became the recordkeeper and trustee of the Plan, respectively. In connection with this arrangement, the Plan's participant account records were transferred from CMC Interactive, LLC to Schwab Retirement Plan Services, Inc. during February 2025. Because Charles Schwab Trust Bank was the Plan's custodian prior to its appointment as trustee, there was no transfer of Plan assets in connection with this transaction.

Effective February 1, 2025, the Plan was restated on a pre-approved plan document designed by Schwab Retirement Plan Services, Inc.

On September 22, 2025, an amendment was signed to add Virgin Cruises Intermediate Limited, Inc. as an adopting employer of the Plan effective January 1, 2026.
