Opinion

We have audited the financial statements of the Colorado State Fraternal Order of Police Legal Defense Fund, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), which comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits (modified cash basis) for the years then ended, and the related notes to the financial statements.

Note 1. Description of the Fund

The following brief description of Colorado State Fraternal Order of Policy Legal Defense Fund (the Fund) is provided for general information purposes only. Members should refer to the Fund document for a more complete description of the Fund's provisions.

General

The Fund provides for payment of various legal fees for members of the Colorado State Fraternal Order of Police. In carrying out this function, the Fund collects contributions from the members (including a portion that is remitted to the national plan starting on January 1, 2010), verifies administrative claims for benefits submitted by members, and disburses funds to cover eligible claims. It is administered by the Colorado State Fraternal Order of Police Legal Defense Fund's Executive Committee and Board of Trustees.

Effective January 1, 2010, the Fund's civil and criminal claims are covered by the national plan. Administrative claims will continue to be covered by the Fund.

Cash

At December 31, 2024 and 2023, the Fund's cash accounts exceeded federally insured limits by approximately \$78,000 and \$610,000, respectively.

Investments

Investments are made up of multiple Certificates of Deposit (CDs) with maturity dates of three months or longer, and a mutual fund.

Contributions

Membership dues were at \$30.00 per month per sworn member to cover the legal fees and settlements as a result of Colorado Senate Bill 217. The dues remained at \$23.00 per month for non-sworn members who are not subject to SB 217. The Fund keeps a portion of the dues each month while the remaining dues are forwarded to national. Effective in June 2023, membership dues decreased from \$30.00 per month to \$25.00 per month.

Each member lodge collects and remits the dues to the Fund in monthly payments.

Investment Account Options

Contributions received from the members are left in cash or invested in various CDs and mutual funds at the discretion of the Board of Trustees until they are needed to pay claims.

Members' Benefits

The Fund, directly or through the national plan, pays costs for members in defense of duty-related criminal matters and civil lawsuits; however, in civil incidents where the employer of the member is providing the defense of the member, the Fund pays only for monitoring. All duty-related administrative actions are covered. Administrative actions resulting from non-duty related occurrences are covered. The Fund provides members up to 10 hours of legal service in a duty-related termination case. For any duty-related incident resulting in loss to a member of up to three days' pay, the committee may recommend reimbursement to the member for the loss of pay in lieu of defending the administrative action. The committee has the authority to challenge and deny payment for unreasonable, excessive, or unrelated charges, and may approve additional benefits to a member for a matter that may not meet all of the requirements to be a covered claim.

Payments of Benefits

The Fund has entered into verbal agreements with four legal firms. The agreements state that the agreed upon retainer payments will be made each month by the Fund and that the legal services performed during the period will be debited against the retainer payments at the rate of \$165 per hour for attorney time and \$85 per hour for paralegal time. No adjustment to the annual payments will be due unless the overage or underage of legal services provided exceeds 5%.

Fund Termination

In the event the Fund terminates, any and all monies and assets remaining in the Fund, after payment of expenses, shall be used for the continuance of the benefits provided by the then existing Fund until such monies and assets have been exhausted.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The Fund's accounts are maintained on a modified cash basis, which is known as the Comprehensive Basis of Accounting rather than under Generally Accepted Accounting Principles (GAAP). The statements of changes in net assets available for benefits reflects only cash received and disbursed. Therefore, receivables, payables, and accrued income and expenses, which would be recognized under accounting principles generally accepted in the United States of America, and which may be material in amount, are not recognized in the accompanying financial statements.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. The mutual fund is valued at the net asset value (NAV) of shares held by the Fund at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in the fair value of investments includes the Fund's gains and losses on investments bought and sold as well as held during the year.

Fund Tax Status

The Fund has not obtained a determination letter from the Internal Revenue Service regarding the Fund's tax status. However, the Fund administrator believes that the Fund is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

The Fund is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Payments of Benefits

Benefit payments are recorded upon distribution.

Note 3. Fund Benefit Obligations

The Fund pays approved plan lawyers on a retainer fee payment schedule. The retainer agreements with the approved lawyers are oral. Fund management sets a minimum retainer fee for each large firm but will pay more than the minimum depending on the expected services during that particular month. For the smaller firms, the retainer fee is equal to the monthly billable hours. This method was changed over the years as an attempt to reduce the Fund obligations. As a result of this change, the Fund obligations as of December 31, 2024 and 2023 are minimal.

Note 4. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Fund, any person who provides services to the Fund, an employer whose employees are covered by the Fund, an employee organization whose members are covered by the Fund, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Fund entered into an informal note receivable with the Colorado State Fraternal Order of Police, the Fund sponsor, during 2023. The Fund sponsor anticipates paying this balance back into the Fund, but there is no set maturity date. The note receivable balance was \$488,783 and \$514,072 as of December 31, 2024 and 2023, respectively, and interest income on related-party note receivable for the years ended December 31, 2024 and 2023 was \$20,736 and \$5,834, respectively.

The Fund paid \$36,000 for compensation and expense reimbursements to the president, secretary and treasurer during 2024 and 2023. In addition, the Fund had additional expenses of \$20,624 and \$12,289 during 2024 and 2023, respectively.

Note 5. Disclosures About Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Fund holds no Level 2 or Level 3 investments.

Certain immaterial revisions have been made to the 2023 financial statements to present the certificates of deposit as Level 2 within the fair value hierarchy. These revisions did not have a significant impact on the financial statement line items impacted.

Note 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7. Subsequent Events

Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.
