Opinion

We have audited the accompanying financial statements of VNU 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 DESCRIPTION OF PLAN

The following description of the VNU 403(b) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan is a defined contribution plan covering all employees of Village Northwest Unlimited (VNU or Plan Sponsor). VNU controls and manages the operation and administration of the Plan. Participants are eligible for VNU matching contributions after the completion of one year of service (and being credited with 1,000 hours or more). The Nationwide Financial Services, Inc. serves as the custodian of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to contribute a portion of their pre-tax annual compensation, as defined by the Plan, subject to certain Internal Revenue Code (IRC) limitations. Participants also have the option to contribute post-tax compensation through Roth contributions. VNU provides matching contributions based on the participants' elective deferrals. During 2024 and 2023, VNU matched \$0.40 per \$1.00 of participant deferrals, with a maximum total of \$1,000. VNU also has the option of making an additional discretionary contribution. No additional discretionary contributions were made during the years ended December 31, 2024 and 2023.

Rollover contributions are also allowed by the Plan.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, allocations of VNU's matching contributions, allocations of VNU's additional discretionary contributions, and Plan earnings net of administrative expenses paid by the Plan and is charged with withdrawals and fees applicable to early withdrawal, if any. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments

Upon enrollment in the Plan, a participant may direct contributions to funds held in variable annuity contracts offered by The Nationwide Financial Services, Inc. Participants may change their investment options at any time.

Vesting

Participants are immediately vested in their contributions, rollover contributions, VNU matching contributions, and VNU additional discretionary contributions plus actual earnings thereon.

Distribution of Benefits

Distributions may be made upon termination, death, disability, retirement, or in the case of a financial hardship as defined in the Plan. Normal retirement age is defined in the Plan as 60 years of age.

Accounts with balances not exceeding \$5,000 must be distributed in a single lump-sum payment. Accounts with balances exceeding \$5,000 may elect a single lump-sum payment or joint and survivor annuities for married participants, and life annuities for single participants.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for the funds held in variable annuity contracts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Administrative Expenses

Certain administrative functions are performed by officers or employees of VNU. No such officer or employee receives compensation from the Plan. The cost of such services has not been determined. Certain other administrative expenses are paid by the Plan.

Uncertain Tax Positions

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management has evaluated their material tax positions and determined there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Payment of Benefits

Benefit payments to participants are recorded upon distribution. There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan but have not yet been paid at December 31, 2024 or 2023.

NOTE 3 PLAN TERMINATION

Although it has not expressed any intention to do so, VNU has the right under the Plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

NOTE 4 FEDERAL INCOME TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (IRC). The Plan Administrator and the Plan's tax counsel believe that the terms of the Plan have been prepared to conform with the requirements of Section 403(b) of the IRC and that the Plan is currently being operated in conformity with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified.

NOTE 5 RISKS AND UNCERTAINTIES

Participants invest their account balances in various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 INVESTMENTS AND FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification (ASC) 820 are described as follows:

Level 1—Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2—Inputs other than quoted prices included within Level 1 that are observable for the asset, either directly or indirectly, such as:

- quoted prices for similar assets in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

Level 3—Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at December 31, 2024 and 2023.

Variable annuity contracts—Variable annuity contracts invest primarily in domestic and international long-term bonds, domestic and international stocks, or single mutual funds. The net asset value (NAV) is determined based on the market value of the underlying investments and other inputs such as the daily asset management charge. The NAV is not publicly quoted but is available to Plan participants when they access their account values via the custodian website.

NOTE 7 RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by The Nationwide Financial Services, Inc. (Nationwide). Nationwide is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Administrative expenses in the amount of \$14,607 and \$56,427 were paid to Nationwide, a party-in-interest, during the years ended December 31, 2024 and 2023, respectively. Administrative expenses in the amount of \$12,494 and \$17,845 were paid to Definiti LLC, the record keeper of the Plan, during the years ended December 31, 2024 and 2023, respectively. These transactions qualify as party-in-interest transactions.

The Plan trustee is currently a participant in the Plan.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 8 SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 14, 2025, the date which the financial statements were available to be issued. There were no subsequent events required to be accrued or disclosed.
