## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of  
G-A-P Supply Corp. 401(k) Cash or Deferred Savings Plan  
Tigard, Oregon

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of G-A-P Supply Corp. 401(k) Cash or Deferred Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE 1 – DESCRIPTION OF PLAN**

The following brief description of the G-A-P Supply Corp. 401(k) Cash or Deferred Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan maintained for the benefit of all eligible employees of G-A-P Supply Corp. d.b.a. Johnstone Supply of Tigard (the Company). Employees who are 18 years of age or older are eligible to participate in the Plan following three consecutive months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan Amendments** - Effective September 1, 2023, the Plan was amended to include Northwest HVAC and E.H. Arbuckle Distributing, Inc. dba Johnstone Supply as a participating employer in the Plan.

**Contributions** - Contributions consist of employee elective deferrals and discretionary matching contributions provided by the Company. Employee elective deferrals and the discretionary matching contributions are recorded in the year in which the employee contributions are withheld from compensation. Participants may voluntarily contribute up to 100% of eligible compensation, limited to \$23,000 and \$22,500 in 2024 and 2023, respectively, as prescribed by the Internal Revenue Code (IRC). Participants aged 50 and older may elect to make an additional catch-up contribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and will automatically escalate by 1% per year until the percentage reaches a maximum of 4% unless changed by the participant. Discretionary contributions, if any, shall be determined at the Company's discretion. For the years ending December 31, 2024 and 2023, the Company elected to make discretionary matching contributions equal to 50% of the first 6% of the participant's elective deferral, not to exceed 3% of the participant's eligible compensation. Contributions are subject to other limits under the IRC.

**Participant Accounts** - A separate account is maintained for each participant, which is credited with the participant's contributions, the Company's contributions, and an allocation of Plan earnings and expenses. Allocation of Plan earnings is based upon participant account balances. Allocation of matching contributions is based on a percentage of each employee's elective deferral. The benefit to which a participant is entitled is the vested amount in their individual account.

**Vesting** - Participants are immediately vested in their voluntary contributions and actual earnings thereon. Vesting in the Company contributions is based on years of service with increases of 20% per year after two years until fully vested after six years of credited service.

**Expenses** - Administrative expenses may be paid by the Company. Expenses not paid by the Company are allocated to participant's accounts based on account balances. Expenses of plan administration, including computer services, office supplies and payroll expenses of administrative and clerical personnel are provided by the Company without charge to the Plan. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

**Payment of Benefits** - On termination of service due to death, disability, or retirement, a participant may be paid a lump-sum amount equal to the value of the participant's account balance. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**Forfeitures** - Forfeitures are the non-vested portion of a participant's account that are lost upon termination of employment. The balance of the forfeited accounts amounted to \$383 and \$24,375 at December 31, 2024 and 2023, respectively. The forfeited amounts may be used to pay Plan expenses or to reduce future employer contributions. Forfeitures in the amount of \$13,325 and \$0 were used to pay plan expenses for the years ended December 31, 2024 and 2023. Forfeitures in the amount of \$52,719 and \$14,459 were used to reduce employer matching contributions in the years ended December 31, 2024 and 2023, respectively.

## **NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting** - The financial statements of the Plan are prepared under the accrual method of accounting.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year and management and operating expenses associated with the Plan's investments.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Benefit Payments** - Benefits are recorded when paid. Accordingly, benefits payable to persons that have elected to withdraw from the Plan but are not yet paid at year-end have not been accrued. At December 31, 2024 and 2023, there were no amounts payable to participants.

**Subsequent Events** - The Plan’s management has performed an evaluation of subsequent events through October 13, 2025, which is the date these financial statements were available to be issued.

**NOTE 3 – INFORMATION CERTIFIED BY THE CUSTODIAN OF THE PLAN**

The following is a summary of the comparative unaudited information regarding the Plan, included in the Plan’s financial statements and supplemental schedules, that was certified by the custodian of the Plan, Charles Schwab Trust Bank as of and for the years ended December 31, 2024 and 2023 and furnished to the plan administrator. The plan administrator has obtained certifications from the custodian that such information is complete and accurate.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

**Basis of Fair Value Measurement**

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access at the measurement date.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trust fund:* The Plan holds investments in the Morley Stable Value Fund, a common/collective trust fund (the "CCT") that is comprised primarily of fully benefit-responsive investment contracts. Principal Global Investors Trust Company, formerly Union Bond & Trust Company, is the trustee of the CCT. The objective of the CCT is to provide a diversified group of investments offering competitive levels of yield consistent with a stable fixed income methodology and the careful and prudent assumption of investment risk providing for preservation of capital stability and predictability of returns, liquidity to pay plan benefits and high credit quality. The CCT invests in other conventional, synthetic and separate account investments contracts issued by life insurance companies, banks, and other financial institutions that invest in a portfolio of securities, primarily equity securities, money market funds and US treasuries. Units in the CCT are valued based on the underlying investments, the majority of which are based on quoted prices. The NAV provided by the trustee is used as a practical expedient to estimate fair value. Units in common collective trust funds are not publicly traded, but rather, are redeemable only by the issuer. The value of the Plan's investment in common collective trust funds represents the value of the Plan's interests in the overall value of the CCT. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the CCT, the investment advisor reserves the right to temporarily delay withdrawal to ensure that securities liquidation will be carried out in an orderly business manner. Investments in common collective trust funds can generally be redeemed without restriction; however, in certain cases, redemption or purchase may be limited to prevent excess and/or short-term trading. In addition, if a fund experiences periods of insufficient liquidity, then the fund may defer honoring any payment request until liquidity is sufficient.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **NOTE 5 – NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow from their vested account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a fixed rate of interest of 1% above the prime rate at the time the loan is made. The maximum loan term is five years unless the loan qualifies as a home loan, in which case the term of the loan is not to exceed 10 years. Interest rates on all outstanding loans ranged from 5.50% to 8.50% at December 31, 2024 and mature through November 2029.

#### **NOTE 6 – CONCENTRATIONS, RISKS AND UNCERTAINTIES**

The Plan provides for investments that are exposed to various risks. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits, and therefore participants' account balances. There were two investments that individually represented more than 10% of the investments held as of December 31, 2024 and 2023, respectively. See the Supplemental Schedule of Assets (Held at End of Year) for the complete listing of investments held as of that date.

#### **NOTE 7 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Charles Schwab Retirement Plan Services, Inc. is the recordkeeper and Charles Schwab Trust Bank is the custodian of the Plan. Investment management and recordkeeper administrative fees paid to Charles Schwab Trust Bank and/or an affiliate of the custodian amounted to \$32,788 and \$22,565 in 2024 and 2023, respectively. As Charles Schwab Trust Bank is the custodian of the Plan these transactions qualify as party-in-interest transactions. In addition, the plan administrator is a participant in the Plan.

#### **NOTE 8 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Upon termination, the Company may continue the Plan to pay benefits as they mature or liquidate and distribute the relevant portion of the Plan to a successor defined contribution plan, or in the absence of a successor plan, to the participants. Net assets transferred or distributed shall be allocated to participants in proportion to their interests.

#### **NOTE 9 – INCOME TAX STATUS**

The Plan is an adoption of a prototype non-standardized profit sharing plan sponsored by Schwab Retirement Plan Services, Inc. The Plan document obtained its latest opinion letter on September 21, 2020, in which the Internal Revenue Service stated that the plan document, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however; there are currently no audits for any tax periods in progress.

#### **NOTE 10 – PROHIBITED TRANSACTIONS**

During 2024 and 2023, elective deferrals and loan repayments withheld from employee's payroll totaling \$90 and \$39,048, respectively, were not remitted to the Plan within the appropriate time period required by the Department of Labor. These transactions constitute prohibited transactions as defined by ERISA. The Company is aware of the occurrences and has taken the appropriate steps to correct \$38,491 of these amounts from 2023, and is in the process of taking the appropriate steps to fully correct the remaining 2024 and 2023 occurrences.
