Note 1 – Description of Plan

The following description of Diamond Drugs, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The plan, established on June 21, 1996, is a defined contribution plan covering all full-time employees and part-time employees who work a regular schedule for Diamond Drugs, Inc., Remedy Repack, Inc., SapphireHealth, LLC and InnovaHealth, LLC (collectively referred to as the “Company”) who have completed six months of service and are age twenty-one or older. The plan is administered by the Company Lincoln Financial Group Trust Company, Inc. serves as the custodian of the assets of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Eligible employees may elect to contribute up to 100% of their compensation into the Plan with a maximum of \$23,000 in 2024 and \$22,500 in 2023. Participants who are at least 50 years of age are permitted to make “catch-up” contributions. The maximum allowed “catch-up” contribution is \$7,500 in 2024 and \$7,500 in 2023. The Company may also make matching contributions at the discretion of the Board of Directors. The Company’s matching contribution for the 2024 plan year was \$685,877, and was \$630,468 for the 2023 plan year.

Funding Policy

The Company shall, with the time period and manner permitted by the Internal Revenue Code, remit to the trustee an amount equal to the elective deferral contributions and the Company matching contribution.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Company contribution and Plan earnings. Company contributions are allocated to participants based upon participant earnings, as defined by the Plan.

Vesting

Participant contributions, plus actual earnings thereon vest immediately. Vesting in the Company’s contributions plus actual earnings thereon, is determined on the basis of years of service. A participant is fully vested after five years of credited service. Full vesting is automatic when certain other circumstances as defined in the Plan, principally the death or disability of the participant, occur.

Investment Options

A participant may direct contributions to a broad range of diversified investment options through the Plan’s trustee.

Payment of Benefits

On termination of service, a participant receives a lump-sum distribution equal to the value of the participant's vested interest in his or her account. In addition, a participant may withdraw funds, subject to Plan restrictions, in the event of a financial hardship.

Forfeited Amounts

At December 31, 2024 and 2023 forfeited nonvested accounts totaled \$107 and \$4,554, respectively. Forfeited amounts were used to reduce Company matching contributions or to reduce plan expense.

Plan Termination

Although the Company has not expressed any intent to terminate the Plan, it reserves the right to do so at any time subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 2 – Summary of Significant Accounting Policies

Accrual Basis of Accounting

The Plan's management policy is to prepare the Plan's financial statement on the accrual basis of accounting in accordance with U.S. Generally Accepted Accounting Principles.

Investments held by a defined contribution plan are reported at fair value, except for fully benefit responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan that is attributable to fully benefit responsive investment contracts. The contract value is the amount a participant would receive if they were to initiate permitted transactions

Investment Valuation

The Plan's investments are stated at fair value, except for fully benefit responsive investment contracts which are recorded at cost. Fair value is the price that would be received in the sale of an asset or paid in a transfer of a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as appreciation in investments held during the year.

Payment of Benefits

Benefits are recorded as an expense when paid. Benefits paid to participants during the year were \$1,112,980.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Subsequent Events

Management has evaluated subsequent events through October 10, 2025 which was the date of the financial statements were issued.

Note 3 – Tax Status

Diamond Drugs, Inc. has obtained a determination letter from the Internal Revenue Service dated March 31, 2014, that informed the administrator that the Plan was designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan was restated for provisions required by the Pension Protection Act since receiving the determination letter. However, the Plan administrator, Trustee, and the Plan's legal counsel believe that the Plan is designed and is currently being operated in compliance with applicable provisions of the IRC and therefore believe that the Plan is qualified, and the related trust is tax exempt. Effective January 1, 2022, the Plan was restated to conform to the CARES act.

Note 4 – Excess Employee Contributions Payable

Contributions received from participants for 2024 and 2023 exceeded the amount allowable under prescribed statutory nondiscrimination provisions of the Plan by \$85,913 and \$108,279, respectively. The excess contribution amounts along with applicable plan earnings were distributed to certain active participants in the Plan on or before March 15, 2025 and March 15, 2024, respectively. These amounts are included in the Plan's Statement of Net Assets Available for Benefits as excess employee contributions payable at December 31, 2024 and 2023.

Note 5 – Information Provided by Custodian

Lincoln Financial Group Trust Company, Inc. held the Plan assets and executed transaction therein. The plan administrator has elected the method of compliance by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Lincoln Financial Group Trust Company, Inc. has provided the trustee with certified statements regarding the assets held by it for the years ended December 31, 2024 and 2023, and the executed transactions, income and expense items for the schedules of investments and reportable transactions for the years ended December 31, 2024.

Note 6 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

Note 7 – Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification 820, Fair Value Measurements and Disclosures provides the framework for measuring fair value. The framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of fair value hierarchy are:

- Level 1 – Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access;
- Level 2 – Inputs to the valuation methodology include items such as quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data through correlation or other means;
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 8 – Guaranteed Investment Contract

The Plan entered into a fully benefit responsive guaranteed investment contract with Lincoln Financial Group Trust Company (Lincoln). Lincoln maintains the contributions in a general account which is credited with earnings on the underlying investments, and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified guaranteed interest rate.

The guaranteed investment contract meets the fully benefit responsive investment contract criteria, and therefore, is reported at contract value. Contract value is the relevant measure for fully benefit responsive investment contracts because it will be the amount received by participants if they were to initiate permitted transactions under the Plan. Contract value represents contributions made under the contract, plus earnings and less participant withdrawals and administration expenses. Participants will ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include amendments to the Plan documents, changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the Plan sponsor or other Plan sponsor events, or failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are probable of not occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 9 – Excess Employee Contributions Payable

Contributions received from participants for 2024 and 2023 exceed the amount allowable under prescribed statutory nondiscrimination provision of the Plan by \$85,913 and \$108,279 respectively. These amounts are included in the Plan's Statements of Net Assets Available for Benefits as excess employee contributions payable at year end.

Note 10 – Party In Interest Transaction

Certain Plan investments are managed by Lincoln Financial group Trust Company, Inc. Lincoln Financial Group is the custodian as defined by the Plan, and therefore these transactions qualify as party in interest transactions. Case Sabatini & Company is the Plan auditor and qualifies as a party in interest.
