### NOTE 1. PLAN DESCRIPTION

The following description of the Oaktree Capital Management, L.P. 401(k) Savings Plan (the Plan) provides only general information. Participants and other interested parties should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering eligible employees who have been employed by Oaktree Capital Management, L.P. (the Partnership and the Plan Sponsor) and certain affiliates. Eligible employees may enter the Plan on the first day of the month coincident with or next following their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2021, the separate deferral election provided for bonuses will not apply to participant compensation pursuant to the Plan Sponsor long term incentive plan.

Effective April 1, 2021, a participant may commence elective deferral as soon as administratively practical after the election is made. In addition, an employee hired or rehired after March 1, 2021 and becomes eligible to participate after April 1, 2021 and who does not make elective deferrals is automatically enrolled to make pre-tax deferral equal to 3% of their compensation.

**Contributions:** Each year, participants may make pretax and Roth deferrals up to 75 percent of their annual compensation, as defined in the Plan and subject to certain limitations under the Internal Revenue Code (IRC). For the year ended December 31, 2024, the maximum compensation deferral was \$23,000. Participants who have attained age 50 before the end of the Plan year are eligible to make an additional \$7,500 in catch-up contributions for the year ended December 31, 2024. Participants may also contribute amounts representing distributions from other eligible retirement plans, as defined in the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan.

Effective January 1, 2019, the Plan was amended to add Partnership matching contributions equal to the lesser of (1) 100 percent of the participant's deferral amount and (2) three percent of eligible compensation, on a payroll period basis.

Effective January 1, 2022, a participant may elect to contribute to the Plan for each payroll period: (a) an amount equal to a whole percentage between 1% and 75% (inclusive) of the compensation during such payroll period or (b) a specified dollar amount, as an after-tax contribution. A Participant may make a separate election with respect to up to 100% of any compensation paid in the form of a bonus in the Plan Year provided, however, a participant may make Elective Deferrals on Compensation up to \$200,000 in a Plan Year. Participants may also elect to withdraw all or any portion of their after-tax contribution accounts.

**Forfeitures:** Forfeitures arise from a participant's termination of employment prior to vesting in Partnership matching contributions and may be used to reduce future Partnership contributions or to pay Plan administrative expenses. During the year ended December 31, 2024, forfeitures, totaling \$123,375 were utilized. As of December 31, 2024 and 2023, forfeitures of \$208,124 and \$174,437, respectively are available for future use.

**Vesting:** Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Partnership's matching contribution is based on years of service.

The vesting schedule of the Partnership matching contributions is as follows:

Years of Credited Service	Vesting Percentage
Less than 1	0%
At least one, but less than two	34%
At least two, but less than three	67%
Three or more	100%

While still employed with the Partnership, if a participant becomes disabled, dies, or reaches normal retirement age, the participant becomes 100% vested.

**Participant Accounts:** Each participant's account is credited with the participant's contributions and Partnership matching contributions as well as allocations of Plan earnings and charged with any withdrawals or distributions requested by the participant, investment losses, and allocation of administrative expenses, if applicable. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Payment of Benefits:** Upon retirement, death, disability, or other termination of employment, a participant or beneficiary is entitled to receive the value of the participant's vested account balance, which may be paid as a lump-sum distribution or in installment payments, as elected by the participant.

### NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting:** The accompanying financial statements have been prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America, primarily from information provided by Vanguard Fiduciary Trust Company (the Trustee and Vanguard).

**Estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income (loss) Recognition:** The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Investments are valued daily. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Benefits Payable to Participants:** Benefits are recorded when paid.

**Subsequent Events:** The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued and has determined that no other events or transactions require recognition or disclosure in these financial statements.

**Administrative Expenses:** The Plan's administrative expenses are paid by either the Plan or Plan Sponsor, as provided by the Plan document. Expenses directly attributable to a particular participant are allocated to and paid from that participant's account. In addition, investment options have fees which reduce the overall return on assets. The net appreciation of investments is inclusive of these fees.

**Fair Value:** The Plan accounts for its financial instruments using a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value measurement hierarchy is based on three levels of inputs, of which the first two are considered observable and the last unobservable.

The three levels of the fair value hierarchy are the following:

- *Level 1* Inputs to the valuation methodology that are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- *Level 2* Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in markets that are inactive; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- *Level 3* Inputs to the valuation that are unobservable and significant to the fair value measurement.

A financial instrument's categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual Funds* - This category consists of publicly traded funds of registered investment companies. The net asset value (NAV) of the mutual fund's shares is quoted on the exchange where the fund is traded and therefore classified as Level 1 within the valuation hierarchy.

*Money Market Fund* - Valued at the closing price reported by the fund's manager from an actively traded exchange and therefore classified as Level 1 within the valuation hierarchy.

*Common/collective Trusts* - Vanguard Retirement Savings Trust III - The Vanguard Retirement Savings Trust III (Savings Trust) is held in a common/collective trust (CCT), is valued at the NAV of units of a bank collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The Savings Trust does not have any unfunded commitments relating to its investments, or any significant restrictions on redemptions. Participant-directed redemptions can be made on any business day and do not have a redemption notice period.

*Self-Directed Brokerage Fund* - Investments held in the self-directed brokerage accounts consist of mutual funds, common stocks, cash and cash equivalents, interest-bearing cash, U.S. Treasury bills, unit investment trusts, certificates of deposit, and other financial instruments. Mutual funds, common stocks, unit investment trusts, interest-bearing cash, and U.S. Treasury bills are valued at their quoted market prices on active exchanges and are therefore classified as Level 1 within the valuation hierarchy. Investments in certificates of deposit are valued at the net asset value per share or unit, multiplied by the number of shares or units held as of the measurement date, and are classified as Level 2 within the valuation hierarchy.

### **NOTE 3. FINANCIAL DATA CERTIFIED BY THE TRUSTEE**

The Plan's investment assets as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, were obtained by management, and agreed to or derived from information certified by Vanguard Fiduciary Trust Company (Vanguard), the trustee of the Plan. The Plan Administrator has obtained certifications from the trustee that information provided to the Plan Administrator by the trustee related to the investment assets is complete and accurate. Accordingly, as permitted by Section 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the Plan's investment assets which appear throughout the financial statements and ERISA-required supplemental schedule.

### **NOTE 4. NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 less the highest outstanding loan balance during the prior 12 months or 50 percent of their vested account balance. The loan interest rate is set at one percent above the prime rate, as defined in the Plan. The loans are stated at the unpaid principal amount and are secured by the balance in the participant's account. Principal and interest are paid ratably through payroll deductions.

### **NOTE 5. PLAN TERMINATION**

The Partnership has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. Upon termination of the Plan, the participants' accounts in the Plan would become fully vested and distributed to them.

### **NOTE 6. TAX STATUS**

The Plan obtained a favorable determination letter dated February 7, 2018, in which the Internal Revenue Service (IRS) stated that the Plan is in compliance with the applicable requirements of the IRC. Although the Plan has been amended since the date of the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan's policy is to recognize tax positions in the financial statements when it is more-likely-than-not the position will be sustained upon examination by the tax authorities. As of December 31, 2024, the Plan had no uncertain tax positions that qualify for either recognition or disclosure in the financial statements. As of December 31, 2024, the Plan's annual tax filings for the prior three (3) years are open for audit by the IRS.

### **NOTE 7. PARTY-IN-INTEREST TRANSACTIONS**

The Plan investments are held by Vanguard. Transactions with Vanguard qualify as party-in-interest transactions for which exemptions exist. Vanguard received \$250,027 for loan administration and recordkeeping fees with the remaining amount paid by the participants through the Plan. Vanguard also received indirect compensation. SageView Advisory Group, LLC is an investment consultant to the Plan. SageView Advisory Group, LLC received \$128,750 for services during the year ended December 31, 2024.

### **NOTE 8. RISKS AND UNCERTAINTIES**

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility. The Plan's exposure to credit loss in the event of nonperformance of investments is limited to the carrying value of such investments. The Plan's provisions as well as those of ERISA and the participants' investment preferences dictate the Plan's concentrations of credit risk and market risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

### **NOTE 9. PLAN AMENDMENTS**

The Coronavirus Aid, Relief, and Economic Security Act (CARES Act) was signed into law on March 27, 2020. During the year ended December 31, 2020, the Plan Sponsor elected to operate the Plan to allow the optional provisions of the CARES Act immediately upon enactment. The Plan Sponsor has until December 31, 2025, to formally amend the Plan to retroactively include the provisions of the CARES Act.

Effective January 9, 2023, the Plan was amended to add a Self-Directed Brokerage Option. This feature allows participants to direct a portion of their accounts through a brokerage window and invest in a broad range of securities, including mutual funds, publicly traded common stocks, cash equivalents, U.S. Treasury bills, unit investment trusts, and certificates of deposit.

Effective July 5, 2023, the Plan Sponsor amended the Plan to permit installment payments as an elected form of distribution.
