Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Honsador Holding LLC Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

1. Description of Plan

The following description of Honsador Holding LLC Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

a. General

The Plan is a defined contribution plan covering eligible employees of Honsador Holding LLC and its subsidiaries (the Company, Plan Administrator or Plan Sponsor). The Plan provides for retirement, death and disability benefits, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). American United Life Insurance Company (AUL) was the Plan's custodian through December 5, 2024. The Plan was amended and restated as of December 6, 2024 and VOYA Institutional Trust Company became the trustee and custodian.

b. Eligibility

Employees are eligible to make salary deferrals on the first day of the month following their completion of 30 days of employment. Non-bargaining employees become eligible for participation in employer matching contributions and profit-sharing contributions as of the first day of the month following the later of the date employees complete one year of service and have attained age 20. Bargaining employees become eligible to participate in profit sharing contributions as of the first day of the month following the date employees complete 30 to 90 days of service, as defined in the Plan.

c. Contributions

The Plan provides for voluntary participant deferrals and discretionary employer profit sharing contributions, not to exceed amounts allowable under the Internal Revenue Code (IRC). Profit sharing contributions are determined annually by the Plan Sponsor and are allocated to eligible participants in the same proportion that each such participant's compensation for the year bears to the total compensation of eligible Plan participants. The profit sharing contribution related to participants from Alpha Supply LLC (Alpha), a subsidiary of the Company, is allocated separately from the allocation of all other participants. In accordance with a collective bargaining agreement, the Plan also provides for agreed-upon employer contributions per compensable hour to employees who are members of the bargaining unit.

1. Description of Plan (continued)

d. Allocation of Earnings, Losses and Plan Expenses

Earnings and losses from the Plan's participant-directed investments, as well as Plan expenses, are allocated to participants' accounts on a daily basis in proportion to the balances of such accounts.

e. Vesting

Participant deferrals and employer contributions related to a collective bargaining agreement, plus earnings thereon, are fully vested upon deposit; profit sharing contributions, plus earnings thereon, become fully vested after 5 years of service for all participants, as defined. Funds rolled over from other qualified plans are fully vested upon deposit. A participant becomes fully vested upon death, permanent disability or attainment of normal retirement age, as defined.

f. Notes Receivable from Participants

Promissory notes receivable from Plan participants are carried at their unpaid principal balances. Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loans are secured by the vested interest in the related participant's account and bear interest at a commercially reasonable rate and are to be repaid over a reasonable period of time not to exceed five years unless the loan is used to acquire a participant's principal residence, in which case the loan term can be extended up to 30 years. Interest rates ranged from 5.25 to 8.50 percent at December 31, 2024. The notes mature at various dates through July 2033.

g. Payment of Benefits

Upon termination of service, participants with vested account balances less than or equal to \$5,000 will be paid a lump sum distribution. When vested account balances exceed \$5,000 and services terminate due to death, the participant's designated beneficiaries will be paid a lump sum distribution. Upon meeting certain age requirements, participants may receive a lump sum distribution of their vested account balance, as defined in the Plan.

h. Forfeitures

The portion of a terminating participant's account that is not vested is considered a forfeiture. Forfeitures are first used to offset Plan expenses and any remaining amounts are allocated to reduce employer contributions.

h. Forfeitures (continued)

As of December 31, 2024 and 2023, approximately nil and \$14,500, respectively, were available to offset Plan expenses or allocate to remaining eligible participant account balances. During 2024, there were approximately \$18,000 of forfeitures. Approximately \$3,800 was used to offset employer contributions during 2024.

i. Administrative Expenses

Administrative expenses of the Plan are recorded when incurred and paid by the Plan to the extent permitted under ERISA. To the extent any expenses of the Plan are not paid from Plan assets, the Plan Sponsor or its subsidiaries pay such expenses. Investment-related expenses are included in net appreciation of fair value of investments.

2. Summary of Significant Accounting Policies

a. Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

b. Management's Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

c. Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Profit Sharing Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

d. Contributions

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation. Employer contributions are based on the same compensation.

e. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan document.

f. Payment of Benefits

Benefits are recorded when paid.

g. Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued and it was determined that all subsequent events had been properly accounted for.

Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedule related to the following assets:

4. Fair Value Measurements

U.S. GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

In accordance with Accounting Standards Codification Topic 820, pooled separate accounts that are measured at net asset value per share (or its equivalent) are not classified in the fair value hierarchy. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of each fund's underlying investments. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The fair value of the pooled separate accounts amounted to \$13,431,268 at December 31, 2023. There were no unfunded commitments, the redemption frequency was daily, and redemption notice period was 30 days.

4. Fair Value Measurements (continued)

The fair value of mutual fund accounts amounted to \$14,984,364 at December 31, 2024.

Following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used as of December 31, 2024 and 2023.

Pooled separate accounts – Plan assets are represented by a unit of account and a per unit value whose value is a result of the accumulated value of underlying investments. The underlying investments include mutual funds. Mutual funds are valued at the closing price reported on the active market on which the individual securities are traded.

Mutual fund accounts - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Guaranteed Investment Contract

The Plan invested in a group annuity contract, American United Life Stable Value Account (the Stable Value Account), with AUL. The Stable Value Account met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value was the relevant measure for fully benefit-responsive investment contracts because this was the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represented contributions made under the Stable Value Account, plus earnings, less participant withdrawals, and administrative expenses. Payment obligations under the Stable Value Account represented a claim supported by all the general assets of AUL. Deposits made to the Stable Value Account were deposited in AUL's general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The interest crediting rate is determined on a quarterly basis and is calculated based upon many factors, including current economic and market conditions, the general interest rate environment, and purchases and redemptions by unit holders. The average market yield earned by the Stable Value Account, which is also the actual interest credited to participants in the Stable Value Account, was approximately 1.50 percent and 1.72 percent for the years ended December 31, 2024 and 2023, respectively.

The credit rating of the issuer at December 31, 2023 was A+ as reported by A.M. Best Rating Services. There were no reserves against contract value for credit risk of AUL or otherwise.

6. **Plan Termination**

Although it has not expressed any intentions to do so, the Plan Sponsor has the right under the Plan to amend or terminate the Plan subject to the provisions set forth in ERISA. Upon termination of the Plan, all participant accounts become fully vested.

7 **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Tax Status

The Plan utilizes a non-standardized pre-approved plan sponsored by VOYA. The Plan has received an opinion letter dated June 30, 2020 from the Internal Revenue Service (IRS) as to the non-standardized pre-approved plan's qualified status. The Plan has been amended since receiving the opinion letter. The opinion has been relied upon by the Plan. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan years from December 31, 2021 are open for examination for federal tax purposes.

9. Exempt Party-in-Interest Transactions

Plan investments include mutual funds managed by Voya. Voya is the trustee and custodian of the Plan and, therefore, these transactions constitute exempt party-in-interest transactions. Participant loans are also considered exempt party-in-interest transactions.
