### Report on the Audit of the Financial Statements

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Mayer Electric Supply Company, Inc. Associates Capital Accumulation Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Mayer Electric Supply Company, Inc. Associates Capital Accumulation Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

#### **Opinion**

## **Note 1 – Description of Plan**

The following description of the Mayer Electric Supply Company, Inc. Associates Capital Accumulation Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of Plan provisions.

In September 2022, the Board of Directors approved freezing the Plan effective December 31, 2022, so that employees will be able to participate in the Rexel USA Inc. Section 401(k) Savings Plan (the Rexel Plan) following Rexel USA, Inc.'s acquisition of Mayer Electric Supply Company, Inc. in November 2021.

The Plan has applied for the Voluntary Correction Program (VCP) with the IRS and has received the compliance statement regarding the VCP in 2025. This indicates that the IRS has given its approval regarding the corrective actions and changes to administrative procedures described in the statement. The Plan was merged into the Rexel Plan on October 9, 2025.

**General** – Prior to December 31, 2022, the Plan was a 401(k) salary deferral and profit sharing plan covering substantially all employees of Mayer Electric Supply Company, Inc, and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Mayer Electric Supply Company, Inc. (the Company) is the Plan's sponsor and serves as Plan administrator.

**Eligibility** – Prior to December 31, 2022, employees of the Company were eligible to participate in the elective deferral portion and Plan upon reaching age 21 and after completing 30 days of service. Participants, upon reaching the age of 21, must be employed as of the last day of the Plan year, to be eligible to receive any employer paid profit sharing contributions.

## **Contributions**

*Participant contributions* – Prior to December 31, 2022, participants could contribute between 1% and 100% of pretax annual compensation, as defined in the Plan, each year. Participants could also elect to make Roth contributions utilizing after-tax contributions. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 4% of eligible compensation and their contributions invested in a designated fund until elected otherwise by the participant. Unless elected otherwise by the participant, pretax deferrals were automatically increased annually by 1%, up to a maximum auto-deferral of 10%.

*Employer match and profit-sharing contributions* – Prior to December 31, 2022, the Company could elect to make discretionary matching and profit-sharing contributions to the Plan. The amount of the matching contributions was based on a sliding scale formula, which uses Company profits and return on investments. Profit-sharing contributions, made at the option of the Company's Board of Directors, were allocated to participants in the same proportion as a participant's compensation bears to the total of all participants' compensation.

Contributions were subject to regulatory limitations.

**Participant accounts** – Prior to December 31, 2022, each participant’s account was credited with the participant’s contributions as well as allocations of the Company’s contributions. Each participant’s account is credited with Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants direct the investment of their account into various investment options offered by the Plan.

**Vesting** – Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of continuous service. Effective December 31, 2022, all participants were 100% vested.

**Notes receivable from participants** – Prior to December 31, 2022, participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were issued by the Plan and secured by the balance in the participant’s account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within a reasonable period of time not to exceed 20 years. Under the terms of the Plan agreement, plan loans will bear a reasonable rate of interest determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions. As of December 31, 2024, the rates of interest on outstanding loans ranged from 4.25% to 9.75%, with various maturities through July 2043.

**Payment of benefits** – On termination of service due to death, disability, or retirement, a participant (or beneficiary) may elect to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Upon termination, vested account balances that do not exceed \$5,000 are automatically distributed to the participant as soon as administratively possible. Additionally, the Plan allows for hardship withdrawals.

**Forfeitures** – Forfeitures are the nonvested portion of a participant’s account that are lost upon termination of employment. Forfeitures are retained in the Plan, must be used in the subsequent year, and may be used to pay the reduce Company contributions or pay Plan’s administrative expenses. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,009 and \$604, respectively. For the year ended December 31, 2024, no forfeitures were used to offset expenses.

**Note 2 – Summary of Significant Accounting Policies**

**Basis of accounting** – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

**Use of estimates** – The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment valuation** – The investments are reported at fair value and contract value. As of December 31, 2024, the Plan’s trustee, T. Rowe Price Group, Inc., certifies the contract value of the guaranteed income account and the fair value of all other investments. For the year ended December 31, 2023, the Plan’s trustee, Prudential Bank & Trust, FSB Company, certified the contract value of the guaranteed income account and the fair value of all other investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the “exit price”) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Contract value is the relevant measurement for assets invested in fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

**Income recognition** – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

**Contributions** – Prior to December 31, 2022, contributions from participants and corresponding matching contributions were recorded in the year in which the employee contributions are withheld from compensation.

**Notes receivable from participants** – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Agreement. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**Payment of benefits** – Benefits are recorded when paid.

**Expenses** – The Plan’s administrative expenses may be paid out of the forfeiture account or paid by the Company. Investment management, distribution, and loan transaction fees are paid by the Plan participants.

**Subsequent events** – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan’s financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits, but arose after the statement of net assets available for benefits date, and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued.

**Note 3 – Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

*Registered investment companies (mutual funds)* – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

*Self-directed brokerage accounts* – Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding.

*Collective trusts* – Units held in collective trusts (CTs) are valued using the net asset value practical expedient (NAV practical expedient) of the CTs as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CTs, minus its liabilities, and then divided by the number of units outstanding. The CT can be redeemed daily, and there are no redemption restrictions or notice requirements.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

The Plan administrator evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits.

**Note 4 – Guaranteed Income Fund**

The Plan entered into a fully benefit-responsive investment contract (FBRIC) with Prudential Retirement Insurance and Annuity Company (Prudential) which was acquired by Empower Annuity Insurance Company of America (Empower). Prudential and Empower maintain the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The FBRIC does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the FBRIC criteria and is therefore reported at contract value. Contract value is the relevant measure for FBRICs because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Prudential and Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations, which may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

During the year ended December 31, 2024, the Plan Sponsor has appointed T. Rowe Price Group, Inc., as the successor trustee after authorizing Empower Trust Company, LLC to terminate the Group Annuity Contract. The Plan sponsor elected to transfer the funds to the successor trustee in 2 installment payments to be made on November 15, 2024, and on November 25, 2025. As of October 13, 2025, the funds presented on the Statement of Net Assets Available for Benefits are yet to be transferred to the successor trustee.

**Note 5 – Tax Status**

The Plan document is a prototype standardized defined contribution plan that received a favorable opinion letter from the Internal Revenue Service (IRS) on August 19, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes/believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statement of net assets available for benefits.

**Note 7 – Certified Investment Information**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustees of the Plan, have certified to the completeness and accuracy of the following:

**Note 8 – Party-in-Interest Transactions**

The Plan paid expenses related to the Plan's operations and investment management to various service providers. Certain Plan investments are managed by T. Rowe Price Group, Inc., and were formerly managed by Empower Annuity Insurance company. Empower Annuity Insurance Company was the trustee of the Plan as of December 31, 2023. T. Rowe Price Group, Inc., was the trustee effective January 3, 2024, and as of December 31, 2024, therefore, transactions with these entities qualify as exempt party-in-interest transactions.

**Note 9 – Form 5500**

The Form 5500 has certain items that differ from amounts shown on the accompanying financial statements. These differences relate to classification only and have no effect upon net assets available for benefits for either period.
