Notes to Financial Statements
December 31, 2024 and 2023

NOTE 1. DESCRIPTION OF THE PLAN

The following brief description of the Alliant Energy Health & Welfare Benefit Plan (the Plan) provides only general information. Participants should refer to the various Plan documents for a complete description of the Plan's provisions.

a. General

The Plan provides health and welfare benefits covering substantially all eligible active employees of Alliant Energy Corporation (Alliant Energy) or its subsidiaries (collectively, the Companies). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan is administered by the Benefit Plans Committee of Alliant Energy and sponsored by Alliant Energy Corporate Services, Inc. (Corporate Services), a direct subsidiary of Alliant Energy.

b. Benefits

The Plan provides health, vision, dental, death and long-term disability benefits to eligible active employees of the Companies and their eligible dependents. The Companies are self-insured for health and dental benefits. Health and prescription drug claims are processed by Anthem Blue Cross Blue Shield and Carelon Rx, and dental claims are processed by Delta Dental of Wisconsin. Vision benefits are insured through VSP. Death benefits are insured through Securian Financial and the long-term disability benefits are insured through Lincoln Financial Group.

The Plan also provides eligible active employees with the option to elect additional death benefits, accidental death and dismemberment benefits and participation in a flexible spending plan. Eligible active employees may also elect health coverage that includes a health reimbursement arrangement or a health savings account which can include employer contributions.

All death and long-term disability benefits are the obligation of the insurer.

c. Amendments to or Termination of the Plan

Corporate Services has the right under the Plan to modify benefits provided and contributions required of employees, to discontinue its contributions, and to terminate the Plan subject to the provisions set forth in ERISA.

NOTE 2. SUMMARY OF ACCOUNTING POLICIES

a. Basis of Accounting

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP) on the accrual basis of accounting. Management has evaluated subsequent events through the date which the financial statements were available to be issued on October 13, 2025.

b. Expenses

Expenses of the Plan are paid from the general funds of the respective Companies.

c. Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results may, in some cases, differ from these estimates.

d. Risk and Uncertainties

Plan obligations for future long-term disability payments to participants are made based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption processes, it is reasonably possible that changes in these estimates and assumptions in the near term could materially affect the amounts reported in the financial statements.

NOTE 3. CONTRIBUTIONS AND FUNDING POLICY

Funding for the health and dental benefits for active employees is made by the Companies as claims are incurred and reported for payment. Funding for the death, long-term disability and vision benefits for active employees is made by the Companies as insurance premiums are incurred. Employees also contribute specified amounts for the coverage selected.

NOTE 4. TAX STATUS

The Plan is subject to routine audits by the Internal Revenue Service; however, there are currently no audits on the Plan for any tax periods. The Committee believes the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE 5. BENEFIT OBLIGATIONS

Plan obligations for future long-term disability payments to participants are determined by the Plan's actuary and are based on those participants considered permanently disabled at December 31, 2024 and 2023 and were calculated using a weighted-average discount rate of 4.30% and 4.60%, respectively.
