### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed the audits of the financial statements of the Memorial Hospital of Rhode Island Defined Contribution Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

## *Notes to Financial Statements*

### **Note 1 - Description of the Plan**

The following description of the Memorial Hospital of Rhode Island Defined Contribution Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan sponsored by The Memorial Hospital of Rhode Island. ("Hospital" or "Employer"). Effective December 31, 2014, the Plan was frozen to new participants and contributions and effective January 1, 2015, current and eligible Plan participants became participants in the Care New England 403(b) Match and Savings Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Substantially all investments are participant-directed.

#### **Participant Accounts**

Each participant's account is credited with a pro rata allocation of the Plan's investment gains or losses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the vested portion from the participant's account. Participants directed the investment of their contributions and the Hospital contributions into various investment options offered by the Plan.

#### **Forfeitures**

As of December 31, 2024 and 2023, the forfeited non-vested balance totaled \$3,956 and \$3,759, respectively. These amounts will be used to reduce Plan expenses. For the Plan year ended December 31, 2024, no forfeitures were used to pay Plan expenses.

#### **Vesting**

All participant balances have been fully vested since the Plan was frozen as of December 31, 2014.

#### **Payment of Benefits**

In-service withdrawals from any account fully vested by the participant are permitted only due to financial hardship or upon reaching age 59½. Participants can withdraw amounts from their rollover accounts at any time. Hardship withdrawals may be taken from a participant's deferral or rollover account only. On termination of service, a participant may receive a lump-sum amount equal to the vested value of his or her account, or upon death, disability or retirement, elect to receive other forms of payment described in the Plan document. Upon termination, if a participant's account balance does not exceed \$5,000, and the participant does not elect to take a distribution, the Plan administrator may distribute the participant's vested account balance directly to the participant without consent.

### **Note 1 - Description of the Plan (Continued)**

#### ***Plan Termination***

Although it has not expressed any intent to do so, the Hospital has the right under the Plan to terminate the Plan subject to the provisions of ERISA. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Hospital may determine.

### **Note 2 - Summary of Accounting Policies**

#### ***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

#### ***Investments, Investment Valuation and Income Recognition***

Investments other than fully benefit-responsive investment contracts (valued at contract value) are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price) and contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could vary from those estimates.

#### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Note 2 - Summary of Accounting Policies (Continued)***

#### ***Revenue Credit and Administrative Expenses***

Administrative expenses are generally paid by the Plan. Effective December 3, 2020, the Plan entered into a service agreement with AIG Federal Savings Bank (“AIG”) for a term of five years and renewing for successive two-year periods thereafter unless terminated. The expenses related to the Plan charged by AIG include an administrative fee of \$60 per year per participant and another \$26 per participant. These fees are all assessed and calculated quarterly. In addition, another fee of \$34 per participant is assessed and calculated quarterly. This amount is deposited into a plan expense account to be used for various allowable plan expenses. This account can be used to cover plan expenses, such as auditing, legal and consultant fees or be allocated back to participants. These amounts are not available to reduce Employer contributions.

The amount available in the expense budget account at December 31, 2024 and 2023 was \$3,034 and \$11,546, respectively. The amounts used from the expense budget account to offset expenses and allocate to participants during the years ended December 31, 2024 and 2023 amounted to \$4,111 and \$3,559, respectively.

For the year ended December 31, 2024, \$4,111 in revenue credits were earned and \$13,125 was charged to participant accounts and included in the total of plan expenses.

#### ***Subsequent Events***

The Employer and Plan management have evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued. During 2025, the Employer transferred its recordkeeping and/or administrative services agreement to Fidelity Workplace Service LLC, effective on or about June 23, 2025.

### ***Note 3 - Information Certified by the Custodian and Insurance Company***

Plan investments are held by the Plan’s custodian and insurance company, VALIC Trust Company Inc. and The Variable Annuity Life Insurance Company (“VALIC”). The fair and contract value of investments as of December 31, 2024 and 2023 and all investment transactions for the year ended December 31, 2024 are reported to the Plan and certified as complete and accurate by the custodian and insurance company. Investment transactions include interest and dividends and net appreciation in fair value of investments. Information included in the supplemental schedule has also been derived from information certified by the custodian and insurance company. The Plan offers investment choices to allow Participants to create a diversified portfolio of assets based on a participant’s risk tolerance.

### **Note 4 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I) and the lowest priority to unobservable inputs (Level III). The three levels of the fair value hierarchy are described below:

Level I – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level II – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.

Level III – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

#### ***Mutual Funds***

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

All mutual fund investments held as of December 31, 2024 and 2023, totaling \$3,881,234 and \$3,808,664, respectively, are Level I within the fair value hierarchy.

### **Note 5 - Investment Contract with Insurance Company**

The Fixed Interest Option is a group fixed annuity product issued by VALIC. Contract or accumulation value, as reported to the Plan by VALIC, represents internal transfers, earnings, participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. At December 31, 2024 and 2023, the contract value amounted to \$40,762 and \$42,640, respectively.

### ***Note 5 - Investment Contract with Insurance Company (Continued)***

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate will be declared annually by VALIC and that will apply to either the entire accumulation value, or separately to amounts in separate time periods. An interest rate will be set in advance of the period to which it relates and will be at least 1% per year for the first 5 contract years and at least 1% thereafter.

The investment will have a guaranteed interest rate of 2% for the first twelve months that began December 3, 2020. The crediting interest rate was 2.65% at December 31, 2024.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

In the event of a discontinuance of the contract, the Fixed Income Option investment allows the plan sponsor to withdraw the contract value either in five equal installments or a decreasing balance method. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

### ***Note 6 - Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events such as an international conflict, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### ***Note 7 - Related-Party Transactions and Exempt Party-in-Interest Transactions***

Plan investments are managed by AIG and VALIC. AIG is the recordkeeper as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. For the Plan year ended December 31, 2024, administrative fees of \$18,221 were paid to VALIC and other service providers, net of \$4,111 in revenue credits.

### ***Note 8 - Income Tax Status***

The Plan adopted The Angel Pension Group, Inc. Volume Submitter 403(b) Plan and that prototype plan has received an advisory letter from the Internal Revenue Service ("IRS") dated March 31, 2017 stating that the form of the plan is qualified under Section 401 of the Internal Revenue Code ("Code") and, therefore, the related trust is tax exempt. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting standards require recording uncertain income tax positions that exist in the Plan's financial statements. Plan management has determined there are no uncertain tax positions and believes there is no adjustment or disclosure required in the Plan's financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
