## INDEPENDENT AUDITOR'S REPORT

To the Trustees  
**UKG Retirement Savings Plan**

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of **UKG Retirement Savings Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of **UKG Retirement Savings Plan's** financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of **UKG Retirement Savings Plan** and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about **UKG Retirement Savings Plan's** ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter – Supplemental Schedule Required by ERISA**

#### NOTE 1: DESCRIPTION OF THE PLAN

The following description of UKG Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined-contribution plan established January 1, 1994, to provide retirement and other related benefits to all employees of UKG, Inc. ("UKG"), formerly Ultimate Software Group, Inc., (the "Company"). Employees are eligible to participate if they are full-time employees and have attained the age of 21. On July 1, 2023, the Plan was amended to exclude interns, collectively bargained employees, leased employees, nonresident aliens, and bona fide residents of Puerto Rico. Temporary employees shall be offered participation in the Plan subject to the eligibility provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On July 1, 2023, the Company acquired all shares of Immedis, Inc. The acquired employees became eligible to participate in the Plan, subject to the Plan's eligibility requirements, on October 1, 2023. Effective February 22, 2024, the Immedis, Inc. component of the Group Management Services, Inc. 401(k) Profit Sharing Plan & Trust was merged into the Plan. The related asset transfers are reflected in "Transfers In" in the accompanying Statement of Changes in Net Assets Available for Benefits.

During 2024, the Plan was amended and restated to reflect the acquisition of Immedis, Inc. and to incorporate other updates to the Plan document. The amendment and restatement did not result in any significant changes impacting these financial statements, except for the establishment of a new vesting schedule applicable to employees of Immedis, Inc.

**Contributions and Allocations:** Each year, participants may elect to contribute a percentage of their annual compensation up to the maximum dollar amount allowed under the Internal Revenue Service ("IRS"), as defined in the Plan. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may designate a portion, or all, of their deferred contributions as Roth contributions, which are includable in the participant's gross income. Participants, with the consent of the Plan Administrator, may deposit amounts received from any other retirement plan which satisfies the tax rules for rollovers. Contributions are subject to certain limitations under the Internal Revenue Code ("IRC"). Unless instructed otherwise by the participant, upon becoming eligible to participate in the Plan, 5% of the participant's eligible compensation will be contributed to the Plan subject to annual limits set by the IRC. Temporary employees shall not be automatically enrolled into the Plan.

The Company may make discretionary matching contributions to the Plan. For the year ended December 31, 2024, the Company made discretionary matching contributions equal to 45% of an employee's contribution to the Plan. No matching employer contributions will be made with respect to catch-up contributions.

The Company may make a discretionary nonelective employer contribution. To be eligible for a discretionary nonelective employer contribution, a participant must be employed with the Company on the last day of the Plan year. No discretionary nonelective employer contributions were made for the year ended December 31, 2024.

**NOTE 1: DESCRIPTION OF THE PLAN (CONTINUED)**

**Participant Accounts:** Each participant's account is credited with the participant's contributions and allocations of the Company's discretionary matching and discretionary nonelective employer contributions and Plan earnings or losses and plan earnings. Allocations of earnings (losses) are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Options:** Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also allows for self-directed brokerage accounts for which the participants are responsible for any investment decisions made in the brokerage accounts.

**Vesting:** Participants are immediately vested in their voluntary contributions plus the investment earnings thereon. Company discretionary matching and discretionary nonelective employer contributions are subject to a vesting schedule based on the number of years of service as follows:

A participant who was a former participant in the Ultimate Software Group 401(k) Retirement Plan shall continue to vest as follows:

**Forfeited Accounts:** At December 31, 2024 and 2023, the forfeited nonvested accounts totaled \$341,438 and \$6,729, respectively. These accounts will be used to reduce future Company contributions or to pay plan expenses. For the year ended December 31, 2024, forfeited nonvested accounts were used to offset employer match contributions by \$3,073,952.

#### NOTE 1: DESCRIPTION OF THE PLAN (CONTINUED)

**Notes Receivable from Participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant notes receivable fund. Notes receivable terms may not exceed 5 years unless for the purchase of a primary residence. The loans are secured by the balance in the participants' account and bear interest at rates based on the prevailing interest rates charged by persons in the business of lending money for loans that would be made under similar circumstances (3.25% to 9.50% at December 31, 2024). Principal and interest are paid ratably usually through payroll deductions.

**Payment of Benefits:** Benefits are payable in a lump sum payment upon normal retirement age, in service withdrawals after age 59½, death, permanent disability, separation of service, or reasons of proven hardships. Upon termination, if the vested balance is less than \$7,000, the Plan can automatically distribute the balance.

#### NOTE 2: SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting:** The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

**Use of Estimates:** The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers, trustees, and other parties involved with the Plan. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants:** Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan documents. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

#### NOTE 2: SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

**Termination of the Plan:** Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate it at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Payment of Benefits:** Benefits payments to participants are recorded when paid.

**Uncertain Tax Positions:** GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**Administrative Expenses and Revenue Credit Program:** Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company or the Revenue Credit Program. Expenses that are paid by the Company are excluded from these financial statements. Fees related to recordkeeping fees, the administration of notes receivable from participants, and distributions are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments. The Revenue Credit Program provides income in situations where recordkeeping revenue earned in connection with Plan services exceeds agreed-upon compensation. Empower (Note 5) will deposit any excess revenue in a plan-level suspense account in the Plan. The Plan Administrator can then direct Empower to pay qualified plan-level expenses or allocate unused credit to eligible participants via funds from the Revenue Credit Program account. The balance in the Plan's Revenue Credit Program account was \$430,291 and \$594,886 as of December 31, 2024 and 2023, respectively.

#### NOTE 3: TAX STATUS

The Plan has received a determination letter from the IRS dated June 23, 2022, stating that the Plan is qualified under Section 401(a) of the IRC and, therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the determination letter; however, the Plan Administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

#### NOTE 4: RISKS AND UNCERTAINTIES

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits.

#### NOTE 7: FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board (FASB), Accounting Standards Codification (“ASC”) 820, “Fair Value Measurement and Disclosures”, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the assets or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### NOTE 7: FAIR VALUE MEASUREMENTS (CONTINUED)

*Self-directed brokerage accounts:* Mutual funds held in the brokerage accounts are valued at the daily closing price as reported by the fund. Common stock is valued at the closing price reported on the active market which the individual securities are traded.

*Common/collective trusts:* Valued at the NAV of units of a collective trust. The NAV, as provided by the fund manager, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

*Variable Annuity Funds:* The Plan offers two variable annuity accounts through T. Rowe Price Associates, Inc. ("T. Rowe"), which has been designated by the fund's Board of Directors as the valuation designee. The fund's financial instruments are valued at the close of the New York Stock Exchange and are reported at fair value, which GAAP defines as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
