Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of AspenTech 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA ("ERISA Section 103(a)(3)(C) audit"). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency ("qualified institution"), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP"); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants to determine the benefits due or which may become due to such participants.

Auditor’s Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Notes to Financial Statements

1. Description of Plan

The following brief description of the AspenTech 401(k) Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution profit sharing plan covering all eligible employees of Aspen Technology Inc. and subsidiaries (the “Company”). Plan management is responsible for oversight of the Plan. The Plan’s investment committee determines the appropriateness of the Plan’s investment offerings and monitors investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Net Transfer of Assets from Merged Plan

Effective January 19, 2023, the Open Systems International 401(k) Plan was merged into the Plan. This resulted in the transfer of 959 participant accounts with net assets totaling \$81,385,357.

Eligibility

Company employees, excluding union employees, nonresident aliens, leased employees, and residents of Puerto Rico, are eligible to participate in the Plan and to receive discretionary matching employer contributions upon attaining age 21.

Eligible employees must complete at least 1,000 hours of service during the plan year and be employed as of the last day of the plan year to be eligible to receive any discretionary nonelective contributions that may be made for that plan year. Employees do not need to satisfy this requirement if they die (including death while performing qualified military service), become disabled, or retire during the plan year.

Contributions

Participants may contribute from 1% to 80% of their compensation into the Plan, subject to Internal Revenue Service (“IRS”) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”). The Plan allows for in-plan Roth conversions, where distributable portions of a participant’s account, which are not part of an outstanding loan balance or designated Roth contributions, will be considered designated Roth contributions for purposes of the Plan. The Roth contribution source was also created and communicated to employees as an enrollment option.

The Company may make a discretionary matching contribution, determined by the employer each plan year, based on a percentage of each participant’s contributions. In 2024 and 2023, the Company provided a matching contribution equal to 50% of employee contributions up to 6% of eligible compensation.

In addition to the matching contribution, the Plan allows the Company to make annual discretionary elective contributions to the Plan. No discretionary elective contributions were made in 2024 or 2023.

Participant Accounts

Each participant account is credited with the participant's contributions, company contributions, if any, and allocations of plan earnings. Participant accounts are charged with an allocation of administrative expenses and transaction fees. Allocations are based on participant earnings, deferrals, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting and Forfeitures

Participants are immediately vested in their elective contributions and actual earnings thereon. The Plan provides for a three-year ratable vesting schedule on company contributions. In the event of death, permanent disability, or retirement, a participant's company contribution account becomes fully vested.

Forfeitures result from non-vested company contributions remaining in the Plan from terminated employees and are used to reduce future company contributions. Forfeitures of \$362,481 in 2024 and \$226,639 in 2023 were used to reduce company matching contributions. The unused forfeiture balance was \$462,469 and \$155,389 at December 31, 2024 and 2023, respectively.

Notes Receivable from Participants

Participants may borrow from their vested account a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the participant's vested balance or \$50,000, reduced by the excess of the highest outstanding loan balance in the participant's account during the prior 12-month period over the existing loan balance. The maximum term of such loans is five years, except for a loan for the purchase of a primary residence, in which case the loan terms may exceed five years. Loans bear a reasonable rate of interest determined by the plan administrator and are repaid ratably through payroll deduction.

Participant notes receivable are stated at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Under the Plan, withdrawals may be made from the participant's account for in-service distributions and hardship. An in-service distribution is allowed if an active participant has reached the age of 59½ or the normal retirement age, as defined. Hardship withdrawals are allowed if certain criteria are met.

If a participant terminates service, the entire amount in his or her salary deferral account and the vested portion of his or her employer account may be distributed or rolled over in the form of a lump-sum payment or distributed annuity payment, as directed by the participant. If the account balance exceeds \$1,000 but is not more than \$5,000 and the participant has not elected to roll over or receive a lump-sum payment, the account balance will be automatically rolled into an Individual Retirement Account. If the account balance is less than \$1,000 and the participant does not make an election, the Plan may make an automatic lump-sum distribution. If service is terminated by

death, disability, or retirement, the entire balance is distributed in the form of a lump-sum or annuity payment.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Company. Expenses paid by the Company are excluded from these financial statements. The Plan also pays investment, administrative, and transaction fees if not paid by the Company. Investment related expenses are included in net appreciation in fair value of investments.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The investments of the Plan are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of the investments within the Plan are reflected on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Discretionary employer contributions are recorded in the relevant period in accordance with the terms in the plan document.

Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

3. Certified Investments

The Plan's assets, investment income, and investment transactions were certified as complete and accurate by Fidelity Management Trust Company ("FMTC"), the plan trustee and a qualified

institution. Therefore, in accordance with the request of the plan administrator and as allowed under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure, the Plan's independent auditors did not perform auditing procedures with respect to the following information, except for comparing such information to the related information included in the financial statements and supplemental schedule, schedule of assets:

4. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level, within the fair value hierarchy, is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual Funds

Shares held in mutual funds traded on national securities exchanges are valued at the net asset value ("NAV") as of December 31, 2024 and 2023.

Common/Collective Trust

The Plan holds an investment in a common/collective trust, specifically the Fidelity Managed Income Portfolio Fund (the "MIP"). The MIP invests in investment contracts issued by insurance companies and other financial institutions, fixed income securities, money market funds, and may include derivative instruments such as futures contracts and swap agreements to provide daily liquidity. The MIP is credited with contributions and earnings on the underlying investments and charged for participant withdrawals and administrative expenses. There are no unfunded commitments and the redemption frequency and period is daily, with no advance notice. The MIP is valued at NAV as a practical expedient for fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes that its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

The plan sponsor adopted FMTC's pre-approved "Non-standardized Plan," and the IRS issued an opinion letter, dated June 30, 2020, stating that the pre-approved plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since the date of the letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and that the Plan continues to be tax-exempt. Therefore, no provision for income taxes has been recorded.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Party-in-Interest Transactions

Certain plan investments are managed by an affiliate of FMTC. Therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.

The Plan receives revenue credits from FMTC quarterly. The revenue credit account can be used to pay plan expenses or can be allocated to eligible plan participants as defined in the agreement. Revenue earned from this agreement is recorded as a reduction of administrative expenses for the years ended December 31, 2024 and 2023.

7. Termination of the Plan

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a partial or complete termination of the Plan, the right of each affected participant's account will be 100% vested and the value of the participant's accounts will be paid in accordance with the provisions of the Plan.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

10. Prohibited Transactions

The Company determined that certain remittances of employee deferrals for the plan year ended December 31, 2024, were not made timely in accordance with DOL guidelines. Under ERISA regulations, late remittances of plan contributions are considered prohibited transactions. During the year ended December 31, 2024, a total of \$57,628 of employee contributions were remitted to the Plan after the ERISA requirement. To ensure that employee plan contributions are deposited in accordance with ERISA requirements, the Company has reviewed its internal processes and strengthened internal controls around the remittance of employee contributions to the Plan.
