### Report on the Audit of the Financial Statements

We have performed audits of the accompanying financial statements of Tanimura & Antle, Inc. **NOTE 1 PLAN DESCRIPTION**

The following description of the Tanimura & Antle, Inc. Profit Sharing 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering substantially all employees who are employed by Tanimura & Antle, Inc. (the Employer or the Company). The Plan was organized effective January 1, 1993 to provide a tax deferred savings plan for employees of the Employer who become participants of the Plan. The Plan has been amended and restated throughout the years to comply with tax legislation and most recently amended effective January 1, 2025. The Plan excludes employees covered by a collective bargaining agreement and residents of Puerto Rico. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility**

Employees are eligible to participate in the deferral and safe harbor match components of the Plan upon turning 18 years of age and after one year of service (at least 1,000 hours of service). Effective April 1, 2024, the Plan changed the one year service requirement to a 30 day service requirement. Participants are eligible for the discretionary profit sharing contribution if they meet the eligibility requirements, work 1,000 hours, and are employed on the last day of the Plan year.

**Contributions**

Eligible participants may elect to contribute up to 50% of eligible compensation, as pre-tax or Roth contributions, not to exceed the limits allowed by Section 415, 402(g) and 401(k) of the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may also contribute amounts representing distributions from other qualified plans.

The Company elected to adopt safe harbor provision and matches an amount equal to 100% of the first 3% of the participant's deferral contribution, plus 50% of the next 2% of the participant's deferral contribution. For the years ended December 31, 2024 and 2023, the employer safe harbor contributions were \$2,966,169 and \$2,773,552, respectively.

The Company may also make a discretionary profit sharing contribution to all qualified employees as determined annually by the Employer. There were no profit sharing contributions for the years ended December 31, 2024 and 2023.

**Participant Accounts and Allocations**

Each participant's account is credited or debited with (1) the participant's contributions by payroll deduction, (2) the participant's portion of employer contributions, (3) an allocation of Plan earnings or losses, (4) rollovers from other qualified plans, and (5) an allocation of Plan expenses. Plan earnings or losses are allocated based upon each participant's account balance.

Certain fees are charged to the fund investments and are offset against Plan investment income and loss as presented on the statements of changes in net assets available for benefits. Participants should refer to the prospectuses of these funds for details on the various types and amounts of investment fees charged to the Plan and their individual accounts.

**Vesting**

Participant contributions, safe harbor contributions, rollovers, and net earnings on these contributions, are fully vested when made or earned. Participants fully vest in the Company's discretionary profit sharing contributions after three years of credited service.

**Payments of Benefits**

Upon termination of service due to death, disability, or retirement, a participant or beneficiary may elect to receive the value of the vested interest in his or her account in the form of a lump-sum distribution. The Plan allows for in-service distributions if a participant reaches 59½ subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

**Notes Receivable from Participants**

Participants may apply to borrow from the Plan a minimum amount of \$1,000 and a maximum equal to the lesser of \$50,000, or, 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Loan fund. Loan funds may be repaid over any reasonable period, not to exceed the fifth anniversary of the date the funds were borrowed, with the exception of loans used for the purchase of a principal residence, which can be repaid over a period of up to 30 years. The loans are secured by the balance in the participant's account and bear interest at the prime rate. The interest rates in effect for the years ended December 31, 2024 and 2023 based on the prevailing interest rates, ranged from 3.25% to 8.50%. Principal and interest are paid ratably through payroll deductions.

**Forfeited Accounts**

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures attributable to employer contributions may be used to reduce administrative expenses of the Plan or reduce employer contributions during the Plan year in which forfeitures occur. At December 31, 2024 and 2023, the amounts of available forfeitures totaled \$26 and \$8,896, respectively. For the years ended December 31, 2024 and 2023, the Employer used \$21,718 and \$-0- of forfeitures to reduce Employer's contributions. For the years ended December 31, 2024 and 2023, the Employer did not utilize any forfeitures to reduce administrative expenses.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies utilizing information provided by the custodian and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions**

Employee contributions and corresponding Employer safe harbor contributions are recorded in the year in which the employee compensation is paid and the deferrals are withheld. Employer profit sharing contributions are recorded in the year in which the related employee compensation is paid.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of benefit payments are charged directly to the participant's account and are included in administrative expense. Investment related expenses are included in net appreciation of fair value of investments.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivables are recorded as distributions on the basis of the terms of the Plan document.

**Subsequent Events**

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued. Effective January 1, 2025, the Employer safe harbor match will change to 100% of deferrals up to 5% of compensation.

**NOTE 3 CERTIFIED INFORMATION**

Empower Trust Company and Empower Annuity Insurance Company of America (EAIC), certified for Massachusetts Mutual Life Insurance under a power of attorney granted to EAIC, have supplied the Plan administrator with certifications as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Investment Trust* – Valued at the NAV of units of the collective trust fund. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY**

The Plan has a traditional fully benefit-responsive guaranteed investment contract with Massachusetts Mutual Life Insurance Company (the Insurance Company). The Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants. The guaranteed investment contract does not permit the Insurance Company to terminate the agreement prior to the schedule maturity date.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Company contributions.

**NOTE 7 RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by the trustees and insurance companies, therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA. Fees paid by the Plan for certain administrative expenses are paid to other service providers. Service providers include CliftonLarsonAllen LLP and Concurrent Investment Advisors LLC. These transactions qualify as party-in-interest transactions which are exempt from the prohibited transactions rules of ERISA.

**NOTE 8 PLAN TAX STATUS**

The Plan is placing reliance on an opinion letter from the Internal Revenue Service (IRS) on the Plan indicating that the Plan is designed in accordance with the applicable section of the IRC. The Plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 9 RISK AND UNCERTAINTIES**

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 10 RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500**

Variations in the timing of the recognition of certain transactions affecting the Plan has resulted in differences between the financial statements and the Internal Revenue Service Form 5500. The following is a reconciliation of these differences:

**NOTE 11 NONEXEMPT TRANSACTIONS**

During the year ended December 31, 2024, the Company timely remitted employee 401(k) deferral contributions for all payroll periods. However, due to a technical issue in December 2023, \$98 of deferral contributions could not be matched with the recordkeeper's system, resulting in a delay in withdrawing the contribution from the Plan Sponsor's account. As a result, the contribution was not remitted within the timeframe prescribed by the Department of Labor. This delay constitutes a prohibited transaction under the Employee Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code (IRC). The Company intends to correct the prohibited transaction by calculating and depositing any lost earnings attributable to the late contribution, filing Form 5330 with the Internal Revenue Service, and paying the applicable excise tax. Details of this late remittance are included in the attached Schedule H, Line 4a.
