Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Umpqua Health and Affiliated Companies Employee Savings Plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Umpqua Health and Affiliated Companies Employee Savings Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. NOTES TO FINANCIAL STATEMENTS

1. Plan Description

The following description of Umpqua Health and Affiliated Companies Employee Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions. The Plan's most recent restatement was effective January 1, 2024. The Board of Trustees oversees the governance of the Plan.

General

The Plan is a defined-contribution plan covering all eligible employees of the following participating employers (collectively, the Employer): Umpqua Health, LLC; Douglas County Individual Practice Association, Inc. (DCIPA); Umpqua Health Newton Creek, LLC; and Umpqua Health Management, LLC. Collective bargaining, leased, and non-resident alien employees are excluded from participating in the Plan. Employees become eligible after three months of employment, with no hour requirements. Prior to 2024, there were also no age requirements. Effective January 1, 2024, participants must be age 18 or older to participate in the Plan. Prior to 2024, non-excluded employees of the Employer become eligible participants of the Plan on the first day of the calendar quarter coinciding with or following the date they meet the eligibility requirements. Effective January 1, 2024, participants enter the Plan immediately upon meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employee Voluntary Contributions

The Plan includes a salary-deferral provision which provides for pre-tax, after-tax and Roth contributions. Each participant may elect to contribute to the Plan a portion of their total annual compensation up to the maximum allowed under the Internal Revenue Code (IRC). Additionally, employees age 50 or older are eligible to contribute catch-up contributions up to Internal Revenue Service (IRS) limits. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Beginning February 1, 2024, the Plan automatically enrolls eligible employees into the Plan at an initial salary deferral rate of 3 percent. The Plan also automatically increases the salary deferral rate of automatically enrolled participants by 1 percent annually up to a maximum deferral rate of 6 percent.

Employer Contributions

The Employer matches 100 percent of elective deferrals up to 6 percent of participant eligible compensation in accordance with the Plan's Safe Harbor provisions. For the years ended December 31, 2024 and 2023, Safe Harbor matching contributions were \$566,359 and \$600,681, respectively.

The Employer will also determine a profit-sharing contribution, if any, which will be contributed to the Plan. In order to be eligible for profit-sharing contributions, the participant must have worked at least 1,000 hours during the Plan year or must be employed on the last day of the Plan year unless the severance of employment was the result of death, disability, or retirement after attaining 65 years of age. For the years ended December 31, 2024 and 2023, no profit-sharing contributions have been made to the Plan.

1. Plan Description, continued

Participant Accounts

Each participant's account is credited with the participant's contribution and the Employer contribution, allocations of Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit provided from the participant's vested account.

The Plan offers a variety of investment options and allows for participant directed investment. Beginning in 2024, participants have the option to utilize Fidelity's BrokerageLink program to self-direct their account among a wider variety of investments. Participant contributions are maintained in separate accounts.

Vesting

Employee voluntary contributions, as well as the Employer's matching and Safe Harbor contributions, are 100 percent vested at all times. Vested interest in the profit-sharing contributions are calculated at 25 percent per year of service, beginning with the participant's second full year of service and reaching 100 percent at the end of five years of credited service of at least 1,000 hours per year. If termination is due to death or disability, participant is considered 100 percent vested.

Forfeited Accounts

Forfeitures of terminated participants' non-vested portions of Employer contributions may be used to reduce future Employer contributions. At December 31, 2024 and 2023, there were no forfeitures available to offset future contributions and no unvested amounts were forfeited from participant accounts.

Participant Loans

Participant loans are not allowed.

Payment of Benefits

Upon termination of service or in the event of death, disability, or retirement as defined in the Plan document, a participant or their survivor become eligible to receive a full or partial lump sum of account balances. In-service withdrawals are permitted on fully vested funds once the participant has reached 59½ years of age. The Plan does not allow hardship withdrawals. For account balances under \$7,000 in 2024 and under \$5,000 in 2023, Plan provisions allow for automatic force-out.

2. Summary of Significant Accounting Policies

Basis of Reporting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Contributions

Participant and employer contributions are recorded in the year in which the participant contributions are withheld or the underlying compensation is paid.

Investment Valuation and Income Recognition

The Plan's investments in registered investment companies, common stock, and cash are stated at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of the valuation of the Plan's investments in insurance contracts. See Note 5 for additional information on fair value measurements.

Purchases and sales of securities are recorded on a settlement-date basis. Interest and dividend income are recorded on the accrual basis of accounting. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses and Fees

General Plan administrative expenses, investment management fees, and other fees are paid directly from participant accounts. Administrative expenses paid by the Employers are excluded from these financial statements. Transaction-based fees relating to optional services (i.e. distribution request, etc.) are charged directly against the appropriate participant's account. Investment related expenses are deducted from investment income.

Revenue Sharing

Beginning in 2024, the Plan contains a revenue sharing expense offset arrangement where the Plan is credited a monthly amount based on a percentage of plan assets which is used to pay expenses. For the year ended December 31, 2024, \$6,019 was credited to the account and used to pay Plan expenses.

Recent Accounting Standard Adopted

On January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13 Financial Instruments - Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*, and all related amendments (ASC 326), which replaced the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits. The financial assets held by the Plan that are subject to ASC 326 are employer contributions receivable and participant contributions receivable.

The Plan adopted ASC 326 effective January 1, 2023. There was no impact to the financial statements as a result of adopting this standard.

3. Information Certified by the Trustee and Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company (Fidelity), acting as the trustee for the Plan as of and for the year ended December 31, 2024, and Charles Schwab Trust Bank, acting as the custodian for the Plan as of and for the year ended December 31, 2023, have certified that the following information included in the accompanying financial statements and supplemental schedules is complete and accurate as of and for the years ended December 31:

4. Insurance Contract

In 2023, the Plan was invested in a fully benefit-responsive investment contract with Standard Insurance Company (The Standard). The Standard maintained the contributions in a pooled account (Stable Value Asset A), which was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. All assets in the stable value fund were credited with interest using a declared quarterly rate determined by The Standard and stated in advance of the coming quarter. There was no specific portfolio of assets in which the stable value fund invests. The credited interest rate is backed by the income received from assets held in The Standard's general account. The crediting rate for the Plan year ended December 31, 2023 was 2.77 percent. The rate will never be below 1 percent and has no maximum interest rate for the Stable Value Option, and it is not considered a guaranteed interest contract or a common/collective trust. Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value with The Standard. The Plan Administrator believes the occurrence of such events that would also limit the Plan's ability to transact at contract value with the Plan participants is not probable. Based on these factors, The Standard has reported that the fair value of the insurance contracts is equal to the current contract value. As of January 1, 2024, the Plan transitioned to Fidelity and is no longer invested in insurance contracts.

5. Fair Value Measurements

Financial Accounting and Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to their fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

5. Fair Value Measurements, continued

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Registered investment companies: The Plan's investments are units of mutual funds, which were held within a group annuity contract for the year ended December 31, 2023. These funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and considered to have a readily determinable fair value.

Interest-bearing cash: Valued at the contract value of shares held, which approximated fair value.

Common stock: Investments held in self-directed brokerage accounts, valued at the closing price reported on the active market on which the stocks are traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Related Party and Party-in-Interest Transactions

Certain Plan investments are managed by Fidelity Workplace Solutions LLC (Fidelity), acting as the third-party administrator for the Plan, and therefore these transactions qualify as party-in-interest transactions. The Plan transitioned to Fidelity from The Standard in 2024. Administrative fees paid to Stancorp Financial Group, an affiliate of The Standard, for 2023 totaled \$37,048. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

7. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of full or partial Plan termination, affected participants will become 100 percent vested in their accounts.

8. Tax Status

The Internal Revenue Service (IRS) has informed FMR LLC., the sponsor of the pre-approved profit-sharing plan, by an opinion letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believe that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The Plan provides for various options that have different investment strategies. These investment securities are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

10. Non-Exempt Transactions

During the year ended December 31, 2024, participant contributions totaling \$62,698 were not remitted to the Plan within the appropriate time period by the Employer. During the year ended December 31, 2023 participant contributions totaling \$3,135 were not remitted to the Plan within the appropriate time period by the Employer. Additionally, \$633 in participant contributions from a prior year were not remitted to the Plan within the appropriate time. A total of \$3,768 in late contributions were corrected with lost earnings in 2024. These transactions constitute prohibited transactions as defined by ERISA. The Employer is taking the appropriate steps to correct the situation by reimbursing employees for lost earnings and interest.

11. Subsequent Events

Management evaluates events and transactions that occur after the statement of net assets available for benefits date as potential subsequent events. Management has performed this evaluation through the date of the independent auditor's report.
