Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Keller Supply Company Profit Sharing 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF THE PLAN:

The Keller Supply Company Profit Sharing 401(k) Plan (the Plan) is a contributory, defined contribution plan for the benefit of the employees of Keller Supply Company (the Company).

The responsibility for operations, investments, policies and administration of the Plan (except for the day-to-day investment management and control of assets) is vested in the Administrative Committee of the Company. Administrative Committee members are appointed by the Company's Board of Directors. Plan assets are held in a trust administered by the Plan trustee under the terms of a trust agreement. The Plan adopted the Hunnex & Shoemaker Defined Contribution Pre-Approved Plan Basic Plan Document #01 effective January 1, 2022. The trustee function of the Plan is performed by Empower Trust Company, LLC (the "Trustee"). The Trustee receives contributions made to the Plan in a trust and invests those contributions as directed by participants and according to the policies established by the Administrative Committee. The Trustee makes payouts from the Plan in accordance with the Plan document. The funds must be used for the exclusive benefit of Plan participants and their beneficiaries. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employees may contribute deferrals subject to statutory limits. The Plan allows participants to designate all or a portion of their elective deferrals on a pretax basis or as Roth deferrals. The Company provides a matching contribution (determined annually by the Company's Board of Directors) equal to a discretionary percentage or amount of each participant's elective deferral. For 2024 and 2023, the Company provided a discretionary matching contribution equal to the lesser of 25% of the first 4% of compensation that a participant contributed to the Plan or 1% of compensation. Additional amounts may be contributed at the option of the Company's Board of Directors. The additional contributed amounts for the profit-sharing component of the Plan are allocated to participants based on eligible compensation. The Company funds its matching and profit-sharing contributions annually. The Company's 2024 matching 401(k) contribution and discretionary profit-sharing contribution were \$515,537 and \$664,463, respectively. The Company's 2023 matching 401(k) contribution and discretionary profit-sharing contribution were \$491,196 and \$1,308,804, respectively. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Employees are eligible to participate in elective deferrals with the performance of one hour of service and are eligible for matching and profit-sharing contributions upon attaining eighteen years of age and completion of one year of service. In addition, eligible employees hired on or after June 1, 2010 are automatically enrolled for a 2% deferral in the absence of an election to the contrary.

A participant may direct the Trustee to invest his/her elective contributions, catch-up contributions, qualified non-elective contributions, rollover contributions and employer contributions in available investment options. Investment options include a variety of mutual funds, including life-cycle funds.

Participants may change their investment selections at any time.

Each participant's account is credited with the participant's contribution and related matching contribution and allocations of the employer's discretionary contributions, net plan earnings, and

forfeitures. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Employer contributions and allocated earnings and forfeitures thereon vest with individual participants based upon vesting service (as defined) with the Company, with 100% vesting after six years of service or at normal retirement age. Forfeitures of the employer match and profit-sharing contributions are reallocated to remaining participants as an additional discretionary matching contribution (employer match) and an additional discretionary nonelective contribution (profit sharing) and were as follows:

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$254,043 and \$160,407, respectively. The majority of these amounts were allocated in March 2025 and 2024, respectively.

Vested benefits are payable upon the retirement, death, disability or termination of a participant.

Participants may receive loans from the Plan. Participant loans carry interest at a commercially reasonable rate as determined by the Administrative Committee, are secured by the related account balances, and have maturities not to exceed five years.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, each participant's account will be fully vested, nonforfeitable, and distributed to the participant after the effective date of the termination.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES:**Basis of accounting -**

The financial statements of the Plan are prepared using the accrual method of accounting.

Valuation of investments and income recognition -

Investments held by a defined contribution plan are required to be reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 2 - Continued:

Investment securities are exposed to various risks, such as interest rate, market, and credit risk. It is reasonably possible, given the level of risk associated with investment securities that changes in the near term could materially affect participants' account balances and the amounts reported in the financial statements.

Notes receivable from participants -

Notes receivable from participants are measured at their unpaid balance. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Expenses -

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Use of estimates -

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan's administrator to make estimates and assumptions that affect the reported amounts of assets and net assets available for benefits at the date of the financial statements and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period. Accordingly, actual results could differ from those estimates.

NOTE 3 - FAIR VALUE MEASUREMENTS:

Fair value is a market-based measurement determined based on assumptions that market participants would use in pricing an asset or liability. Under generally accepted accounting principles, there are three levels of inputs, which prioritize the inputs used in measuring fair value as follows:

- Level 1: Observable market inputs such as quoted prices (unadjusted) in active markets for identical assets or liabilities.
- Level 2: Observable market inputs, other than the quoted prices in active markets, that are observable either directly or indirectly; and
- Level 3: Unobservable inputs where there is little or no market data, which require the reporting entity to develop its own assumptions.

The inputs or methodology used for valuing investments is not necessarily an indication of the risk associated with investing in those securities.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5 - FEDERAL INCOME TAXES:

Keller Supply Company (Employer) adopted the Hunnex & Shoemaker Defined Contribution Pre-Approved Plan Basic Plan Document #01 ("Prototype Plan") and Trust effective January 1, 2022. It is the intent of the prototype plan to be exempt from federal income taxes. An opinion letter dated June 30, 2020 from the Internal Revenue Service has been obtained by the prototype plan sponsor. The Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan is qualified, and the related trust is tax-exempt as of the financial statement date.

Generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has concluded that as of December 31, 2024, the Plan has not taken any uncertain positions that would require recognition or disclosure. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS:

Empower Trust Company LLC acts as a custodian and recordkeeper via its subsidiary, Empower Retirement for the Plan. Hunnex and Shoemaker (H&S) provides third party administration services. Therefore, transactions with the above named and their subsidiaries qualify as party-in-interest transactions.

NOTE 7 - SUBSEQUENT EVENTS:

The Plan has evaluated subsequent events through October 14, 2025, the date these financial statements were available to be issued.
