Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by the qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors’ Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on these financial statements.



In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedules, (1) Schedule H, Line 4a - Schedule of Delinquent Participant Contributions for the year ended December 31, 2024 and (2) Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, have been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.



In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or are derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements

Note 1 - Description of the Plan

The following description of the VNA of Care New England 403(b) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, established January 1, 2008, covering all eligible employees of Kent County Visting Nurse Association ("VNA" or "Employer"). Employees are eligible to participate in the Plan on the first day of the month after the date of hire ("Participants"). Employees will become eligible for the Employer non-elective contribution after attaining age 21 and one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Substantially all investments are participant-directed.

Effective January 1, 2019, employees who transferred from The Providence Center ("Center") to the VNA as a result of the transaction between Care New England and the Center received credit for service performed with the Center for purposes of eligibility and vesting (but not for non-elective contributions) under the Plan. For purposes of the non-elective contributions, these employees shall only receive credit for determining years of service for service performed with the VNA.

Employees who transferred from The Memorial Hospital of Rhode Island ("Memorial") to the VNA as a result of the transaction between Care New England and Memorial received credit for service performed with Memorial for purposes of eligibility and vesting (but not for non-elective contributions) under the Plan. For purposes of the non-elective contributions, these employees shall only receive credit for determining years of service for service performed with the VNA.

Participant Contributions

Each year, participants may contribute from 1% to 100% of their respective annual compensation, subject to limitations established by the Plan and the Internal Revenue Service. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans ("Rollovers"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Notes to Financial Statements

Note 1 - Description of the Plan (Continued)

Employer Non-Elective Contributions

The Employer non-elective contribution is a percentage of eligible compensation. The percentage is determined by the sum of a participant's age and years of vesting service, determined as of the first day of the Plan year, as follows:

<u>Sum of Member's Age and Years of Vesting Service</u>	<u>Percentage of Compensation</u>
Under 40	3.00%
40-49	4.00%
50-59	4.25%
60-69	4.75%
70-79	5.50%
80 or over	5.75%

An employee is not required to make deferral contributions to be eligible for a share of the Employer's non-elective contribution.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Employer non-elective contribution, and a pro rata allocation of the Plan's investment gains or losses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the vested portion from the participant's account.

Forfeitures

As of December 31, 2024 and 2023, the forfeited non-vested balance totaled \$2. These amounts can be used to offset a portion of Employer contributions. For the Plan year ended December 31, 2024, no forfeitures were used to reduce Employer contributions.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer's non-elective contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after three years of service.

Notes Receivable from Participants

Participants may borrow, subject to provisions, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1-5 years or up to 10 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Principal and interest are paid directly to VALIC Trust Company Inc. and The Variable Annuity Life Insurance Company ("VALIC") by the Participants.

Note 1 - Description of the Plan (Continued)

Payment of Benefits

In-service withdrawals from any account fully vested by the participant are permitted only due to financial hardship or upon reaching age 59½. Participants can withdraw amounts from their rollover accounts at any time. Hardship withdrawals may be taken from any of the participants' accounts. On termination of service, a participant may receive a lump-sum amount equal to the vested value of his or her account, or upon death, disability or retirement, elect to receive other forms of payment described in the Plan document. Upon termination, if a participant's account balance does not exceed \$5,000, and the participant does not elect to take a distribution, the Plan administrator may distribute the participant's vested account balance directly to the participant without consent.

Plan Termination

Although it has not expressed any intent to do so, the VNA has the right under the Plan to discontinue its non-elective contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the VNA may determine.

Note 2 - Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments, Investment Valuation and Income Recognition

Investments other than fully benefit-responsive investment contracts (valued at contract value) are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price) and contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Note 2 - Summary of Accounting Policies (Continued)

Contributions

Contributions from Plan participants and the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Revenue Credit and Administrative Expenses

Administrative expenses are generally paid by the Plan. Effective December 3, 2020, the Plan entered into a service agreement with AIG for a term of five years and renewing for successive two-year periods thereafter unless terminated. The expenses related to the Plan charged by AIG includes an administrative fee of \$60 per year per participant and another \$26 per participant. These fees are all assessed and calculated quarterly. In addition, another fee of \$34 per participant is assessed and calculated quarterly. This amount is deposited to a plan expense account to be used for various allowable plan expenses. This account can be used to cover plan expenses, such as auditing, legal and consultant fees or be allocated back to participants. These amounts are not available to reduce Employer contributions.

The amount available in the expense budget account at December 31, 2024 and 2023 was \$239 and \$314, respectively. The amounts used from the expense budget account to offset expenses during the year ended December 31, 2024 amounted to \$6,951.

For the year ended December 31, 2024, \$6,951 were earned in revenue credits and \$7,133 was charged to participant accounts and included in the total of plan expenses.

Subsequent Events

The Employer and Plan management have evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued. During 2025, the Employer transferred its recordkeeping and/or administrative services agreement to Fidelity Workplace Service LLC, effective on or about June 23, 2025.

Note 3 - Information Certified by the Custodian and Insurance Company

Plan investments are held by the Plan's custodian and insurance company, VALIC Trust Company Inc. and The Variable Annuity Life Insurance Company ("VALIC"). The fair and contract values of investments as of December 31, 2024 and 2023 and all investment transactions for the year ended December 31, 2024 are reported to the Plan and certified as complete and accurate by the custodian and insurance company. Investment transactions include interest and dividends and net appreciation in fair value of investments. Information included in the supplemental schedule of assets (held at end of year) and notes receivable from participants have also been derived from information certified by the custodian and insurance company. The Plan offers investment choices to allow Participants to create a diversified portfolio of assets based on a participant's risk tolerance. Participants in the Plan may direct contributions to a variety of investment options.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I) and the lowest priority to unobservable inputs (Level III). The three levels of the fair value hierarchy are described below:

Level I – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level II – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.

Level III – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 4 - Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

All mutual fund investments held as of December 31, 2024 and 2023, totaling \$16,089,220 and \$14,045,464, respectively, are Level I within the fair value hierarchy.

Note 5 - Investment Contract with Insurance Company

The Fixed Interest Option is a group fixed annuity product issued by VALIC. Contract or accumulation value, as reported to the Plan by VALIC, represents contributions, earnings, participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. At December 31, 2024 and 2023, the contract value amounted to \$192,396 and \$182,280, respectively.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate will be declared annually by VALIC and that will apply to either the entire accumulation value, or separately to amounts in separate time periods. An interest rate will be set in advance of the period to which it relates and will be at least 1% per year for the first 5 contract years and at least 1% thereafter.

The investment will have a guaranteed interest rate of 2% for the first twelve months that began December 3, 2020. The crediting interest rate was 2.65% at December 31, 2024.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

In the event of a discontinuance of the contract, the fixed income option investment allows the plan sponsor to withdraw the contract value either in five equal installments or a decreasing balance method. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Note 6 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events such as an international conflict, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note 7 - Related-Party Transactions and Exempt Party-in-Interest Transactions

Plan investments are managed by AIG and VALIC. AIG is the recordkeeper as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. For the Plan year ended December 31, 2024, administrative fees of \$17,336 were paid to VALIC and other service providers net of \$6,951 in revenue credits. Notes receivable from participants also qualify as exempt party-in-interest transactions, as defined by ERISA.

Note 8 - Income Tax Status

The Plan has adopted the Angel Pension Group, Inc. volume submitter 403(b) plan and that volume submitter has received an advisory letter from the Internal Revenue Service ("IRS") dated March 31, 2017 stating that the form of the plan is acceptable under Section 403(b) of the Internal Revenue Code ("Code"), and therefore, the related trust is tax exempt. The plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting standards require recording uncertain income tax positions that exist in the Plan's financial statements. Plan management has determined there are no uncertain tax positions and believes there is no adjustment or disclosure required in the Plan's financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 - Delinquent Participant Contributions

Under U.S. Department of Labor Regulation Section 2510.3-102, 403(b) Plan related salary deferrals and loan repayments withheld from employees' paychecks must be deposited into the Plan as soon as reasonably possible. When this regulation is not satisfied, the Plan Sponsor has engaged in a prohibited transaction. During the year ended December 31, 2023, contributions of \$22,468 were not remitted to the Plan within the required time period. The Employer corrected for lost earnings to all affected participants in 2025.
