We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

#### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

#### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not

a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Supplemental Schedules Required by ERISA**

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedules of assets (held at end of year) as of December 31, 2024 and reportable transactions year then ended are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## NOTES TO FINANCIAL STATEMENTS

### **Note 1. Description of Plan**

The following description of the Health and Welfare Fund of Teamsters Local 473 (the "Plan") provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

- A. General – The Plan is a multiemployer health and welfare plan formed in 1987 under a trust agreement participating employers and Teamsters Local Union No. 473 (the "Union"). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.
- B. Benefits – The Plan provides medical, prescription drug, dental, vision, disability and life insurance benefits to retirees, active participants and their dependents who meet certain eligibility requirements. The Plan provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act of 1986 ("COBRA").

The Plan is self-funded for short-term disability benefits. In addition, the Plan provides a health reimbursement arrangement ("HRA") to certain retirees that is funded solely through employer contributions. The HRA allows eligible participants to be reimbursed tax free for medical insurance premiums. Amounts remaining at the end of the year are carried over and can accumulate to be used to reimburse future premiums when incurred. The Plan is not permitted to refund any part of the balance to the participant; the account cannot be used for anything other than reimbursement of qualified medical expenses and any remaining amounts are not portable when a participant terminates their retiree coverage under the Plan. All other benefits provided by the Plan are covered under fully insured products.

- C. Contributions – Employers make monthly contributions to the Plan on behalf of their covered employees at rates specified in applicable collective bargaining agreements. Certain employers may require employee participant co-share amounts in accordance with their respective collective bargaining agreements. The cost of the post-retirement benefits is shared by participating employers and retirees. In addition to deductibles and copayments, retirees make monthly self-payments to the Fund. Retiree contribution amounts are determined annually so that they are intended to cover 100% of the cost for retirees receiving coverage.
- D. Plan Administration – The Plan is administered by a Board of Trustees (the "Trustees") comprised of members selected by the Company and the Union. The Trustees have full authority to control and manage the operation and administration of the Plan.
- E. Termination – Although they have not expressed any intent to do so, the Trustees have the right to terminate the Plan subject to the provisions of ERISA.

### **Note 2. Summary of Significant Accounting Policies**

- A. Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

## NOTES TO FINANCIAL STATEMENTS (CONTINUED)

**Note 2. Summary of Significant Accounting Policies (Continued)**

- B. Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.
- C. Cash – The Plan holds its temporary cash in a noninterest-bearing account with a national financial institution and at times it may exceed federally insured amounts. The actual balance may exceed the reported balance due to outstanding checks.
- D. Recognition of Contribution Revenue – Contribution revenue is recognized in the month for which coverage is being provided. Contributions received after the coverage months are recorded as receivables. Management estimates an allowance for uncollectible accounts. The estimate is based on management's review of delinquent accounts and an assessment of the Plan's historical evidence of collections. There is no allowance for bad debt as of December 31, 2024 or 2023.
- E. Investment Valuation and Income Recognition – The Plan's investments are held by KeyBank in a non-insured trust fund. Investments are reported at fair value. Fair value is defined as the price that would be received to sell an asset or would be paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.
- F. Health Reimbursement Arrangement – Retirees hired prior to 1991 are eligible to receive a monthly subsidy of up to \$400 per month. For retirees electing medical coverage, this subsidy is used to offset the retiree's premium. For retirees opting out of medical coverage, the subsidy is contributed to the retiree's HRA. Included in the accompanying statements of net assets are amounts available to reimburse certain retired participants for qualified medical expenses. Employer contributions to the Health Reimbursement Accounts for 2024 and 2023 were \$283,782 and \$295,934, respectively. Medical benefits and expense reimbursements were \$246,635 and \$251,201 for 2024 and 2023, respectively. The HRA balance as of December 31, 2024 and 2023 was \$352,003 and \$346,706, respectively.
- G. Post-Retirement Benefits – A post-retirement benefit obligation has been recognized for future benefits expected to be paid to or for (1) currently retired participants and their beneficiaries and dependents, and (2) active participants and their beneficiaries and dependents after retirement from service with the participating employers. These benefit obligations represent the actuarial present value of the cost of those estimated future benefits that are attributed by the terms of the Plan to participant service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current retirees of the Plan. The obligations represent the amounts that are expected to be funded by contributions from the participating employers and from existing assets of the Plan. Prior to an active participant's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributable to that employee's service with a participating employer or employers rendered to the valuation date.

**Note 2. Summary of Significant Accounting Policies (Continued)**

The actuarial present value of the expected post-retirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment. The following were included in the assumptions used to calculate the post-retirement benefit obligations:

Discount Rate	5.25% per annum in 2024 and 4.75% in 2023.
Mortality Rates Non-Disabled	115% of PRI-2012 Headcount-weighted Healthy Retiree Blue Collar Mortality Tables projected generationally from 2012 using Scale MP-2021 in 2024 and 2023.
Disabled	115% of the PRI-2012 Headcount-weighted Disabled Annuitant Mortality Tables projected generationally from 2012 using Scale MP-2021 in 2024 and 2023.
Retirement	Age 52 – 65 based on historical and current demographic data, adjusted to reflect estimated future experience.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation. The funding of post-retirement benefit obligations is not covered by the contribution rate provided by the current bargaining agreements. The Plan is not obligated to pre-fund such benefits and funds these benefits during the participants' retirement, and not necessarily during the participants' active employment. Changes to the contribution rates or plan benefits are implemented based on the Trustees' periodic review of projected expenses and asset requirements.

The weighted-average health care cost trend rate assumption can have a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates increased by one percentage point each year, it would increase the obligation as of December 31, 2024 and 2023 by \$1,324 and \$210, respectively.

- H. Payment of Benefits – Benefit claims and insurance premiums are recorded when paid by the Plan.
- I. Subsequent Events – The Plan evaluated subsequent events through September 30, 2025, the date these financial statements were available to be issued.

**Note 3. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for Plan assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- The money market fund is a short-term investment fund that maintains daily liquidity and has a constant unit value of \$1.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following tables set forth by level the Plan's assets at fair value as of December 31, 2024 and 2023.

**Note 5. Tax Status**

The Trust established under the Plan to hold the Plan's assets is qualified pursuant to Section 501(c)9 of the Internal Revenue Code, and, accordingly, the Trust's net investment income is exempt from income taxes. The Trust has obtained a favorable tax determination letter from the Internal Revenue Service and management believes that the Trust, as amended, continues to qualify and to operate as designed.

The Plan's management has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6. Related Party / Party-in-Interest Transactions**

The Plan's expenses include various amounts reimbursed to the Union for administrative salaries, payroll taxes and occupancy costs incurred in the normal course of the Plan's operations. Total reimbursements to the Union for 2024 and 2023 were \$13,038 and \$12,615, respectively, of which \$927 and \$1,223 was payable at December 31, 2024 and 2023, respectively.

The Union is a contributing employer to the Plan. The Plan received contributions of \$17,418 and \$15,690 from the Union in 2024 and 2023, respectively.

**Note 7. Significant Contributing Employer**

In 2024 and 2023, one employer accounted for approximately 90% of total employer contributions to the Plan.

**Note 8. Risks and Uncertainties**

The Plan holds various investment securities which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

The actuarial value of plan benefit obligations is reported based on certain assumptions pertaining to payment trends and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.




