To the Plan Administrator

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

## Notes to Financial Statements December 31, 2024 and 2023

### 1. Description of Plan

The following description of the Natural Alternatives Partnership for Profits Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### *General*

The Plan’s date of inception was July 1, 1987. The Plan is a defined contribution plan covering all eligible employees of Natural Alternatives International, Inc. and subsidiary (the “Company”). An eligible employee is a regular, full-time employee of the Company who has one month of service. The Plan provides participants with a salary deferral option pursuant to Section 401(k) of the Internal Revenue Code. The Company serves as the Plan Sponsor and Administrator of the Plan. The Plan engages Fidelity Management Trust Company (the “Trustee”) to hold and invest certain Plan assets and execute certain Plan transactions. The Plan was restated effective July 22, 2015. The Plan was amended on June 1, 2018 to allow Plan expenses including legal, accounting and employee communication fees to be paid from forfeitures, if available, or allocated to the Plan participants.

The latest Plan amendment was effective January 1, 2022, to allow discretionary employer profit sharing contributions, reduce the service requirement for plan eligibility from 6 months to 1 month, increase the safe harbor match to 100% up to 5% of eligible compensation, reduce the vesting of non-elective contributions to immediate, and remove the 1,000 hours work requirement for non-elective contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### *Eligibility*

Employees of the Company who have completed one month of service are eligible to participate in the Plan.

#### *Participant Contributions*

Participants may make pre-tax elective deferral contribution subject to an annual limit of 100% of eligible compensation, as defined in the Basic Plan Document, or the annual maximum as determined by the Internal Revenue Code (\$23,000 in 2024). Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions (\$7,500 in 2024). Participants may also rollover amounts representing distributions from other qualified defined benefit or contribution plans.

#### 1. Description of Plan (continued)

##### *Employer Contributions*

As of January 1, 2022, the Company has elected to make matching contributions to all participants in an amount equal to 100% up to 5% of eligible compensation contributed to the Plan as deferral contributions.

The Company may make a discretionary additional matching contribution. If the Company makes a discretionary additional matching contribution, the discretionary additional matching contribution will be based on the participant's eligible compensation deferred into the Plan each Plan year. Discretionary matching contributions are limited to 5% of eligible compensation contributed to the Plan as of January 1, 2022. There were no discretionary matching contributions for the years ended December 31, 2024 and 2023.

In addition, the Company may make discretionary nonelective contributions in an amount to be determined by the Board of Directors for each Plan year. Participants must be employed as the last day of the Plan year to be eligible to receive any nonelective contributions that may be made for the Plan year as of January 1, 2022. There were no discretionary nonelective matching contributions for the years ended December 31, 2024 and 2023.

##### *Participant Accounts*

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions, qualified rollovers, the Company's discretionary matching contributions, if any, allocations of the participant's investment earnings or losses, and an allocation of certain transaction fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### *Investment Options*

Participants may make direct contributions, including Company matching and nonelective discretionary contributions, in any of a variety of investment options held by Fidelity Management Trust Company.

##### *Vesting*

Participants are 100% vested in their deferral contributions, safe harbor matching employer contributions, rollover contributions, employer matching contributions, qualified nonelective contributions, and any earnings thereon. As of December 31, 2021, employer nonelective contributions and earnings shall be vested in accordance with the following schedule:

Any amount not vested upon a participant's separation from service is forfeited and used to pay Plan expenses or reallocated to remaining participants. Effective January 1, 2022, the Plan was amended to reduce the vesting of non-elective contributions to immediate.

##### *Notes Receivable from Participants*

A participant may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's account balance. The loan is secured by the vested balance in the participant's account and bears interest at a rate determined according to the Plan Document at the execution of the loan. Principal and interest are paid ratably through payroll deductions or through other regular payments authorized by the Plan Administrator if payroll deductions are not possible. Outstanding notes receivable must be repaid upon the participant's termination of employment with the Company. For participant loans that become delinquent and result in default, the amount of the unpaid loan principal and interest due to the Plan will be deemed a distribution. Deemed distributions are reported as a taxable distribution. A participant may have one note receivable outstanding at a time. Interest rates were 4.25% - 9.50% for each of the years ended December 31, 2024 and 2023.

##### *Payment of Benefits*

The Plan allows for participants to make withdrawals from the Plan upon reaching age 59 ½ or in the case of serious financial hardship, as approved by the Administrator. Additionally, the value of the participants' contributions and the value of all vested Company contributions are payable to participants or their designated beneficiaries upon death, disability, retirement or upon termination of employment with the Company. If the participant is an active employee at the time of his/her death or disability, the account balance will automatically become 100% vested. At the participant's election, payment may be made in cash as a single lump sum or in installments.

##### *Payment of Benefits (continued)*

Any distribution greater than \$1,000 that is made to a participant without the participant's consent before the participant's normal retirement age (or age 62, if later) will be rolled over to an individual plan designated by the Plan Administrator. On termination of service due to death, disability or retirement, or for termination of service due to other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or may elect to direct or partially direct transfer to an individual retirement account ("IRA"), an individual retirement annuity, or another qualified plan.

##### *Forfeitures*

Forfeitures are the portion of the employer's discretionary matching contributions that are lost by a participant who terminates employment prior to becoming fully vested under the Plan's vesting schedule. Forfeited amounts are held by the Plan and are used to offset future employer discretionary matching contributions. Forfeitures included in Plan assets were \$7,512 and \$1,861 as of the Plan years ended December 31, 2024 and 2023, respectively. The Plan Sponsor used forfeitures in the amount of \$79 and \$84 toward administrative fees for the Plan years ended December 31, 2024 and 2023, respectively.

##### *Administrative Expenses*

Plan expenses are deducted from participant accounts, investment income or forfeitures, if available.

#### 2. Summary of Significant Accounting Policies

##### *Basis of Accounting*

The financial statements are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

##### *Use of Estimates*

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, the reported amounts of additions and deductions from net assets during the reporting period. Actual results could differ from those estimates.

##### *Investment Valuation and Income*

The Plan's investments are stated at fair value. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. See Note 4 for discussion of fair value measurements.

##### *Notes Receivable from Participants*

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan's Administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

#### 3. Summary of Investment Data Certified by the Plan Asset Custodian

The Plan's investments were held by Fidelity Management Trust Company at December 31, 2024 and 2023 and the following investment information was certified to be complete and accurate within the meaning of 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Investments and notes receivable from participants as shown in the statements of net assets available for plan benefits as of December 31, 2024 and 2023.

#### 4. Investments

Investment information disclosed in the accompanying financial statements and the supplemental schedule of assets held at end of year, including investments held at December 31, 2024 and 2023, net appreciation/depreciation in the value of investments, and interest income and dividends for the year ended December 31, 2024, were obtained or derived from information supplied to the Plan Sponsor and certified as complete and accurate by the Trustee.

The Plan's mutual fund investments are stated at fair value. The Plan uses a hierarchy for measuring the fair value of all financial assets and liabilities that are being measured and reported at fair value on a recurring and non-recurring basis. Fair value is measured in levels, which are described in more detail below, and are determined based on the observability and reliability of the assumptions used to determine fair value.

Level 1: Valuation for assets and liabilities traded in active exchange markets. Valuations are obtained from readily available pricing sources for market transactions involving identical assets or liabilities.

Level 2: Valuations for assets and liabilities traded in less active dealer or broker markets. Valuations are obtained from third party pricing services for identical or comparable assets or liabilities.

Level 3: Valuations for assets and liabilities that are derived from other valuation methodologies, including option pricing models, discounted cash flow models, and similar techniques, and not based on market exchange, dealer, or broker traded transactions. These valuations incorporate certain assumptions and projections in determining the fair value assigned to such assets or liabilities.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified within the Level 1 of the valuation hierarchy.

Common/collective trust: Valued at the net unit value ("NUV") of units held by the Plan at year-end as reported by the fund manager. The Plan uses a practical expedient permitting a reporting entity to measure the fair value of certain investments using the NUV per share of the investment rather than one of the three fair value levels previously

described. The Plan's investment in the contracts held by the common/collective trust is indirect, and as a result, is not considered fully benefit responsive.

#### 5. Party-in-Interest Transactions

As of December 31, 2024 and 2023, the Company was the Plan Sponsor, and the Trustee was the custodian and record-keeper as defined in the Plan document and, therefore, these transactions qualify as allowable party-in interest transactions. Participant loans also qualify as exempt party-in-interest transactions.

Additionally, the Plan Sponsor is a party-in-interest to the Plan; however, there were no transactions with the Plan Sponsor other than the funding of contributions to the Plan and payment of certain administrative expenses of the Plan.

#### 6. Administration of Plan Assets

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

#### 7. Tax Status

The Plan obtained its initial determination letter on March 31, 2014, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. The Plan received its latest determination letter on June 30, 2020 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. However, the Plan Administrator and the Plan's tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate certain tax positions taken by the plan and recognize a tax liability (asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

The Plan Administrator believes the Plan is no longer subject to income tax examinations for years prior to December 31, 2019.

#### 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits and the statement of changes in net assets available for plan benefits.

The Plan invests through mutual funds in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.

#### 9. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their portion of Company contributions.

#### 10. Subsequent Events

The Plan Sponsor has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued. Effective January 1, 2025, the Plan was amended to change the employer matching contribution to 50% of employee contributions up to 6% of eligible compensation.
