## Independent Auditor's Report

To the Plan Administrator of  
Hollingsworth & Vose Company Union Savings Plan:

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

### 1. DESCRIPTION OF THE PLAN

The following description of Hollingsworth & Vose Company Union Savings Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### a. General

The Plan is a defined contribution 401(k) plan covering substantially all employees of Hollingsworth & Vose Company (the Company) (the Plan Sponsor) located at the West Groton and East Walpole, Massachusetts, and Easton, New York locations. The Plan Administrator is responsible for oversight of the Plan, the appropriateness of the Plan's investment offerings, and monitors investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### b. Eligibility

Eligible employees may participate in the Plan and receive the Company's discretionary matching and discretionary non-elective contributions upon being hired by the Plan Sponsor. The Plan excludes all non-union employees or union employees unless their collective bargaining agreement specifically provides for participation in the Plan, and temporary employees.

#### c. Contributions

Each year, participants may contribute up to 60% of pre-tax annual compensation, as defined in the plan document, up to the maximum allowed by the Internal Revenue Service (IRS). The Plan allows for catch-up contributions for participants who have attained age fifty by the end of the plan year. The Plan allows for participants to make post-tax (Roth) contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover contributions). The Plan includes an auto-enrollment provision whereby eligible participants are automatically enrolled in the Plan with a deferral contribution equal to 6% of eligible compensation as defined in the plan document, unless they affirmatively elect not to participate within the first 35 days of employment. The Plan also includes an auto-escalation provision whereby the participants deferral percentage is increased by 1% on April 1<sup>st</sup> of each year for any participant who has elected a deferral election of less than 6%, unless they affirmatively elect not to participate, or elect a different deferral percentage. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company contributes discretionary matching contributions based on collective bargaining agreements, subject to certain statutory limitations. Participants must be actively participating in order to receive the Company's discretionary matching contributions. There were \$492,820 of discretionary matching contributions remitted to the Plan for the year ended December 31, 2024.

The Company also contributes discretionary non-elective contributions based on collective bargaining agreements, subject to limitations imposed by the Internal Revenue Code (IRC). There were \$231,298 of discretionary non-elective contributions remitted to the Plan for the year ended December 31, 2024.

#### c. Contributions (Continued)

Subsequent to year-end, the Company worked with their service provider to calculate corrections needed in relation to the definition of eligible compensation and discretionary match and discretionary non-elective calculations for the plan years 2024, 2023, 2022, 2021, and 2020, and funded the corrections and associated lost earnings to the Plan in 2025. This amount is reflected within the employer contributions receivable in the amount of \$498,010 in the accompanying statements of net assets available for benefits.

#### d. Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Company's discretionary matching and discretionary non-elective contributions, and plan earnings or losses, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant's earnings, account balances or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled to is the benefit that can be provided from the participant's vested account.

#### e. Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions, and actual earnings or losses thereon. Participants become fully vested upon death or disability. Vesting does not change if a participant moves from one Company sponsored plan to another. Participants vest in the Company's discretionary matching and discretionary non-elective contributions based on years of service as follows:

Less than 2 Years	0%
2 Years	25%

#### f. Payment of Benefits

The Plan provides for a retirement benefit to be paid to participants who have reached the later of the normal retirement age of 65 or the fifth anniversary of the participant's employment, or the later of early retirement age of 55 or the fifth anniversary of the participant's employment. Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of their account. There are also retirement benefits available upon disability and death. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan Administrator will authorize the benefit payment without the participant's consent, as allowed by the Plan's provisions. Effective August 26, 2024, the involuntary force-out distribution limit was increased to \$7,000 under the provisions of SECURE Act 2.0.

#### f. Payment of Benefits (Continued)

The Plan allows in-service withdrawals upon attainment of age 59 ½. A participant may also request a withdrawal upon demonstration to the Plan Administrator that they were suffering a "hardship". Hardship is defined in applicable regulations promulgated or to be promulgated pursuant to the applicable section of the IRC or standards established by the Secretary of the Treasury or their delegate.

#### g. Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants are only allowed one outstanding loan at a time. Loan terms range up to five years, unless for the purchase of a primary residence in which the term of the loan can be ten years. Loans are secured by the vested balance in the participant's account and bear interest at an amount determined by the Plan Administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. Principal and interest are paid ratably through payroll deductions.

#### h. Forfeitures

Forfeitures represent non-vested Company contributions forfeited by participants who terminate their employment or who withdraw from the Plan. Forfeitures can be used to reduce any Company contributions or to pay plan expenses. As of December 31, 2024 and 2023, there were unallocated forfeitures totaling \$126,099 and \$69,016, respectively. The Plan Sponsor used \$21,713 and \$15,695 of forfeitures to reduce Company contributions and pay plan expenses, respectively, during 2024.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Presentation

The Plan prepares its financial statements in accordance with generally accepted accounting principles (U.S. GAAP) established by the Financial Accounting Standards Board (FASB). References to U.S. GAAP in these notes are to the FASB Accounting Standards Codification (ASC).

#### Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Investments in mutual funds are included in the financial statements at quoted market prices on public exchanges which represent the net asset value (NAV) of shares held by the Plan at year-end. The Plan's interest in the common collective trust is stated at NAV based on information reported by the investment advisor using the audited financial statements of the collective trust at year-end. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the Plan's investment advisor and qualified institution. See Note 4 for discussion of fair value measurement.

#### Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. As of December 31, 2024, there were \$60,931 in defaulted loans that have been deemed distributed and included in benefits paid to participants in the accompanying statement of changes in net assets available for benefits.

#### Contributions

Contributions from plan participants and the discretionary matching and non-elective contributions from the Plan Sponsor are recorded in the year which the participant contributions are withheld from compensation.

#### Payment of Benefits

Benefits paid to participants are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of participant loans and processing of distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses, including plan record keeping and investment advisory services are included in net appreciation of investments.

#### Subsequent Events

Subsequent events have been evaluated through October 10, 2025, which is the date the financial statements were available to be issued. There were no events that met the criteria for recognition for disclosure in the financial statements.

### 3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S QUALIFIED INSTITUTION

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company (Fidelity), the qualified institution, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of December 31, 2024, and the related investment transactions and investment income and interest income on notes receivable from participants reported in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to certified investment information, except for comparing such certified investment information included in the accompanying financial statements and supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of December 31, 2024.

### 4. FAIR VALUE MEASUREMENT

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. *Fair Value Measurement* establishes a hierarchy of the valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs). The fair value hierarchy is as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust:* Valued at the NAV of units in a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. As of December 31, 2024 and 2023, the Plan had no plans to sell the common collective trust at amounts different from NAV. Participant transactions (purchases and sales) may occur daily. If the Plan were to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

There have been no changes to the methodologies used at December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. COMMON COLLECTIVE TRUST

The Plan's investment in the common collective trust (CCT) is represented by the CCT's underlying investment in the Fidelity Managed Income Portfolio fund which invests in fully benefit-responsive investment contracts, commonly referred to as guaranteed investment contracts (GICs), synthetic investment contracts, and similarly designed contracts issued by insurance companies, banks and other financial institutions. The Plan's investment in the CCT is not considered a fully benefit-responsive investment contract and is reported at fair value (see Note 4).

### 6. TAX STATUS

The Plan Sponsor has obtained an opinion letter dated June 30, 2020, in which the IRS stated that the restated prototype plan document was in compliance with applicable requirements of the IRC. The Plan Administrator timely adopted the restated prototype plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently being operated in accordance with the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

### 7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested and all accrued benefits shall be paid to participants in accordance with the provisions of the Plan.

### 8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, transactions with investment funds managed and held by the qualified institution are considered party-in-interest transactions. During 2024, the Plan paid the qualified institution administrative and services fees of \$53,356.

### 9. RISKS AND UNCERTAINTIES

The Plan invests in various investments. Investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that these changes could materially affect the amounts reported in the statements of net assets available for benefits.

### 10. TRANSFERS BETWEEN QUALIFIED PLANS

The Plan Sponsor maintains two qualified 401(k) savings plans: a union (Hollingsworth & Vose Company Union Savings Plan) and a non-union plan (Hollingsworth & Vose Company (Salaried) Savings Plan). When the status of a plan participant changes, the vested balance of that participant's account is transferred to the appropriate plan. Net transfers to the Hollingsworth and Vose Company (Salaried) Savings Plan totaled \$100,033 for the year ended December 31, 2024.

### 11. DELINQUENT PARTICIPANT CONTRIBUTIONS

During 2024, 2023, 2022, and 2021, the Plan Sponsor failed to segregate and remit in a timely manner certain participant contributions (salary reduction amounts) and loan repayments from its assets within the required time period as specified by the United States DOL Reg. 2520.3012. Failure to segregate and remit contributions within the specified time period is a prohibited transaction. Plan management intends to correct these amounts in 2025.
