NOTE 1 PLAN DESCRIPTION

The following description of the Blue Rock Products Co. Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was initiated on January 1, 1978 and is a profit sharing plan covering all employees of Blue Rock Products Company (the Company). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and was last amended in November 2024 to require employees to be employed on the last day of the year to receive the profit sharing contribution.

The Plan is administered by the sponsor, Blue Rock Products Company. First State Bank and Trust acts as third party administrator and serves as the directed trustee of the Plan, maintains the records of participant data, and holds the Plan assets.

Eligibility

Employees of the Company are eligible to receive discretionary employer profit sharing contributions to the Plan after attainment of one year of service consisting of at least 1,000 service hours during the Plan year, and attainment of age 21. Participants are entered in the Plan on the first day of January or July following meeting the eligibility requirements. Once eligible, employees must work at least 500 hours during the Plan year and be employed on the last day of the Plan year to receive any discretionary employer profit sharing contributions.

Contributions

The Company may make a discretionary profit sharing contribution annually. The amount of such contribution will be allocated to eligible participants in the proportion that their eligible compensation bears in relation to the eligible compensation of all qualifying participants. For the years ended December 31, 2024 and 2023, discretionary profit sharing contributions were made equal to 10.5% and 11.1% of eligible compensation, respectively. Qualified rollovers from other plans are also permissible by the Plan document. Employee deferrals are not permitted by the Plan.

Participant Accounts

Each participant's account is credited with the Company's contribution and an allocation of Plan earnings and forfeitures. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan allows for participant-directed investment programs for which separate funds are maintained. The value of each participant's account is determined daily.

Participants' Investment Options

Participants are allowed to invest in a variety of investment choices as more fully described in the Plan's literature. All investment choices vary in the types of investments, rates of return, and investment risk. Participants may change their investment options by contacting First State Bank and Trust.

Payment of Benefits

Upon termination of employment, death, disability or retirement, a participant may elect to receive a lump sum payment, partial payments, installment payments or purchase an annuity contract equal to the value of the participant's vested interest. Terminated participants with vested account balances of \$1,000 or less will be required to take a lump sum distribution upon termination. Hardship distributions are also permitted for vested balances of participants who have not separated from service. In-service distributions are allowed upon the attainment of age 59½ and after participating in the Plan for a period of five years. Generally, certain minimum distributions are required for participants who have separated from service and have reached the required minimum distribution age.

Vesting

Vesting in the Company's discretionary profit sharing contributions plus actual earnings thereon is based on years of service. A participant is 100% vested after six years of credited service.

Forfeitures

Forfeitures of nonvested participant interests under the Plan are reallocated among active participants of the Company in the same manner as the Company's discretionary profit sharing contribution. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,518 and \$2,491, respectively. These forfeitures were allocated in full to participants in the subsequent year.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Basis of Presentation

The accompanying financial statements are presented in accordance with accounting principles generally accepted in the United States of America, ("GAAP"), as codified by the Financial Accounting Standards Board.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year and is reflected in the statements of changes in net assets available for benefits.

Payment of Benefits

Benefit distributions are recorded when paid.

Administrative Expenses

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and thus are not separately disclosed in the accompanying financial statements. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Income Taxes

The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence.

NOTE 4 FAIR VALUE MEASUREMENT

FASB ASC Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Topic 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:
Quoted prices for similar assets or liabilities in active markets;
Quoted prices for identical or similar assets or liabilities in inactive markets;
Inputs other than quoted prices that are observable for the asset or liability;
Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

Mutual funds (including money market mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 INCOME TAX STATUS

The Plan adopted a non-standardized pre-approved plan sponsored by First State Bank and Trust. The pre-approved plan has received an advisory letter dated June 30, 2020 from the Internal Revenue Service as to the Plan's qualified status. The pre-approved plan advisory letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken a significant uncertain tax position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

NOTE 6 EXEMPT TRANSACTIONS WITH PARTIES-IN-INTEREST

The Plan auditor, Brady Martz, and the trustee of the Plan, First State Bank & Trust qualify as parties-in-interest. Both parties provide services to the Plan and charge fees for those services. Fees paid by the Plan to these parties-in-interest amounted to \$29,024 and \$35,575 for the years ended December 31, 2024 and 2023, respectively.

NOTE 7 AMENDMENT AND TERMINATION

Although it has not expressed any intent to do so, the Company reserves the right at any time to amend or terminate the Plan subject to the provisions of the Plan and ERISA. If the Company terminates contributions or the Plan is terminated, all participants become fully vested.

NOTE 8 RISKS AND UNCERTAINTIES

Participants direct the investment of their accounts into various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect account balances and the amounts reported in the statement of net assets available for benefits.
