Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements, are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.
- identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Coleman Professional Services, Inc.- VEBA's internal control. Accordingly, no such opinion is expressed.
- evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Coleman Professional Services, Inc.- VEBA's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter - 2024 Supplemental Schedules Required by ERISA***



In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying supplemental schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

***Other Matter - 2023 Financial Statements***

The financial statements of Coleman Professional Services, Inc.- VEBA as of and for the year ended December 31, 2023, were audited by other auditors whose report dated October 2, 2024, expressed an unmodified opinion on those statements.

## Notes to the Financial Statements

December 31, 2024 and 2023

### 1. DESCRIPTION OF PLAN

The following description of the Coleman Professional Services, Inc.- VEBA (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan, established January 1, 2017, is a defined benefit health and welfare plan that provides health benefits to eligible employees of Coleman Professional Services, Inc. (the Organization and Plan sponsor). Certain plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan trustees are responsible for oversight of the Plan.

**Eligibility and benefits** - The Plan provides health benefits (medical and prescription drugs) to full- and part-time employees who work 30 or more hours per week and their eligible dependents. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Health claims of active participants and their dependents are processed by a third-party claims processor, UnitedHealthcare Insurance Company (Claims Processor) beginning January 1, 2024, but the ultimate responsibility for payments to participants and providers is retained by the Plan. During 2023, The Health Plan was the claims processor for the plan. The Plan terminated the relationship with The Health Plan as of December 31, 2023.

**Contributions** - The Plan is funded by employer, employee, and COBRA contributions. In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. The Organization makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Organization on an as-needed basis.

**Stop-loss coverage** - The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). Premiums for stop-loss insurance are included in premiums paid in the accompanying statements of changes in net assets (deficit) available for benefits. At December 31, 2023, the Plan was owed refunds of \$969,279, which were received in 2024, with no such amounts owed at December 31, 2024. Stop-loss refunds totaling \$636,872 and \$1,560,998 for the years ended December 31, 2024 and 2023, have been netted with claims paid in the accompanying statements of changes in net assets (deficit) available for benefits. The Organization has an aggregate maximum limit of reimbursement liability of \$1,000,000.

**Self-insured benefits** - All Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processor under administrative services only (ASO) arrangements. The Claims Processor pays claims directly to or on behalf of participants and is then reimbursed by the Plan's VEBA trust.

### 2. SUMMARY OF ACCOUNTING POLICIES

**Basis of accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Cash** - The Plan maintains its cash in accounts at national financial institutions which, at times, may exceed federally insured limits. The Plan has not incurred any losses resulting from cash held at the financial institutions.

**Payment of benefits** - Claim payments are recorded when paid by the Claims Processor. Amounts due to the Claims Processor that have yet to be reimbursed by the Plan are recorded as payable to Claims Processor in the statements of net assets (deficit) available for benefits.

**Expenses** - The Plan pays administrative expenses that consist primarily of fees paid to its third-party claims processor. These expenses are reported on the statements of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Organization on behalf of the Plan.

**Rebates** - Rebates due from the Plan's Claims Processor are recorded when earned. Rebates due as of the financial statement date would be reported as a receivable, with the offset being netted against claims paid. Rebates received totaling \$1,448,697 and \$449,895 have been netted with claims paid in the accompanying statements of changes in net assets (deficit) available for benefits for the years ended December 31, 2024 and 2023.

**Benefit obligations** - Plan obligations at December 31, 2024 and 2023, for claims incurred but not reported, are estimated by the Plan's management based on claims data provided by the Plan's Claims Processor. These amounts are paid by the Plan only if claims are submitted and approved for payment. These claims represent a liability to the Organization. Claims and premiums that have been processed and approved for payment at year end, but not paid, and claims incurred but not reported are not considered liabilities of the Plan under U.S. GAAP and, therefore, are not presented as liabilities or claims and premiums paid in the accompanying financial statements.

**Subsequent events** - Subsequent events were evaluated through October 13, 2025, the date the financial statements were available to be issued.

### 3. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain administrative functions of the Plan are performed by officers or employees of the Organization. No such officer or employee receives compensation from the Plan.

The Plan has arrangements with service providers. These transactions are party in interest transactions under ERISA. Amounts paid to the claims processor amounted to \$151,130 in 2024 and \$227,669 in 2023.

### 4. PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### 5. TAX STATUS

The VEBA and related trust received an exemption letter from the Internal Revenue Service (IRS) dated July 20, 2017, stating that the trust is tax-exempt under the provisions of Section 501(c)9 of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time, the trust may be subject to income taxes. No federal or state income taxes have been recorded during the years ended December 31, 2024 and 2023, for unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax exempt status of the trust. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan sponsor has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **6. RISKS AND UNCERTAINTIES**

Due to uncertainties inherent in the estimations and assumptions or process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
