Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the Knuttsen Chevrolet 401(k) Retirement Savings Plan (the Plan) an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Opinion

We have performed a compilation engagement in accordance with Statements on Standards for Accounting and Review Services promulgated by the Accounting and Review Services Committee of the AICPA. We did not audit or review the financial statement, nor were we required to perform any procedures to verify the accuracy or completeness of the information provided by plan management. Notes to Financial Statements

Note 1 – Description of the Plan

The following description of the Knudtsen Chevrolet 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

- a. **General** – The Plan is a defined contribution plan qualifying as a salary reduction plan as defined in Section 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- b. **Eligibility** – To be eligible to make an employee or Roth deferral, and receive an employer safe harbor contribution, employees must have attained age 18 and worked six months of service with Knudtsen Chevrolet Company (the Company). The entry date is the first day of the month following fulfillment of the eligibility requirements.
- c. **Contributions** – Participants make voluntary tax-deferred contributions to the Plan through payroll deductions subject to Internal Revenue Service (IRS) limitations. Participants may change their deferral percentage at any time. The Plan also allows participants to make rollover contributions from other qualified plans.

The Company's safe harbor contributions are calculated at 100% of the participant deferrals that are not in excess of 4% of the participant's plan compensation as determined at the end of the calendar year. The Plan also allows discretionary nonelective employer contributions for employees that have completed 1,000 hours and are employed on the last day of the year.

- d. **Participant accounts** – Participants self-direct the investment of their account balance. Each participant's account is credited with the participant's deferral contributions and allocations of (a) the Company's matching contributions, (b) the Company's discretionary contributions, and (c) plan earnings or losses. Each account is also charged with an allocation of the administration expenses of selected funds. Employer contributions are allocated based on the employee's authorized deferral and the Plan's matching limit described above. Earnings allocations are based on participant investment selections and account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- e. **Vesting** – Participants are immediately vested in their voluntary contributions and rollovers plus actual earnings thereon. Vesting in employer matching and discretionary contributions is based on years of service. A participant is 100% vested after six years of credited service according to the following schedule:

- e. **Payment of benefits** – Upon termination of service, a participant shall receive a lump-sum amount or required minimum distributions. In-service withdrawals due to hardships are permitted.
- f. **Forfeited accounts** – Forfeitures occur when a participant separates from service before becoming 100% vested in matching or discretionary contributions. The Plan allows forfeitures to be used to reduce administrative fees or as a supplement to future employer contributions. For the year ended December 31, 2024, forfeitures of \$7,481 were used to reduce employer contributions.
- g. **Notes receivable from participants** – Participants may borrow up to the lesser of \$50,000 or 50% of their vested interest in the Plan to be repaid in level installments every payroll period via payroll deduction. The loans are secured by the participant’s account balance and bear interest at the rate of prime plus 1% interest rate in effect when the loan is made. Participants should refer to the Plan’s loan policy agreement for a more complete description of the Plan’s provisions. Loans go into default if payments are not received for four consecutive months, and the remaining balance is considered a deemed distribution.

Note 2 – Summary of Significant Accounting Policies

- a. **Basis of accounting** – The financial statements of the Plan are prepared in conformity with accounting principles generally accepted in the United States of America as applied to employee benefit plans and in accordance with the plan agreement.
- b. **Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.
- c. **Investment valuation and income recognition**– The Plan’s investments are stated at fair value, as certified by the Plan’s custodian, John Hancock Life Insurance Company. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of shares are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

- d. **Payment of benefits** – Benefits are recorded when paid.

Note 2 – Summary of Significant Accounting Policies (Continued)

- e. **Administrative expenses** – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of certain benefit payments are charged to the participants and are included in benefits paid to participants and beneficiaries. Investment related expenses are included in net appreciation in fair value of investments.
- f. **Subsequent events** – Subsequent events have been evaluated through October 10, 2024, the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024:

Level 1 – The Plan has no investments that are classified as Level 1 for the years ended December 31, 2024 or 2023.

Level 2 – The Plan has no investments that are classified as Level 2 for the years ended December 31, 2024 or 2023.

Level 3 – The Plan has no investments that are classified as Level 3 for the years ended December 31, 2024 or 2023.

Investments measured at net asset value (NAV):

Pooled separate accounts are valued at net asset value provided by the fund management. Pooled separate accounts are based on market prices determined by pricing services from John Hancock Life Insurance Company and other reliable sources. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. The fair value of units in pooled separate accounts is determined by dividing the market value of the fund by the total number of units in the fund.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in Fair Value Levels

Note 4 – Information Reported and Certified by the Custodian

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by John Hancock Life Insurance Company, the custodian of the Plan, for the year ended December 31, 2024, as complete and accurate, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplemental schedule:

- (a) Investments as indicated on the statements of net assets available for benefits;
- (b) Net appreciation in fair value of investments as indicated on the statement of changes in net assets available for benefits; and
- (c) Supplemental schedule – assets held for investment.

Note 5 – Parties-in-interest Transactions

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. The Company provides certain accounting, recordkeeping, and administrative services to the Plan for which it receives no compensation.

The third-party administrator of the Plan provides financial, recordkeeping, and administrative services to the Plan for which all fees are paid by the Company.

Certain plan investments are held in investment funds managed by John Hancock Life Insurance Company, which is a custodian as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions.

Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Note 6 – Tax Status

The Internal Revenue Service (IRS) has determined and informed the Plan that it is qualified and the Plan is tax-exempt under appropriate sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's Board of Trustees believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of the liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, and the Plan could be subject to income tax if certain issues were found by the IRS that could result in the disqualification of the Plan's tax-exempt status; however, there are currently no audits for any tax periods in progress.

Note 7– Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions and there would be a complete distribution of the assets to the participants.

Note 9 – Delinquent Participant Contributions

During the year ended December 31, 2024, participant contributions of \$17,107 were withheld from employee paychecks, but were not remitted as soon as reasonably possible from the date of withholding to the date of deposit. These transactions constituted loans from the Plan to the Company for the amount of time until the deposits were made. In October 2025, the Company contributed additional amounts for lost earnings related to the late deposits to the Plan of \$55 and calculated \$8 in excise taxes related to these late deposits.
